- Contract type performance-based; cost-reimbursement w/performance fee and award term incentive
 - 5-year base period
 - Potential to earn up to 15 additional years of award term
- Maximum of 60-day transition period
- New Contractor will be expected to assume full responsibility for TJNAF on June 1, 2026
- Not identical to the cancelled TJNAF RFP; changes have been made throughout the RFP including, but not limited to, meaningful changes to the evaluation factors
- Proposal Submission Instructions (L.1)
 - 3-Volume proposal
 - Acknowledgment of amendments
 - Volume II 100-page limitation



- Performance Fee (B.3)
 - Max fee
 - Fee base
 - Transition is cost only, no fee
 - 2026, 2027, 2028, and 2029 potential forfeiture up to \$300K for each Key Personnel departure
- Allowability of Subcontractor Fee (B.4)
 - How fee is shared within a Teaming Arrangement is at the contractor's discretion
- Award Term Incentive (F.2)
 - The initial evaluation period for the first award term extension will be the first three performance evaluation periods of the contract term.

- Employee Compensation: Pay and Benefits (H.21)
 - This clause has changed significantly, please review it carefully
- Special Financial Institution Account Agreement (H.35)
 - Required
