# EFRCs and Hubs by the Numbers

- Budget (FY2020)
  - EFRCs: \$115M/year
  - Batteries and Energy Storage Hub: \$24M/year
  - Solar Fuels Hub: \$20M/year
- Number of awards
  - EFRC: 88 total since 2009 (41 Active)
  - Energy Storage Hub:
    - JCESR, 2012 present
  - Solar Fuels Hub:
    - JCAP, 2010 2020
    - LiSA and CHASE, 2020 ...
