# **SUMMARY**

The Climate Model Development and Validation (CMDV) Activity in the Climate and Environmental Sciences Division (CESD), Office of Biological and Environmental Research (BER) of the Office of Science (SC), U.S. Department of Energy (DOE), is a new effort to improve climate model architecture, software, and computational design to prepare for exascale

computing, to develop scale-aware physics for climate systems, and to enhance methods for model validation. This solicitation focuses mainly on the development and validation of scale-aware physics parameterizations for the atmosphere, with the goal of including these in either the current or next generation version of DOE's Accelerated Climate Model for Energy (ACME). A recent workshop report (<a href="http://www.arm.gov/publications/programdocs/acme-arm-asr-draft-report.pdf">http://www.arm.gov/publications/programdocs/acme-arm-asr-draft-report.pdf</a>) describes a new strategy to better align DOE capabilities across scales and disciplines in order to much more rapidly advance ACME development. In line with this strategy, this FOA solicits university and other non-DOE-Laboratory investigators to participate as collaborators in team projects led by DOE National Laboratories that will work in an end-to-end manner between measurements and modeling, and across scales from local and/or regional to global, in order to improve the fidelity of global climate model simulations, with a view to enhanced predictability and address critical climate science challenges.

The model representation of clouds and aerosols, and their changes in response to energy and climate drivers, remain the most uncertain elements in model predictions of the climate system. Therefore, improved predictability requires greater understanding and representation of the behaviors of clouds and chemistry within global climate models.

#### SUPPLEMENTARY INFORMATION

# **Program Objective**

This CMDV activity will draw upon and integrate capabilities that span atmospheric research within BER, with the ultimate goal of providing a substantial and measurable improvement to atmospheric process representation and coupled climate fidelity in DOE's ACME model, and to address significant atmospheric science research challenges. BER's atmospheric research includes the ARM Facility (which is the premier ground-based observations facility with a mission to advance climate change research), the Atmospheric System Research (ASR) activity (which focuses on quantifying the interactions among aerosols, clouds, precipitation, radiation, dynamics, and thermodynamics to improve fundamental process-level understanding) and the Earth System Modeling (ESM) activity (which develops all aspects of global Earth System Models toward a goal of a predictive understanding of climate). CMDV offers an opportunity to leverage and combine these capabilities to ensure that DOE atmospheric measurements, process understanding and modeling, and parameterization development can be effectively utilized in an Earth System Model, as demonstrated by a careful evaluation plan. The processes to be targeted as part of the CMDV activity must be observed, modeled, and validated over a range of scales, from field to the ESM grid-scale.

# **Atmospheric System Research (ASR)**

The goal of the ASR activity is to improve the scientific understanding and treatment in atmospheric models of clouds, aerosols, and radiative transfer processes that are important drivers of climate change. ASR conducts research to: determine the properties of, and interactions among, aerosols, clouds, precipitation, and radiation that are most critical to understand in order to improve their representation in climate models; ascertain the roles of atmospheric dynamics, thermodynamic structure, radiation, surface properties, and chemical and

microphysical processes in the life cycles of aerosols and clouds, and develop and evaluate models of these processes; and identify and quantify processes along the aerosol-cloud-precipitation continuum that affect the radiative fluxes at the surface and throughout the atmosphere and the radiative and latent heating rate profiles, and improve the ability to accurately model these processes.

# Earth System Modeling (ESM)

Earth System Modeling supports the development of a much more sophisticated climate predictive capability in order to underpin the Nation's societal and energy planning. These developments include complex representations of climate systems, coupling these with "human" systems and drivers as needed to improve climate simulation fidelity, and the application of nextgeneration computational methods to facilitate and to accelerate model computational performance on DOE's current and next-generation NERSC and Leadership Class Facility (LCF) computers. In 2014, DOE recently launched a Laboratory-led, multi-institutional project to develop the Accelerated Climate Model for Energy (ACME). The ACME project is developing and applying a computationally advanced climate and Earth system model to investigate the challenges posed by the interactions of climate change with energy and related sectors. The ACME model simulates the fully coupled climate system at high-resolution (15-25 km) and is incorporating coupling with energy, water, and related technologies and infrastructures, and with a focus on near-term hindcasts (1970-2015) for model validation and a near-term projection (2015-2050) for societal planning. The model further employs regional-refinement using adaptive mesh methodologies in order to provide ultra-high-resolution to resolve critical physical and dynamical phenomena.

ACME's scientific goals address three areas:

- 1. <u>Water Cycle</u>: "How do the hydrological cycle and water resources interact with the climate system on local to global scales?"
- 2. **Biogeochemistry**: "How do biogeochemical cycles interact with global climate change?"
- 3. <u>Cryosphere-Ocean System</u>: "How do rapid changes in cryosphere-ocean systems interact with the climate system?"

A major motivation for the ACME project is the paradigm shift in computing architectures and their related programming models as computational capabilities move towards the exascale era. ACME is therefore optimizing climate code performance for current and next-generation DOE Computer Facilities, by exposing increased concurrency throughout the model and increasing the on-core performance of key computational kernels. Redesigning code for better concurrency through the use of modularized kernels for accelerators will be beneficial for most envisioned exascale architectures.

An important aspect of adaptation to new architectures is a substantial effort to improve software design and practice. Early priorities for ACME software engineering include maintaining build, test, and performance tools for the relevant computer platforms, and providing rapid development and debugging capabilities to the team. In the longer-term, ACME will expand use

of regression testing, tools for code coverage, correctness analysis, debugging at scale, and traceability of code back to scientific requirements. Productivity will be enhanced by greater use of libraries, frameworks, and tools.

ACME also has a substantial workflow effort, to enable and automate model simulation, post-processing, analysis and validation. Building from the Ultrascale Visualization Climate Data Analysis Tools (UV-CDAT) software, ACME output will be processed on a single workflow platform. Importantly, the workflow software can accommodate the very large data sets from the ACME high-resolution simulations and will enable "server-side" analysis of output rather than requiring porting of output to local machines. Model evaluation is initially based on well-established metrics developed by leading climate modeling centers. Availability of new observations, a focus on the ACME driving questions, and emphasis on high-resolution require development of new diagnostics and metrics. Metrics are being established that will track model improvement and realism of the coupled system.

The ACME project has completed its first coupled model system (version 1 or "v1"), with the expectation that debugging, tuning and initial simulations will be completed in 2017, followed by v1 code and output release. Version 2 (v2) developments are now actively underway; applications to this FOA would be well-suited to contribute to the v2 phase of development. The ACME project expects that v2 will be frozen in 2018, followed by a testing-simulation phase and release during 2019-2020. For more advanced developments that are not complete before the v2 freeze, contribution to v3 would be possible.

For more information on v1 and v2, see <u>v1 developments and simulation plan</u>, and <u>preliminary v2 development plans</u>.

The CMDV projects that will be supported in response to this solicitation must be capable of significantly enhancing atmospheric process development and validation, with a particular focus on ACME. ACME's variable resolution atmosphere, which can span the range of 100km to 15km, provides a particularly challenging opportunity for developing "scale-aware" physics. A SciDAC project which is nearing completion, "Multiscale Methods for Accurate, Efficient and Scale-Aware Models of the Earth System" has been developing scale-aware representations of atmospheric convection as well as cloud microphysics. The proposed project science as part of this solicitation, including development and testing goals, should extend, enhance and complement those of the Multiscale and ACME projects, but not duplicate them.

# **ARM Climate Research Facility**

The ARM Climate Research Facility is a DOE Office of Science User Facility that provides the climate research community with strategically located in situ and remote sensing observatories designed to improve the understanding and representation, in climate and earth system models, of clouds, aerosols, and radiation as well as their interactions and coupling with the Earth's surface. ARM currently operates three fixed site facilities, each representing uniquely different

climate regimes (<a href="http://www.arm.gov/sites">http://www.arm.gov/sites</a>) -- the Southern Great Plains (SGP), the North Slope of Alaska (NSA), and the Eastern North Atlantic (ENA) in the Azores. ARM also operates its three ARM Mobile Facility (AMF) units on deployments to a variety of climatic regimes for shorter durations (<a href="http://www.arm.gov/sites/amf">http://www.arm.gov/sites/amf</a>). The third mobile facility (AMF3) is currently in an extended term deployment at Oliktok Point, Alaska. Each ARM fixed and mobile facility has a suite of ground-based remote sensing and in situ instruments providing measurements of surface and boundary layer meteorology, atmospheric radiation, aerosol properties, and cloud and precipitation properties. ARM also has an aerial facility component which provides in situ measurements of aerosol and cloud properties.

The ARM Facility has recently released an updated <u>Decadal Vision</u> report and is undergoing a reconfiguration that is designed to accelerate the application of ARM observations and data processing for the understanding of key atmospheric processes and improving the representation of those processes in global climate models. As part of this reconfiguration, ARM has begun to develop a framework for routine large eddy simulation (LES) model runs over the ARM sites.

In the first phase of this development, a pilot project, the LES ARM Symbiotic Simulation and Observation (LASSO) project, was funded to develop the initial modeling workflow, with a focus on shallow convection at the ARM Southern Great Plains (SGP) site. The LASSO project (<a href="http://www.arm.gov/science/themes/lasso">http://www.arm.gov/science/themes/lasso</a>) will make available to the community a series of LES simulations and accompanying diagnostic datasets. It will also develop an ensemble of model forcing data methodologies, metrics to evaluate and intercompare the simulations, and software to simplify reproduction of the simulations. It is anticipated that preliminary LES model configurations with bulk microphysics for the SAM and WRF models and initial simulations of 6-10 cases of shallow convection, including an ensemble of forcing data, model output, and associated ARM data diagnostics will be available by June 2016. Simulations of additional shallow convection cases that include input data from the new ARM Boundary Facilities and simulations that include spectral bin microphysics are expected to be available by January 2017. Transition of the pilot project to ongoing, routine ARM simulations for shallow convection events is expected by summer 2017.

## **Requirements for projects**

It is expected that one or two comprehensive cross-disciplinary atmospheric projects will be selected in response to this FOA. Specifically, each project will bring together a team of observational and data scientists from the ARM community, process analysis and modeling scientists from the ASR community, and climate modeling and computational scientists from the ESM community to develop new computationally efficient, scale-aware physics capabilities for ACME (versions 2-3) and validate these capabilities against ARM observations and LES output. Proposed efforts should draw from topics and strategies described in a recent DOE draft workshop report (<a href="http://www.arm.gov/publications/programdocs/acme-arm-asr-draft-report.pdf">http://www.arm.gov/publications/programdocs/acme-arm-asr-draft-report.pdf</a>). Projects should clearly address each of the following expectations, which will be assessed under the "Scientific and Technical Merit" and "Appropriateness of the Proposed Method or Approach" merit review criteria (See Section V.A.2 for merit review criteria).

- 1. Identify a targeted and well-defined set of aerosol and/or cloud processes that currently limit ACME's predictive capability, so that improvement of these in ACME will be likely to improve its coupled climate simulation and lead to significant advancement of one or more "grand-challenge" science goals.
- 2. Include a plan to improve the representations of the targeted processes at multiple resolutions, spanning coarse (100km) to ultra-high (10km) resolutions of ACME to those attained by LES-CRM models, making use of high-resolution models and observations to develop representations appropriate for ACME.
- 3. Systematically construct an end-to-end plan to simulate and validate (with observations) each process in a manner appropriate to each scale and model configuration. This methodology should first be implemented on the key aerosol/cloud processes being improved within this project, but should also have broader applicability to other atmospheric processes. The validation methodology may build on existing BER capabilities such as the Cloud-Associated Parameterizations Testbed (CAPT), LASSO, the Aerosol Modeling Testbed (AMT), or other testbed projects, if appropriate for the processes being studied.
- 4. Global model development and testing should be done using the ACME model and, if appropriate to the project goals, higher-resolution modeling should use the ARM LASSO project capabilities.
- 5. Use existing/upcoming observations from ARM as well as other appropriate and available sources, to develop *virtual field campaign datasets* that include a well-organized and documented collection of ARM observations (including multiple-parameter relationships), model-forcing data sets, and needed external datasets (e.g., satellite, weather radar) to develop and validate the process parameterizations at a range of scales.
- 6. All software developed under the project should be of high-quality and follow modern software practices (see, e.g., <u>ACME software practice</u> and <u>ARM coding guidelines</u>). Note that it is expected that any software developed under this project will be shared with the ACME and broader BER communities. Any new diagnostics for ACME should be designed to contribute to the ACME diagnostics packages.
- 7. Include a Data Management Plan (DMP) that is consistent with the <u>ACME DMP</u> and with the <u>ARM data policy</u>. Virtual field campaign datasets developed under this project should be preserved and shared with the community as PI Data Products in the ARM archive.

As noted in Section IV.C of this FOA, a Data Management Plan is a required element for all applications. Data Management plans should be no longer than 3 pages, and must be included as an appendix (i.e., not counted in the page limitation) as described in Section IV.

Each team project will be led by a DOE laboratory, but should include university and/or non-DOE-Laboratory scientists as co-investigators and collaborators. The latter investigators are encouraged to contact the appropriate Divisions within the DOE National Laboratories to discuss potential teaming arrangements. More information on the DOE National Laboratories is available at <a href="http://www.energy.gov/about-national-labs">http://www.energy.gov/about-national-labs</a>. DOE National Laboratories may apply as both team leads and as collaborators to another Laboratory's team. Non DOE-Laboratory institutions may apply as members of multiple teams. However, an individual researcher may

participate in at most two full applications as a Principal Investigator, Co-Principal Investigator, or Senior Personnel; and a National Laboratory can submit at most one application as a team lead. It is expected that all team members will have clear roles that are integrated with the broader project and contribute directly to project goals/deliverables.

Each of the following guidelines regarding project management and team integration should be addressed in the application. Note that "Team Integration and Project Management" is one of the merit review criteria for the proposed projects (See Section V.A.2 for merit review criteria).

- 1. The integrated team should consist of observational scientists, process analysis and/or modeling scientists, climate modelers, and computational scientists. While there will be a lead PI for the project, each of these elements should be clearly represented on the leadership/management team.
- 2. The project should work directly with (develop and use) the ACME model and may use outputs from the LASSO project (if appropriate to the project goals). The proposed project should clearly identify liaisons or integrators between the proposed project and ACME and/or LASSO. These individuals will be responsible for establishing integration of project tasks, timelines and software of the new project with the ACME/LASSO projects, and will facilitate communication across projects. If significant additional activities for the ACME or LASSO projects (e.g., additional simulations, software development, etc.) are required for integration with the proposed project, they should be planned and budgeted for in this proposal.
- 3. The project management structure and timelines should be clear and include demonstrable integration of institutions, scales of study, and disciplines (e.g. modeling and observations). There should be at least a 35% time commitment from all team members unless there is clear justification for smaller commitment for particular individuals and roles.

If selected, projects will engage in the <u>ACME collaboration</u> arrangement, enabling access of project developers to ACME code and software. While each project should propose, and will be evaluated on the quality of, a specific plan for validation of the proposed model element and its resulting ACME implementation, projects must share software as specified in the ACME collaboration arrangement and will ideally develop common validation elements available to all projects during the project funding period.

Investigators currently funded by ARM, ASR, or ESM (including ARM infrastructure members and investigators engaged in the ACME or LASSO projects) may apply to this FOA. However, they should clearly describe how the efforts proposed under this FOA differ from their currently funded projects.

# **Participation in BER meetings:**

Due to the integrated nature of this project, and the need to connect to both the ARM/ASR and ACME communities, the project should be represented by attendance at one or both ACME face-to-face Team meetings and the ARM/ASR Joint User Facility/PI Meeting; key project personnel are also encouraged to participate in ACME task telephone calls and ASR working groups, as

appropriate to the mutual goals of the teams. **Appropriate** costs for participation in these meetings by key personnel should be included in the budget. **Cost estimates should assume that each meeting is for a one-week period in the Washington, DC area.** 

#### Collaboration

DOE anticipates supporting multi-institutional projects under this FOA. Multi-institutional teams must be led by a DOE National Laboratory and are expected to be strongly coordinated. Multi-institutional applications must include a project management plan in the project narrative that clearly indicates the role of each institution.

Collaborative applications submitted from different institutions must clearly indicate that they are part of a collaborative project/group. Every partner institution must submit an application through its own sponsored research office. Each collaborative group can have only one lead institution. Each application within the collaborative group, including the narrative and all required appendices and attachments, must be identical with the following exceptions:

- Each application must contain a correct SF-424 (R&R) cover page for the submitting institution only.
- Each application must contain a unique budget corresponding to the expenditures for that application's submitting institution only.
- Each application must contain a unique budget justification corresponding to the expenditures for that application's submitting institution only.

DOE National Laboratories should apply separately through Lab Announcement LAB 16-1530 in PAMS, while the non-Laboratory collaborating institutions' applications should be submitted following the above rules in response to this FOA.

# **Section II – AWARD INFORMATION**

### A. TYPE OF AWARD INSTRUMENT

DOE anticipates awarding cooperative agreements under this FOA, in order to ensure effective coordination with the ACME project.

DOE will consider funding multi-institution collaborations under this FOA (see previous section).

#### **B. ESTIMATED FUNDING**

It is anticipated that approximately \$1,000,000 per year will be available under DE-FOA-0001530 and approximately \$4,400,000 per year under the companion DOE National Laboratory Announcement LAB 16-1530, subject to appropriations of funds by the Congress. Non-DOE Laboratory awards will be Cooperative Agreements and are expected to be made for a period of three years at a funding level appropriate for the proposed scope, with out-year support contingent on the availability of Climate Model Development and Validation funds and satisfactory progress.

DOE is under no obligation to pay for any costs associated with the preparation or submission of an application. DOE reserves the right to fund, in whole or in part, any, all, or none of the applications submitted in response to this FOA.

In addition to the individual award ceiling in Section C, the total annual budget for all non-DOE National Laboratory members of the multi-institutional collaboration may not exceed \$500,000 per year.

#### C. MAXIMUM AND MINIMUM AWARD SIZE

The award size will depend on the number of meritorious applications and the availability of appropriated funds.

#### **Ceiling**

\$300,000 per year per non-DOE-Laboratory institution.

#### Floor

\$50,000 per year.

#### D. EXPECTED NUMBER OF AWARDS

Approximately 2 (multi-institutional) project awards are expected.

The exact number of awards will depend on the number of meritorious applications and the availability of appropriated funds.

#### E. ANTICIPATED AWARD SIZE

It is anticipated that award sizes for each non-DOE National Laboratory institution will range from \$50,000 per year to \$300,000 per year, with the total of these to be \$500,000 per year per project.

The award size will depend on the number of meritorious applications and the availability of appropriated funds.

### F. PERIOD OF PERFORMANCE

Non-DOE Laboratory collaborations will be Cooperative Agreement Awards, and are expected to be made for a period of three years.

Continuation funding (funding for the second and subsequent budget periods) is contingent on: (1) availability of funds appropriated by Congress and future year budget authority; (2) progress towards meeting the objectives of the approved application; (3) submission of required reports; and (4) compliance with the terms and conditions of the award.

# G. TYPE OF APPLICATION

DOE will accept only new applications under this FOA.

# Section III – ELIGIBILITY INFORMATION

### A. ELIGIBLE APPLICANTS

All types of applicants are eligible to apply, except Federally Funded Research and Development Center (FFRDC) Contractors, and nonprofit organizations described in section 501(c)(4) of the Internal Revenue Code of 1986 that engaged in lobbying activities after December 31, 1995.

DOE National Laboratories may apply as both team leads and as collaborators to another Laboratory's team. Non DOE-Laboratory institutions may apply as members of multiple teams. However, an individual researcher may participate in at most two (2) full applications as a Principal Investigator, Co-Principal Investigator, or Senior Personnel; and a National Laboratory can submit at most one application as a team lead.

Applicants that are not domestic organizations should be advised that:

- Individual applicants are unlikely to possess the skills, abilities, and resources to successfully
  accomplish the objectives of this FOA. Individual applicants are encouraged to address this
  concern in their applications and to demonstrate how they will accomplish the objectives of
  this FOA.
- Non-domestic applicants are advised that successful applications from non-domestic applicants include a detailed demonstration of how the applicant possesses skills, resources, and abilities that do not exist among potential domestic applicants.

A Letter of Intent is highly recommended and must be submitted by March 3, 2016 at 5:00 pm Eastern Time. For multi-institutional collaborations, a single letter of intent should be submitted by the lead institution on behalf of the project team.

The LOI is to help in planning the review and the selection of potential reviewers for the application. For this purpose, the LOI must include the following information:

- Anticipated title of proposed project
- Principal investigator name, email, and institution
- Name and institution of each co-investigator or senior personnel
- Anticipated budget (per year) for each institution
- Brief description of the key cloud or aerosol process that will be addressed in the application and how the cross-disciplinary nature of the team is suited to work in an end-to-end manner between measurements and modeling, and across scales from field to global, in order to improve global climate model simulations of this process.
- For each funded investigator or senior personnel, provide an alphabetical list of collaborative co-investigators including co-authors of the past 48 months, co-editors of the past 24 months, graduate and postdoctoral advisors/advisees, and close associations. For publications or collaborations with more than 10 authors, only list those individuals in the core group with whom the Principal Investigator interacted on a regular basis while the research was being done.

Not including the list of investigators and collaborators, the LOI may not exceed two pages.

The LOI must be submitted electronically through the DOE Office of Science Portfolio Analysis and Management System (PAMS) website <a href="https://pamspublic.science.energy.gov/">https://pamspublic.science.energy.gov/</a>. It is important that the LOI be a single file with extension .pdf, .docx, or .doc. The filename should not exceed 50 characters. The Principal Investigator (PI) and anyone submitting on behalf of the PI must register for an account in PAMS before it will be possible to submit a letter of intent. All PIs and those submitting LOIs on behalf of PIs are encouraged to establish PAMS accounts as soon as possible to avoid submission delays.

You may use the Internet Explorer, Firefox, Google Chrome, or Safari browsers to access PAMS.

# Section V - APPLICATION REVIEW INFORMATION

### A. CRITERIA

### 1. Initial Review Criteria

Prior to a comprehensive merit evaluation, DOE will perform an initial review in accordance with 10 CFR 605.10(b) to determine that (1) the applicant is eligible for the award; (2) the information required by the FOA has been submitted; (3) all mandatory requirements are satisfied; (4) the proposed project is responsive to the objectives of the funding opportunity announcement, and (5) the proposed project is not duplicative of programmatic work. - Competency of Applicant's Personnel and Adequacy of Proposed Resources; and
- Reasonableness and Appropriateness of the Proposed Budget.

The evaluation process will include program policy factors such as the relevance of the proposed research to the terms of the FOA and the agency's programmatic needs. Note that external peer reviewers are selected with regard to both their scientific expertise and the absence of conflict-of-interest issues. Both Federal and non-Federal reviewers may be used, and submission of an application constitutes agreement that this is acceptable to the investigator(s) and the submitting institution.

The questions below are provided to the merit reviewers to elaborate the criteria established by regulation:

SCIENTIFIC AND/OR TECHNICAL MERIT OF THE PROPOSED RESEARCH

- What is the scientific innovation of proposed research?
- What is the likelihood of achieving valuable results?
- How might the results of the proposed work impact the direction, progress, and thinking in relevant scientific fields of research?
- How does the proposed work compare with other efforts in its field, both in terms of scientific and/or technical merit and originality?
- Does the proposal articulate a well-defined set of aerosol and/or cloud processes that

currently limit ACME's predictive capability, as well as "grand challenge" research goals that could be achieved as a result of this project or these model improvements?

### APPROPRIATENESS OF THE PROPOSED METHOD OR APPROACH

- Does the proposed project present an end-to-end approach, with respect to a) process scales, b) model-observational approaches, and c) a careful "scale-dependent" validation plan, that is suitable for making progress on the process of interest?
- How logical and feasible are the research approaches? Are the conceptual framework, methods, and analyses well justified, adequately developed, and likely to lead to scientifically valid conclusions?
- Does the proposed plan effectively utilize appropriate DOE modeling and measurement capabilities, including the ACME model, ARM measurements, and LASSO models?
- Does the proposal recognize significant potential problems and consider alternative strategies?

### TEAM INTEGRATION AND PROJECT MANAGEMENT

- Is there a sound management strategy for coordinating the research within the project?
- Is the proposed research plan a cohesive and integrated effort that is greater than the sum of its individual parts?
- Is the role of each partnering institution clearly articulated in the proposal? Does the management plan adequately engage all institutions and investigators?
- Does the management plan include a plan and approach to integrate with ACME, LASSO and ARM dataset, development, scientific and software elements? Is the role of the project liaisons appropriate and adequate for successful project integration?
- Does the proposal include a task timeline and team structure appropriate to the project scope?
- Is the Data Management Plan suitable for the proposed research and to what extent does it support the validation of research results?

# COMPETENCY OF APPLICANT'S PERSONNEL AND ADEQUACY OF PROPOSED RESOURCES

- What is the past performance and potential of the Principal Investigator (PI) and other key team leaders?
- How well qualified is the research team, including key project leaders and liaisons, to carry out the proposed research?
- Is the role and merit of each partnering institution clearly indicated in the proposal?
- Is each team member committed at 35%; are any exceptions to this adequately justified?
- Are the research environment and facilities adequate for performing the research?

### REASONABLENESS AND APPROPRIATENESS OF THE PROPOSED BUDGET

- Are the proposed budget and staffing levels adequate to carry out the proposed research?
- Is the budget reasonable and appropriate for the scope?

# **B. REVIEW AND SELECTION PROCESS**

### 1. Merit Review

Applications that pass the initial review will be subjected to a formal merit review and will be evaluated based on the criteria codified at 10 CFR 605.10(d) in accordance with the guidance provided in the "Office of Science Merit Review System for Financial Assistance," which is available at: http://science.energy.gov/grants/policy-and-guidance/merit-review-system/.

#### 2. Selection

The Selection Officials will consider the following items, listed in no order of significance:

- Scientific and technical merit of the proposed activity as determined by merit review
- Availability of funds
- Relevance of the proposed activity to Office of Science priorities
- Ensuring an appropriate balance of activities within Office of Science programs
- Previous performance

### 3. Review of Risk

Pursuant to 2 CFR 200.205, DOE will conduct an additional review of the risk posed by applications submitted under this FOA. Such review of risk will include:

- Technical merit of the application,
- Reports and findings from audits performed under 2 CFR 200 or OMB Circular A-133, and
- Systems maintained under 2 CFR 180, including the SAM "Exclusions" and "Do Not Pay" systems.

No legal liability on the part of the Government for any payment may arise until funds are made available to the contracting officer for this award and until the awardee receives notice of such availability, to be confirmed in writing by the contracting officer.

# Glossary of Useful Grants and Cooperative Agreement terms

**acquisition cost** The cost of an asset, including the cost to put it in place. When used with equipment

(capital expenditure), the term means the net invoice price of property or supplies including cost of modifications, attachments, accessories, or auxiliary apparatus necessary to make the property usable for the purpose for which it was acquired. Other charges, such as the cost of installation, transportation, taxes, duty, or protective intransit insurance, are included or excluded from the unit acquisition cost in accordance with the recipient's regular accounting practices. It does not include costs for rental of

property or alteration and rental of real property.

**administrative**The general business management practices that are common to the administration of all grants, such as financial accountability, reporting, equipment management, and

retention of records.

**allocation** The process of assigning costs to one or more cost objectives, in reasonable and realistic

proportion to the benefit provided or other equitable relationship.

**allocability** The principle which requires that an expense or service charged must directly benefit

and be necessary for the performance of the project; when multiple projects are

benefited reasonable proportions must be able to be assigned.

**allowable cost** A cost incurred by a recipient that is: (1) reasonable for the performance of the award;

(2) allocable; (3) in conformance with any limitations or exclusions set forth in the Federal cost principles applicable to the organization incurring the cost or in the award documents as to the type or amount of cost; (4) consistent with regulations, policies, and procedures of the recipient that are applied uniformly to both federally supported and other activities of the organization; (5) accorded consistent treatment as a direct or indirect cost; (6) determined in accordance with generally accepted accounting

principles; and (7) not included as a cost in any other federally supported award (unless

specifically authorized by statute).

**application** A request for financial support of a project or activity submitted to DOE on specified

forms and in accordance with DOE instructions. Also known as a proposal

**Appropriation Act** The statute that provides the authority for Federal agencies to incur obligations to and

make payments out of the U.S. treasury for specified purposes.

**approved budget** The financial expenditure plan for the grant-supported project or activity, including

revisions approved by DOE and permissible revisions made by the grantee. The approved budget consists of Federal (grant) funds and, if required by the terms and conditions of the award, non-Federal participation in the form of matching or cost sharing. The approved budget specified in the award documents may be shown in detailed budget categories or as total costs without a categorical breakout. Expenditures charged to an approved budget that consists of both Federal and non-Federal shares are

deemed to be borne by the grantee in the same proportion as the percentage of

Federal/non-Federal participation in the overall budget.

**assurance** A certification by an applicant, normally included with the application or State plan,

indicating that the entity is in compliance with, or that it will abide by, a particular

requirement if awarded a Federal grant.

authorized The individual, named by the applicant organization, who is authorized to act for the organizational applicant and to assume the obligations imposed by the Federal laws, regulations, requirements, and conditions that apply to grant applications or grant awards.

The provision of funds by DOF, based on an approved application and budget or

The provision of funds by DOE, based on an approved application and budget or progress report, to an organizational entity or an individual to carry out a project or

activity.

**award documents**The entirety of the documents describing the legal relationship between DOE and an awardee or recipient. The award documents include an Assistance Agreement and other

documents which may be incorporated by reference or as attachments to the Assistance Agreement. The award documents are the official, legally binding document, signed (or the electronic equivalent of signature) by a contracting officer that:

- notifies the recipient of the award of a grant;
- contains or references all the terms and conditions of the grant and Federal funding limits and obligations; and,
- provides the documentary basis for recording the obligation of Federal funds in the DOE accounting system.

**Bayh-Dole Act** 

Law which encourages universities and researchers to develop their inventions into marketable products; formal citation is Section 6 of the Patent and Trademark Amendment of 1980, Pub. L 96-517

budget

An estimate of expenditures to be incurred in the performance of a proposed statement of work, or the financial plan or cost assessment for the grant proposal. The budget represents costs associated with project implementation.

budget period

The intervals of time (usually 12 months each) into which a project period is divided for budgetary and funding purposes.

business officer

The financial official of the grantee who has primary fiscal responsibility for the grant. Also known as authorized organizational representative.

carryover

Unobligated Federal funds remaining at the end of any budget period that, with the approval of the contracting officer or under an automatic authority, may be carried forward to another budget period to cover allowable costs of that budget period (whether as an offset or additional authorization). Obligated, but unliquidated, funds are not considered carryover.

change in scope

An activity whereby the objectives or specific aims identified in the approved grant application are significantly changed by the grantee after award. Contracting officer prior approval is required for a change in scope to be allowable under an award. The process by which a Federal awarding agency determines that all applicable

closeout

The process by which a Federal awarding agency determines that all applicable administrative actions and all required work under an award have been completed by the grantee and the Federal awarding agency.

competitive segment

The initial project period recommended for support or each extension of a project period resulting from a renewal award.

conference (domestic or international)

A symposium, seminar, workshop, or any other organized and formal meeting, whether conducted face-to-face or via the Internet, where individuals assemble (or meet virtually) to exchange information and views or explore or clarify a defined subject, problem, or area of knowledge, whether or not a published report results from such meeting.

consortium or subaward agreement

A formalized agreement whereby a research project is carried out by the grantee and one or more other organizations that are separate legal entities. Under the agreement, the grantee must perform a substantive role in the conduct of the planned research and not merely serve as a conduit of funds to another party or parties. These agreements typically involve a specific level of effort from the consortium organization's PD/PI and a categorical breakdown of costs, such as personnel, supplies, and other allowable expenses, including F&A costs. The relationship between the recipient and the collaborating organizations is considered a subaward relationship.

consultant

An individual who provides professional advice or services for a fee, but normally not as an employee of the engaging party. In unusual situations, an individual may be both a consultant and an employee of the same party, receiving compensation for some services as a consultant and for other work as a salaried employee. To prevent apparent or actual conflicts of interest, grantees and consultants must establish written guidelines indicating the conditions of payment of consulting fees. Consultants also include firms that provide professional advice or services.

continuation application/award

A financial assistance request (in the form of an application or progress report) or resulting award for a subsequent budget period within a previously approved project period for which a recipient does not have to compete with other applicants.

contract

An award instrument used to acquire from a non-federal party, by purchase, lease, or

Contract (or Grants Management) Officer barter, property or services for the direct benefit or use of the Federal government. The same term may be used to describe a vendor relationship between a recipient and another party under a grant (to acquire routine goods and services); however, the recipient may use subaward to describe the contract under a grant relationship. A DOE official responsible for the business management aspects of grants and cooperative agreements, including review, negotiation, award, and administration, and for the interpretation of grants administration policies and provisions. COs and GMOs are delegated the authority to obligate DOE to the expenditure of funds and permit changes to approved projects on behalf of DOE.

**Contract (or Grants Management) Specialist**  A DOE staff member who works with a contract or grants management officer and is assigned the day-to-day management of a portfolio of grants and/or cooperative agreements. These activities include, but are not limited to, evaluating grant applications for administrative content and compliance with statutes, regulations, and guidelines; negotiating grants; providing consultation and technical assistance to grantees; and administering grants after award.

cooperative agreement

A type of financial assistance used when there will be substantial Federal scientific or programmatic involvement. Substantial involvement means that, after award, scientific or program staff will assist, guide, coordinate, or participate in project activities. The government-wide principles, issued by OMB (or, in the case of commercial organizations, the Federal Acquisition Regulation [48 CFR 21], or, in the case of hospitals, 45 CFR 74, Appendix E, "Principles For Determining Costs Applicable to Research and Development Under Grants and Contracts with Hospitals"), on allowability and unallowability of costs under federally sponsored agreements. As of

cost principles

December 26, 2014, the cost principles will be consolidated in 2 CFR 200. The portion of the costs of a project or program not borne by the sponsor; these could be grantee contributions or third-party in-kind contributions; costs used to satisfy cost sharing requirements are subject to the same policies governing allowability as other

costs of the project. Research grants are generally not subject to cost sharing requirements. Also known as matching.

cost sharing

deadline

debarment and suspension

The published date and/or time that a grant application is to be either postmarked/mailed or electronically submitted to the funding agency

postmarked/mailed or electronically submitted to the funding agency.

The actions taken by a debarring official in accordance with OMB guidance at 2 CFR

180, "Non-procurement Debarment and Suspension," to exclude a person or organization from participating in grants and other non-procurement awards

government-wide. If debarred or suspended, the person or organization may not receive financial assistance (under a grant, cooperative agreement, or subaward, or contract under a grant) for a specified period of time. Debarments and suspensions carried out pursuant to 2 CFR 376 are distinct from post-award suspension action by an awarding

agency.

**direct costs** Costs that can be identified specifically with a particular sponsored project, an

instructional activity, or any other institutional activity, or that can be directly assigned

to such activities relatively easily with a high degree of accuracy.

A charge to a grant that the Federal awarding agency determines to be unallowable in accordance with the applicable Federal cost principles or other terms and conditions

contained in the award.

domestic organization

A public (including a State or other governmental agency) or private non-profit or forprofit organization that is located in the United States or its territories, is subject to U.S. laws, and assumes legal and financial accountability for awarded funds and for the performance of the grant-supported activities.

**DUNS** number

disallowance

A nine-digit number established and assigned by Dun and Bradstreet to uniquely

identify a business entity.

effort

The amount of time, usually expressed as a percentage of the total, which a faculty member or other employee spends on a sponsored project. No one is allowed to spend more than 100% total commitment on all academic activities, including grant-sponsored research, university-sponsored research, teaching, administration, advising and other

equipment

contracted duties. Effort is indicated on the budget in units of person-months. An article of tangible nonexpendable personal property that has a useful life of more than 1 year and an acquisition cost per unit that equals or exceeds \$5,000 or the capitalization threshold established by the organization, whichever is less.

expanded authorities

Authorization to grantees under certain research grant mechanisms which waives the requirement for prior agency approval for specified actions related to awards. Example: 90-day preaward spending authority, no cost extensions for up to one additional year, and automatic carryover of unobligated funds from one budget period to the next. The expanded authorities are now contained in the standard terms and conditions for most research grants.

expiration date

Generally, the date signifying the end of the current project period, after which the grantee is not authorized to obligate grant funds.

facilities and administrative costs

Costs that are incurred by a grantee for common or joint objectives and that, therefore, cannot be identified specifically with a particular project or program. These costs also are known as indirect costs.

Federal Financial Report Submitted on Standard Form (SF) 425, to indicate the status of awarded funds for the period covered. Frequency of reporting is specified in the Reporting Checklist provided as part of the award documents. Replaces the SF-269 Financial Status Report (FSR) Transfer by DOE of money or property to an eligible entity to support or stimulate a public purpose authorized by statute.

financial assistance

See Federal Financial Report.

Financial Status Report foreign travel

Foreign travel includes travel outside of the United States and its territories and possessions (Guam, American Samoa, Puerto Rico, the Virgin Islands, and the Canal Zone) and Canada. A trip is considered foreign travel for all legs of the itinerary if the traveler does not return to his or her post prior to departure for a foreign destination. Costs for foreign travel may be restricted by the language of a Funding Opportunity Announcement.

funding opportunity announcement

A publicly available document by which a Federal Agency makes known its intentions to award discretionary grants or cooperative agreements, usually as a result of competition for funds. Funding opportunity announcements may be known as program announcements, requests for applications, notices of funding availability, solicitations, or other names depending on the Agency and type of program. Funding opportunity announcements can be found at <a href="mailto:Grants.gov/FIND">Grants.gov/FIND</a>. An FOA may also be known as a solicitation.

grant

A financial assistance mechanism providing money, property, or both to an eligible entity to carry out an approved project or activity. A grant is used whenever DOE anticipates no substantial programmatic involvement with the recipient during performance of the financially assisted activities.

grant-supported project or activity

Those activities specified or described in a grant application or in a subsequent submission that are approved by DOE for funding, regardless of whether Federal funding constitutes all or only a portion of the financial support necessary to carry them out.

grantee

The organization or individual awarded a grant or cooperative agreement by DOE that is responsible and accountable for the use of the funds provided and for the performance of the grant-supported project or activity. The grantee is the entire legal entity even if a particular component is designated in award documents. The grantee is legally responsible and accountable to DOE for the performance and financial aspects of the grant-supported project or activity. Also known as awardee or recipient.

**Grants.gov** 

Grants.gov (http://www.grants.gov/) has been designated by the Office of Management and Budget as the single access point for all grant programs offered by 26 Federal grantmaking agencies. It provides a single interface for agencies to announce their grant opportunities and for all applicants to find and apply for those opportunities. See facilities and administrative costs definition.

indirect costs institutional base salary

The annual compensation paid by an organization for an employee's appointment, whether that individual's time is spent on research, teaching, patient care, or other

matching or cost sharing

activities. Base salary excludes any income that an individual may be permitted to earn outside of duties for the applicant/grantee organization. Base salary may not be increased as a result of replacing organizational salary funds with grant funds. The value of third-party in-kind contributions and the portion of the costs of a federally assisted project or program not borne by the Federal government. Matching or cost sharing may be required by statute or program regulation. Costs used to satisfy matching or cost-sharing requirements are subject to the same policies governing allowability as other costs under the approved budget.

merit (or peer) review

The process that involves the consistent application of standards and procedures that produce fair, equitable, and objective examinations of applications based on an evaluation of scientific or technical merit or other relevant aspects of the application. The review is performed by experts (reviewers) in the field of endeavor for which support is requested. Merit review is intended to provide guidance and to the DOE individuals responsible for making award decisions.

monitoring

A process whereby the programmatic and business management performance aspects of a grant are assessed by reviewing information gathered from various required reports, audits, site visits, and other sources.

no-cost extension

An extension of time to a project period and/or budget period to complete the work of the grant under that period, without additional Federal funds or competition.

non-Federal share

When cost sharing or matching is required as a condition of an award, the portion of allowable project/program costs not borne by the Federal government.

allowable project/program costs not borne by the Federal government. The amounts for which the recipient has made binding commitments for orders placed for property and services, contracts and subawards, and similar transactions during a funding period that will require payment during the same or a future period. Government-wide guidance issued to Heads of Federal agencies by the Director of

obligations

OMB. OMB Circulars directly pertinent to grants include the following:

• cost principles (OMB Circular A-21, OMB Circular A-87, and OMB Circular A-

**OMB Circulars** 

- uniform administrative requirements (OMB Circular A-102 and OMB Circular A-110).
- audit requirements for non-profit organizations (OMB Circular A-133). Some (but not all) of these OMB Circulars have been reissued in Title 2 of the Code of Federal Regulations.

DOE administrative regulations are located in Title 10 of the Code of Federal Regulations.

Other Significant Contributors

Individuals who have committed to contribute to the scientific development or execution of the project, but are not committing any specified measurable effort (i.e., person months) to the project. These individuals are typically presented at "effort of zero person months" or "as needed." Individuals with measurable effort may not be listed as Other Significant Contributors (OSCs). Consultants should be included if they meet this definition.

participant

Program participants are the recipients of service or training provided at a workshop, conference, seminar, symposium or other short-term instructional or information-sharing activity funded by an external grant or award, or the training beneficiaries of the project or program funded by an external grant or award. A participant is not involved in providing any deliverable to the grantee or a third party or would not be terminated or replaced for failure to perform.

participant costs

Costs used to pay program participants small stipends and reimbursement of travel costs or other out-of-pocket costs incurred to support attendance at a workshop, conference, seminar, symposium, or other short-term training or information-sharing activity. The metric for expressing the effort (amount of time) PD/PI(s), faculty and other senior/key personnel devote to a specific project. The effort is based on the type of appointment of the individual with the organization; e.g., calendar year, academic year, and/or summer term; and the organization's definition of such. For instance, some institutions define the academic year as a 9-month appointment while others define it as

person months

a 10-month appointment.

pre-application or preproposal A brief outline or narrative of proposed work and sometimes budget, for informal review by a sponsor to determine whether a full application should be submitted. Three predominant reasons for requiring submission of a preliminary pre-application are:

- Reduce the applicant's unnecessary effort in proposal preparation when the chance of success is very small. This is particularly true of exploratory initiatives where the community senses that a major new direction is being identified, or competitions that will result in a small number of actual awards.
- Increase the overall quality of the full submission.
- Distill the number of applications that will be submitted to the agency and the number of anticipated reviewers needed to review.

Any cost incurred prior to the beginning date of the project period or the initial budget period of a competitive segment (under a multi-year award), in anticipation of the award and at the applicant's own risk, for otherwise allowable costs.

Written approval from the designated contracting officer required for specified post-award changes in the approved project or budget. Such approval must be obtained before undertaking the proposed activity or spending DOE funds

The individual(s) designated by the applicant organization to have the appropriate level of authority and responsibility to direct the project or program to be supported by the award. The applicant organization may designate multiple individuals as program directors/principal investigators (PD/PIs) who share the authority and responsibility for leading and directing the project, intellectually and logistically. When multiple PD/PIs are named, each is responsible and accountable to the applicant organization, or as appropriate, to a collaborating organization for the proper conduct of the project or program including the submission of all required reports. The presence of more than one PD/PI on an application or award diminishes neither the responsibility nor the accountability of any individual PD/PI.

Program income is gross income earned by a research grant recipient from the activities, part or all of which are borne as a direct cost by the grant. Examples are fees for services performed under the grant, rental or usage fees charged for use of equipment purchased with grant funds, third party patient reimbursements for hospital or medical services paid from the grant, funds generated by the sale of commodities, such as cell lines or research animals developed from or paid for from the grant, and patent or copyright royalties.

The DOE official responsible for the programmatic, scientific, and/or technical aspects of a grant. The same role is filled by Program Directors, Program Officers, or Project Directors at other Federal agencies.

Periodic, frequently annual, report submitted by the grantee and used by DOE to assess progress and to determine whether to provide funding for the budget period subsequent to that covered by the report.

 $Location(s) \ of \ where \ the \ work \ described \ in \ the \ research \ plan \ will \ be \ conducted.$ 

The total time for which Federal support of a project has been programmatically approved as shown in the award documents; however, it does not constitute a commitment by the Federal government to fund the entire period. The total project period comprises the initial competitive segment, any subsequent competitive segments resulting from a renewal award(s), and extensions.

See application.

Reallocation of funds available for spending between budget categories to allow best use of funds to accomplish the project goals.

The organizational entity or individual receiving a grant or cooperative agreement. An application requesting additional funding for a period subsequent to that provided by a current award. Renewal applications compete for funds with all other peer reviewed applications and must be developed as fully as though the applicant is applying for the first time.

prior approval

research

A systematic, intensive study intended to increase knowledge or understanding of the subject studied, a systematic study specifically directed toward applying new knowledge to meet a recognized need, or a systematic application of knowledge to the production of useful materials, devices, and systems or methods, including design, development, and improvement of prototypes and new processes to meet specific requirements. Also termed "research and development."

research misconduct

Fabrication, falsification, plagiarism, or other practices that seriously deviate from those that are commonly accepted within the scientific community in proposing, performing, or reporting research, or in reporting research results; does not include honest error or honest differences in interpretations or judgments of data.

SAM.gov

The System for Award Management (SAM) is the Government-wide system that consolidated the Central Contractor Registration (CCR), the Excluded Parties List System (EPLS), the Online Representations and Certifications Application (ORCA), and the Federal Agency Registration (FedReg).

scope of work

The aims, objectives, and purposes of a grant; as well as the methodology, approach, analyses or other activities; and the tools, technologies, and timeframes needed to meet the grant's objectives. This includes the research or training plan included with the original grant application, along with any approved modifications.

Senior/Key Personnel

The PD/PI and other individuals who contribute to the scientific development or execution of a project in a substantive, measurable way, whether or not they receive salaries or compensation under the grant. Typically these individuals have doctoral or other professional degrees, although individuals at the masters or baccalaureate level may be considered senior/key personnel if their involvement meets this definition. Consultants and those with a postdoctoral role also may be considered senior/key personnel if they meet this definition. "Zero percent" effort or "as needed" is not an acceptable level of involvement for Senior/Key Personnel.

significant rebudgeting

A threshold that is reached when expenditures in a single direct cost budget category deviate (increase or decrease) from the categorical commitment level established for the budget period by more than 25 percent of the total costs awarded. Significant rebudgeting is one indicator of change in scope.

small business concern

A business that is independently owned and operated and not dominant in its field of operation; has its principal place of business in the United States and is organized for profit; is at least 51 percent owned, or in the case of a publicly owned business, at least 51 percent of its voting stock is owned by U.S. citizens or lawfully admitted permanent resident aliens; has, including its affiliates, not more than 500 employees; and meets other regulatory requirements established by the SBA at 13 CFR 121.

See Funding Opportunity Announcement

solicitation subaward

A legal instrument by which a recipient provides funds (or property in lieu of funds) to an eligible subrecipient (or a lower-tier transaction) to perform a substantive portion of the grant-supported program or project. The term includes such financial assistance when provided by any legal agreement (even if the agreement is called a contract) but does not include any form of assistance which is excluded from the definition of a grant, including the recipient's procurement of property or services needed to carry out the project or program. The term includes consortium agreements.

subrecipient

A party that receives a subaward from a recipient or another subrecipient under a Federal financial assistance award and is accountable to the recipient or subrecipient for the use of the Federal funds provided by the subaward.

supplement

A request for an increase in support during a current budget period for expansion of the project's scope or to meet increased costs unforeseen at the time of the new or renewal application. A supplement may increase support for future years in addition to the current year. Supplements require applications and are subject to administrative and merit review.

terms and conditions of award

All legal requirements imposed on a grant by DOE, whether based on statute, regulation, policy, or other document referenced in the grant award, or specified by the grant award document itself. The award documents may include both standard and

special conditions that are considered necessary to attain the grant's objectives, facilitate post-award administration of the grant, conserve grant funds, or otherwise protect the

Federal government's interests.

unallowable costs Specific categories of costs that cannot be charged, directly or indirectly, to federally

sponsored agreements in accordance with federal regulations or the terms and

conditions of the award.

unliquidated obligation For reports prepared on a cash basis, the amount of obligations incurred by the recipient

that has not been paid; or

For reports prepared on an accrued expenditure basis, the amount of obligations

incurred by the recipient for which an outlay has not been recorded.

**unobligated balance** The portion of the funds authorized by the Federal agency for expenditure by the

recipient that has not been obligated by the recipient.

Validate In the context of the data management plan requirements, validate means to support,

corroborate, verify, or otherwise determine the legitimacy of the research findings. Validation of research findings could be accomplished by reproducing the original experiment or analyses, comparing and contrasting the results against those of a news

experiment or analyses, or by some other means.
