## SUMMARY

DOE's Established Program to Stimulate Competitive Research (DOE EPSCoR) hereby announces its interest in receiving applications from <u>eligible jurisdictions</u> for Implementation Grants. The applications are sought for research in key science and technology areas related to DOE missions as limited by the specific language of this FOA.

Note that there is a listing of <u>areas of either specific interest or disinterest</u> under the section labelled Supplementary Information. Please review this list carefully when considering preparation of a potential application. Assessment of responsiveness to the requirements of the FOA will be part of the review of the required pre-applications. Non-responsive pre-applications will be not be permitted to submit an application. In addition, a comparative review of preapplications by program managers will be used to determine the most competitive preapplications for encouragement of application submissions.

Grants awarded under this program are intended to improve research capability through the support of a group of scientists and engineers, including graduate students and post-doctoral fellows, working on a common scientific theme in one or more than one EPSCoR jurisdictions. These awards are not appropriate mechanisms to provide support for individual faculty science and technology research projects.

While the academic, non-profit and industrial research community is welcome to lead or to participate in applications, a strong component of graduate student education is required for all applicants. DOE EPSCoR currently follows eligibility determinations made by the National

Science Foundation Experimental Program to Stimulate Competitive Research (NSF EPSCoR) for its Research Infrastructure Improvement program. Thus, entities located within the following jurisdictions will be eligible to apply under this FOA: Alabama, Alaska, Arkansas, Delaware, Guam, Hawaii, Idaho, Kansas, Kentucky, Louisiana, Maine, Mississippi, Montana, Nebraska, Nevada, New Hampshire, North Dakota, Oklahoma, Puerto Rico, Rhode Island, South Carolina, South Dakota, Vermont, Virgin Islands, West Virginia, and Wyoming.

# SUPPLEMENTARY INFORMATION

## **Program Objectives**

The U.S. Department of Energy's Established Program to Stimulate Competitive Research (DOE EPSCoR) is a federal-state partnership program designed to:

- Enhance the capabilities of designated jurisdictions to conduct sustainable and nationally competitive energy-related research through increased human and technical resources, including training of scientists and engineers.
- Advance DOE's overarching mission by supporting early stage research and development for a wide range of topical areas across the Department:
  - Office of Science: Advanced Scientific Computing Research, Basic Energy Sciences, Biological and Environmental Research, Fusion Energy Sciences, High Energy Physics, and Nuclear Physics
  - Technology Offices: Electricity, Energy Efficiency and Renewable Energy, Environmental Management, Fossil Energy, Nuclear Energy, and the National Nuclear Security Administration.

The objectives of the DOE EPSCoR Implementation Grants are to:

- Jumpstart capability development in the jurisdiction(s) through increased human and technical resources.
- Support a group of researchers working on a common scientific theme, with mutually supporting goals and objectives.
- When topically relevant to the subject matter of the application, promote collaborations with other institutions of higher education and industry with strong participation by students, postdoctoral fellows, and junior faculty from EPSCoR eligible institutions. These collaborations may include institutions from other EPSCoR jurisdictions. Collaborations involving more than one institution or more than one EPSCoR jurisdiction, while welcome, are not a requirement.

DOE EPSCoR also encourages but does not require implementation grants to work toward building beneficial relationships between institutions in EPSCoR jurisdictions and the 10 worldclass Federally Funded Research and Development Centers (FFRDCs) managed by the Office of Science. These institutions offer opportunities to leverage capabilities of DOE national user facilities and develop intellectual collaborations that may not be available locally. Please refer to the section on <u>funding limitations</u> below for limitations on national laboratory participation.

To further the success of the federal-state partnership and of the implementation grants in general, applicants must be aware of the following expectations:

- 1. Applications must present the opportunities for enhanced academic research and development competitiveness and if appropriate, industrial or economic competitiveness, for the jurisdiction, including plans for the acquisition of sustained non-EPSCoR support.
- 2. Applications must exhibit a coherent focus on one DOE-related research area bringing together multiple researchers.
- 3. Applications must present a management plan for coordinating multiple investigators working on a common theme. This must include performance milestones and a timetable for achieving project goals and deliverables. Adequate provision for substantive time commitment by the principal investigator, the research team and appropriate administrative support is an important factor contributing to the success of Implementation Grants. Previous experience indicates that strong external advisory boards are also a useful tool to assist in management of Implementation Grant awards. DOE EPSCoR strongly encourages their formation and regular use.

5. DOE EPSCoR reserves the right to give priority to applications that propose to develop new research areas rather than those that propose to enhance or continue research areas that have been previously funded under EPSCoR implementation grants. Other program policy and selection criteria are described in <u>subsection 2 of Section V B, REVIEW AND SELECTION PROCESS</u>.

Applications must identify the topical research area or areas with respect to the relevant DOE program office or offices (listed below) and the office's specific program goals. Please review the websites for information on the office's goals as well as reviewing the section on topics identified of special interest and disinterest below. The relevant program Office(s) and the associated scientific/technical point(s) of contact on the DOE (and not National Laboratory) staff must be identified on the first page of the application narrative. If the program office or the associated scientific/technical point(s) of contact are unknown, please contact the DOE EPSCoR office well in advance of the pre-application due date.

As a measure of relevance to DOE missions, DOE EPSCoR will ask the program office or offices to make a meaningful commitment to applications selected for award such as a financial contribution of up to 10% of the support for the proposed effort. While program offices or program office staff may not recommend commitment of funds prior to merit review, prospective applicants should make themselves aware of potential programmatic areas of interest prior to drafting an application. #### Areas of Specific Interest and Disinterest

While applications are welcome serving the research mission of the DOE offices listed above, a number of DOE programs provided additional guidance regarding of areas of specific interest or disinterest for their program or for subprograms within their overall program. Please note that lack of additional guidance in a topical area DOES NOT NECESSARILY MEAN a lack of interest. Many program managers instead wish to provide their respective communities the opportunity to propose broadly.

Pre-applications and applications that propose research in areas of disinterest will be deemed nonresponsive to the FOA and will be declined without review.

#### For Advanced Scientific Computing Research

In Applied Mathematics—Research and development of applied mathematical models, methods, and algorithms for understanding complex natural and engineered systems related to DOE's mission. Important areas of supported research include: (1) novel numerical methods for the scalable solution of large-scale, linear and nonlinear systems of equations, including those solution methods that take into consideration the possibilities brought about by future HPC architectures; (2) optimization techniques and next-generation solvers; and (3) numerical methods for modeling multiscale, multi-physics or multi-component continuous or discrete systems that span a wide range of time and length scales.

In Computer Science—Research that enables computing and networking at extreme scales and the understanding of extreme scale, or complex data from both simulations and experiments. It aims to make high performance scientific computers and networks highly productive and efficient to solve scientific challenges while attempting to reduce domain science application complexity as much as possible. The computer science program does this in the context of sharp increases in the heterogeneity and complexity of high performance computing systems; the need to seamlessly and intelligently integrate simulation, data analysis, and other tasks into coherent and usable workflows; and the challenges posed by highly novel computing platforms such as artificial intelligence, machine learning, neuromorphic and quantum systems.

#### **For Basic Energy Sciences**

#### For Biological and Environmental Research

#### In Biological Systems Sciences-

*for Genomic Science:* Areas of interest are: (1) Determine the molecular mechanisms, regulatory elements, and integrated networks needed to understand genome-scale functional properties of microbes, plants, and communities (including the study of natural microbiomes and model microbiomes in targeted field environments relevant to BER's bioenergy and environmental research efforts); (2) develop "-omics" experimental capabilities and enabling technologies needed to achieve a dynamic, system-level understanding of organism and community functions; and, (3) develop the knowledge base, computational infrastructure, and modeling capabilities to advance predictive understanding, manipulation and design of biological systems.

*For Biomolecular Characterization and Imaging Science:* Areas of interest are: Develop advanced characterization, measurement and imaging technologies to visualize the spatial and temporal relationships of key metabolic processes governing phenotypic expression in plants and microbes, information crucial for developing an understanding of the impact of various environmental and/or 5iosystems designs on whole cell or community function.

The current focus of the program is on fundamental plant biology leading to the development of dedicated bioenergy crops, development of new platform microorganisms with traits relevant to the breakdown of lignocellulosic biomass and/or production or fuels and products from lignocellulosic biomass, and understanding the biologically mediated controls on nutrient (C, N, P) cycling in environmental systems.

**Areas of specific disinterest are**: starch-derived fuels and products; natural gas-, petroleum-, or coal-derived biofuels and bioproducts; bioethanol, biohydrogen, and biogas production; pharmaceuticals; nutraceuticals; cosmetics; food products; municipal solid waste; microbial fuel cells; wastewater treatment; biomimetic hydrogen production; microbial bioremediation; and applications focused exclusively on eukaryotic algal systems.

#### **For Fusion Energy Sciences**

#### In Burning Plasma Science: Foundations-

*for Advanced Tokamak and Spherical Tokamak:* Areas of specific interest include: experimental research addressing critical issues that may affect the tokamak concept (e.g. plasma disruptions, impulsive heat loads, confinement and transport, and operational maintenance and complexity), or research on topics common to all fusion power plant concepts (e.g. interactions between plasma and material surfaces). Innovative applications of transformational approaches and technologies such as machine learning, advanced manufacturing, and engineered materials are also encouraged.

*for Theory and Simulation of Magnetically Confined Plasmas:* Areas of specific interest include: macroscopic stability including transient effects such as edge localized modes, plasma disruptions, and runaway electron physics; collisional and turbulent transport of particles, momentum, and energy; interaction of radiofrequency waves with plasma and surrounding structures; the physics of energetic particles; and boundary or edge physics,

including the edge pedestal.

#### In Burning Plasma Science: Long Pulse—

*for Long Pulse Tokamak:* Areas of specific interest include: research conducted by U.S. collaborative teams on long pulse superconducting international tokamaks as well as short pulse international tokamaks with unique capabilities. These teams build on the experience gained from U.S. fusion facilities to conduct research on these international machines to enable the exploration of scientific regimes that cannot be sustained for long duration on domestic facilities.

*for Long Pulse Stellarator:* Areas of specific interest include: understanding and (if possible) reducing the level of turbulent transport in stellarators, and improving the understanding of 3-D shaping in an integrated manner in plasmas with higher levels of performance. Also of interest is stellarator research aimed at resolving magnetic-confinement fusion plasma science issues that will be faced in the next generation of machines, including ITER, and addressing new and unique scientific regimes that can be achieved with long-pulse superconducting international stellarators.

*For Fusion Nuclear Science, Materials Research and Enabling R&D Programs for Fusion:* Areas of specific interest include: research aimed at resolving key hurdles in order to establish the scientific proof of principle for fusion energy from a materials science and engineering perspective. More specifically, proposals are encouraged for the development of plasma-facing materials and components; development of advanced structural and functional materials; development of breeder blanket concepts; development of tritium fuel cycle technologies; and development of superconducting magnet technologies.

In Discovery Plasma Science: Plasma Science Frontiers-

*for General Plasma Science:* Areas of specific interest include: (1) dynamical processes in laboratory plasmas, magnetospheric, solar, and astrophysical plasmas, such as magnetic reconnection, particle energization, plasma dynamo, turbulence and transport, energetic particles, flows, collisional and collisionless shocks; (2) understanding the behavior of dusty plasmas, non-neutral, single-component matter and/or anti-matter plasmas, and ultra-cold neutral plasmas; and (3) understanding plasma processes and/or plasma chemistry in low temperature plasma, interfacial plasma, plasma-surface interaction, interaction of plasma with materials and/or biomaterials, microplasmas, and the synthesis of nanomaterials.

Areas of specific disinterest are: low-energy nuclear reactions and "cold fusion" research.

*For High Energy Density Laboratory Plasmas (HEDLP)*: Areas of specific interest include: research focusing on the study of ionized matter at extremely high density and temperature, specifically when matter is heated and compressed to a point that the stored energy in the matter reaches approximately 100 billion Joules per cubic meter. More specifically, proposals are encouraged in the following areas: (1) high-energy-density hydrodynamics, (2) radiation-dominated dynamics and material properties, (3) magnetized HED plasmas, (4) nonlinear optics of plasmas and laser-plasma interactions,

(5) relativistic HED plasmas and intense beam physics, and (6) warm dense matter. Applications focusing on developing high energy density materials relevant to Quantum Information Science (QIS) are also encouraged.

**Areas of specific disinterest are:** low-energy nuclear reactions and "cold fusion" research.

*For Measurement Innovation:* Areas of specific interest include: research in diagnostic systems to achieve higher resolution or higher reliability, reduce complexity, and improve the ability to function in a burning plasma environment or provide access to previously unmeasured parameters. Proposals should seek to enable breakthroughs in scientific understanding, the linking of theory/computation with experiments, or active control of plasma properties to optimize device operation and plasma performance in a variety of device configurations.

#### **For High Energy Physics**

Areas of specific interest include research within the three experimental scientific frontiers: Energy, Intensity, and Cosmic Frontiers, as well as crosscutting efforts that enable new scientific opportunities by developing the necessary tools and methods for discovery. The program focuses on those opportunities identified by the <u>2014 Particle Physics Project Prioritization Panel (P5) long-range strategic plan</u>. These include experimental, theoretical and computational research into the physics explored with high energy and/or high intensity particle beams, studies of the nature of dark matter and dark energy, and research and development efforts in particle accelerator science and technology and in particle detector technology. Computing technology (including high performance and exascale approaches) and quantum information science (including simulation, sensors, and algorithms) that relate to and impact high-energy physics are also of interest.

**Areas of specific disinterest** are those that are not in alignment with the P5 report and HEP program priorities. These include heavy ion physics, neutrinoless double beta decay, the LHCb experiment, classical gravitational physics, classical astrophysics, and future gamma and cosmic ray experiments.

#### For Energy Efficiency and Renewable Energy In Advanced Manufacturing Technologies

<u>For Hybrid/Integrated Chemical Reaction-Separation</u> – background: Most chemical processes begin with a reaction and are followed by a separation of the product mixture into desired product, unreacted feedstock, and unwanted by-products. The unreacted feedstock and unwanted by-products are recycled back to the reactor. Since most industrial reactions have typically low conversions and selectivity's, the separation train is usually both energy and capital intensive. Similarly, the recycle loop is usually large, resulting in large electrical energy required to pump the liquids or compress the gases in order to move the fluids around.

Area of interest include: integrated reactor and separation technologies that improve both reactions and separations together, especially using non-thermal processes like reactive distillation, membrane reactors and ionic reaction media to result in simplified processes. Reactions and separations in the chemical industry are coupled and therefore problems associated with either one of them must be solved simultaneously. This would be the most effective way to deal with the coupled nature of process reaction and separation and provides the opportunity to break non-idealities like reaction equilibriums, isomers separation, and azeotropes.

<u>For Ionic Liquids for Improved Chemical Reactions and Separations</u> – background: Molecular design and synthesis of new ionic liquids (IIs) with different functionalities has expanded the scope of applications for ionic liquids. Ils are unique organic salts composed entirely of ions, typically large poor coordinating organic cations and small inorganic anions, resulting in highly polar molecules. The use of IIs has grown beyond their advantage over conventional organics solvents in the development of green technologies to other areas like reaction media and catalysis, separations (especially azeotropes), battery electrolytes, lubricants, and so on.

Areas of interest include: better understanding of molecular interactions between ionic liquids and other fluids in order to develop better separation methods to get pure and more stable IIs.

<u>For Materials for Sensors in Harsh Environments</u> – background: Sensor materials responding to changes in stress, temperature, composition, electromagnetic and gravitational fields are well characterized for many applications, but there are few sensor materials capable of withstanding harsh environments of high temperature, high stress, and corrosive environments. This is especially true for microelectronic and micromechanical sensors, which are typically silicon based.

Areas of Interest: Exploratory investigations in materials capable of converting or generating a measurable signal related to their environments are warranted, and especially so for environments regarded as too extreme for available sensor use. It would be useful for such sensors to be integrated into a wireless configuration. Example end uses include gas turbines, high temperature furnaces, and corrosive environments such as supercritical CO<sub>2</sub>.

#### ADDITIONAL (GENERAL) AREAS FOR CONSIDERATION

Some experimentation into electro processes and what is happening, for example, covetics, enhanced forming, plasma and microwave interaction within carbon fiber production, laser and e-beam and x-Ray and neutron interactions with materials such as used in additive manufacturing, etc.

#### In Fuel Cell Technologies-

An area of specific interest is the development of new physics-based multi-scale theoretical and computational models to accelerate the discovery and development of engineered materials and interfaces for key hydrogen and fuel cell applications. Specific subtopics of interest within the program are listed below.

For PGM-Free Catalysts for Fuel Cells-background: The development of high-

performance, durable PGM-free catalysts for polymer electrolyte membrane (PEM) and alkaline electrolyte membrane (AEM) fuel cells critically depends on modeling methodologies that provide a fundamental understanding of the reaction mechanism, such as helping elucidate the active site of these catalysts, improve the understanding of catalyst degradation, and are predictive in nature. Multi-scale modeling approaches to understand the catalyst in the context of the reaction environment, approaches to determine materials that can replace iron (Fe) as the main constituent in current state of the art PGM-free oxygen reduction reaction (ORR) catalysts, and approaches to quantify and describe catalyst durability, among others, are needed.

An area of specific interest is the development of high-throughput, predictive models to the accelerate discovery and development of PGM-free catalysts for fuel cells. Models relating to PEM ORR catalysts, as well as to PGM-free AEM ORR and hydrogen oxidation reaction (HOR) catalysts are of interest.

*For Hydrogen Storage Materials*—background: Multi-scale models to predict reactive solid interfaces are critical to the advancement of breakthrough materials systems for hydrogen storage. Nearly all advanced nucleation and growth models rely on an accurate description of the thermodynamics and kinetics of solid-solid interfaces. In complex light metal hydrides, these interfaces are particularly complicated, since they are multicomponent, incoherent, and involve molecular reactions.

An area of specific interest is the development a reliable theoretical formalism for integrating the necessary first principles-derived ingredients (chemical reaction, defect formation/migration, and solid-state diffusion kinetics) to give a good model for the structure/chemistry, energetics, and dynamics of reactive interfaces relevant to viable hydrogen storage materials.

*For Hydrogen Compatible Materials for Infrastructure*—background: A physics-based understanding of materials compatibility in hydrogen environments is critical for reliable performance of technologies in a broad range of sectors (e.g. structures in offshore environments, hydrogen tube trailers and storage vessels, welding of pipelines, etc.). Current macroscopic models of hydrogen induced damage rely heavily on empirical data and trends rather than a foundational, constitutive understanding of nano-and microstructural scale phenomena.

An area of specific interest is the derivation of predictive relationship of materials compatibility with hydrogen, based on an integrative approach leveraging advanced multi-scale/multi-physics computational theory in conjunction with state-of-the-art characterization techniques (such as in-situ neutron diffraction imaging). Areas of interest include: characterization and prediction of the behavior of short cracks that behave in a nonlinear fashion, use of oligocrystals to study interactions between hydrogen and grain boundaries, exploration of innovative techniques to characterize materials compatibility without the use of high-pressure hydrogen chambers (e.g. using inerting gases), and modeling of the behavior of polymers in hydrogen at an atomistic scale.

*For Hydrogen Production Materials*—background: Multi-scale/multi-physics approaches to model reactive solid-solid and solid-liquid interfaces are critical to the advancement of breakthrough materials systems for hydrogen production by water splitting. Effective models must address the thermodynamic and kinetic phenomena of multiple materials and interfaces, as well as electronic, ionic and mass transport effects over multiple time and length scales. In direct solar water splitting pathways, fundamental light-matter interactions also need to be accounted for.

Areas of specific disinterest across fuel cell technologies include models of hydrogen production materials systems (which is being addressed in the HydroGEN Consortium) and composite materials relevant to compressed hydrogen storage tanks.

Another area of specific interest is in discovery and development of scalable, and efficient approaches for liquefaction. Conventional liquefaction cycles (e.g. for natural gas, hydrogen, etc.) rely on mechanical cycles (e.g. compression, throttling) that are inherently inefficient. For example, liquefaction of hydrogen utilizes heat transfer fluid along with mechanical equipment to achieve a temperature of 20K, and consumes 10-15 kWh/kg. Alternative approaches with potential to achieve step-change improvements in liquefaction efficiency are of interest. Examples include: 1) the development and evaluation of acoustic liquefaction concepts; 2) the discovery, development, and evaluation of caloric materials (e.g. elastocaloric, electrocaloric, and magnetocaloric materials) for use in liquefaction; 3) the development of highly efficient, low-cost cryocoolers for use in hydrogen liquefaction; and 4) the discovery and development of catalysts for isomeric conversions of hydrogen (e.g. from para to ortho form).

#### In Solid State Lighting

Practical LED advancements have outpaced the fundamental semiconductor physics, materials science, semiconductor device understanding of the LED devices themselves. In order to accelerate understanding of the underlying LED science that can lead to future LED performance advancements, we propose the following R&D topics: 1) modeling of LED materials-device-synthesis relationships and expected performance, and 2) characterization of alternative LED materials. These topics are related and can have overlap depending on the capabilities of research institution.

Developing a predictive model for LED performance based on materials properties, device structures, and synthesis possibilities could guide R&D advancements in all three aspects of LED design – materials, device, and synthesis. Currently, there is only limited capability to predict LED performance for the most mature LED materials and predictive models for less mature LED materials routinely fall short, for example, predictions of ZnO LED, non-polar and semipolar GaN LED, dilute nitrides LED, etc. Historically, LED advancements have come from experimental progress; but given the vast array of materials combinations, there may be materials-device-synthesis combinations that are favorable for developing new LED technologies. This proposed topic could be categorized as an underpinning for 'materials by design', if a reliable, materials agnostic, predictive model could be developed. The second, related, topic would be to develop and apply a standard characterization approach for LEDs of all materials systems, so their performance and limitations can be readily compared. LED characterization information could feed into the LED modeling topic. LED characterizations could be based on experimental results that are performed first-hand by the research institution or based on literature based results. However, it would be important to understand the shortcoming of the various LEDs which are not always apparent in the published literature results. A broad effort to characterize the performance of wide array of LED materials could result in a 'library' of LED information that includes materials, devices, and synthesis techniques.

With the development of both of these R&D topics a feedback loop could be created that provides a process for prediction-synthesis-characterization of LEDs. Both of the described R&D topics require a large level of effort across a wide range of institutions but could also be a stepping stone for developing institutional expertise within the topic of LED materials and device science. Both of these topics would also support the objectives of the DOE SSL R&D Program. In order to reach the ultimate DOE SSL Program targets for LED lighting efficacy, breakthroughs will be necessary to achieve the required LED efficiency at green, amber, and red emission wavelengths. R&D results that can be used to further guide R&D approaches to achieve these breakthroughs will be highly valuable for enabling more effective use of R&D funds. The proposed R&D topics would also likely have crossover benefits for other optoelectronic device development, including lasers, photovoltaics, displays, and more.

#### In Solar Energy Technologies—

The <u>Solar Energy Technologies Office (SETO)</u> supports the development of solar technologies that decrease the cost of solar generated electricity to utilities and consumers. Areas of interest for the development of solar technologies have been outlined in previously released <u>FOAs</u>, however a brief list is included here to guide applicants:

*For photovoltaic systems:* Areas of interest include: stable, high performance photovoltaic absorber materials and cell architectures to enable module efficiencies above 25%; fundamental understanding of the degradation mechanisms for PV materials; durable, transparent polymer substrate and packaging materials; new materials and processes for metallization; development of new characterization techniques to enable understanding of high performance PV materials and devices; novel charge separation and solar energy harvesting materials and mechanisms for converting solar energy to electricity and/or fuels.

<u>for concentrating solar power technologies</u>: Areas of interest include: thermal energy storage materials and technologies for operation > 700 °C, including thermochemical endothermic/exothermic cycles, phase change materials, and the encapsulation of phase change materials; methods for low-loss broad-solar-spectrum optical concentration that do not require tracking; novel materials or concepts to enable low-cost transport of pressurized fluids at > 700 °C, including robust high-temperature thin film insulators; development of passive corrosion control mechanisms for molten chloride salts operating between 450 and 800 °C; novel materials or concepts to enable passive thermal transport or control in CSP systems.

*for systems integration:* Areas of interest include: interaction of solar PV power electronics and legacy control devices in electric power systems, inverter-dominated network control, scalable dynamic system modeling for power system operation, enhanced protection for solar PV and power systems, and grid services provided by distributed energy resources.

*for soft costs:* Areas of interest include: impacts of public policy on technological development speed and verified breakthroughs; behavioral dynamics and decision science with regards to adoption (personal or organizational) of new technologies; identification and analysis of non-economic drivers of technological adoption; analysis of novel business models and their influence on technological adoption; analysis of the adoption of new technologies and its drivers for low-income individuals or communities; methods to increase solar energy access for low-income individuals; analysis for the potential use of block chain for solar energy management and transactions.

Areas of specific disinterest across solar energy technologies include: DC-based distribution and transmission materials and designs; frameworks and testing services for interoperability; frameworks and testing services for cybersecurity; energy storage materials and system designs; business model and benefit/cost analysis of solar deployment options; and grid pricing models and transactive grid frameworks; analysis of behavioral dynamics or economics for topics unrelated to technological development or adoption; cryptocurrencies or coin offering related research.

# For Fossil Energy <u>Multi-functional Catalyst Research and Development –</u>

N.B. <u>Background information in support of this topic</u> is available at the linked file.

As outlined in the background section for this topic, the reduction of flaring through the direct conversion of methane is a multifaceted problem. High-productivity catalysts are needed that can mimic the conversion processes that are found in methanotrophic and other organisms, while possessing robust properties consistent with the challenging operating conditions and constraints found at remote production sites. Additionally separation materials (i.e., membranes, sorbents or solvents) are needed that can be integrated into a multi-functional reactor, which can simultaneously:

- Pretreat the associated gas feed to remove impurities, such as H<sub>2</sub>S, and condensable hydrocarbons, such as propane, butanes and C5+ compounds (as necessary)
- Directly convert methane alone, or in combination with ethane and/or CO<sub>2</sub>, into easily transported, value-added intermediates or finished products (to be identified and proposed by the applicant)
- Fractionation of the reaction raw products to recover the desired product(s) and recycle unconverted reactants

Proposals to this topic area should be directed toward:

1. Identifying pathways for synthesizing and separating products identified by the applicant based on specified feeds

- 2. Molecular design of high-productivity catalysts and materials that can mimic and improve upon conversion processes found in methanotrophic and other natural organisms
- 3. *In silico* screening of proposed catalyst and separation material(s) formulations for the pathways identified in (1), reflecting both stand-alone and integrated catalysis and separation systems
- 4. Bench-scale screening of most promising catalysts and materials identified in (2)

Others areas of particular interest for this topic area include:

- Co-conversion of ethane, CO<sub>2</sub> or both;
- Chemistries that employ CO<sub>2</sub> as a source of carbon, oxygen or both in the final product
- Chemistries that make use of excess hydrogen in methane to provide the energy requirements of the conversion reaction
- Production of economically-transportable products
- Initially target high-value, small volume product markets but can pivot toward commodity markets as the technology develops and matures
- Technology platforms capable of producing a variety of products using the same or similar catalysts
- Catalysts integrated with other materials and used for simultaneous conversion, feed gas purification, fractionation of products, and removal of unconverted reactants

## Areas considered outside the scope for this topic area include:

- Biological conversions based on gas fermentation
- Indirect conversion processes that involve gaseous intermediates, such as synthesis gas (CO+H<sub>2</sub>)
- Non-conversion uses for waste methane, such as oil reservoir pressure management
- Research focused on developing actual industrial reactor and separation equipment, and process design and integration
- Other critical aspects of mitigating flaring that are **not of interest** for the EPSCoR FOA are:
  - 1)*Multi-functional, Compact Equipment Development and Design* process intensification will need to be used to minimize processing steps and combine process unit operations into a minimum number of compact modules that can be easily transported and relocated in remote areas and
  - 2) Energy-efficient Process Development and Integration modular components of a conversion technology will need to be highly integrated, since process utilities must be minimized at remote sites. The system will also need to be operable under a wide range of varying operating conditions. Advanced process control systems incorporating real-time simulation will also need to be developed and tested to ensure the complete system can perform under realworld operating conditions.

However, applicants need to carefully consider these latter aspects in formulating their R&D approach to ensure that catalysts and materials developed through their research are holistically applicable to solving the flaring problem. Applicants are also

advised that successful catalysts and materials developed under this EPSCoR funded project may be of interest to DOE's Office of Fossil Energy in the future, should the Office pursue the development and demonstration of technologies addressing aspects one and two above.

#### Selenium Reclamation from Amine Solvents

N.B. <u>Background information in support of this topic</u> is available at the linked file.

Solvent reclamation can be an important component of advancing the future deployment of carbon capture technologies. This topic requests R&D to develop solvent reclamation techniques that can be used to reclaim selenium (with or without other metals) from amine solvents. It is anticipated that the Technology Readiness Level (TRL) of the proposed work will be TRL 3. Anticipated work scope includes laboratory-based R&D where selenium remediation/removal technologies are developed and tested on amine solvents contaminated with selenium and/or other metals. In addition to a final report, a techno- economic analysis (TEA) will be required that presents the cost for the solvent mitigation(s) proposed. The TEA can follow guidance provided by DOE's National Energy Technology Laboratory.

#### For Nuclear Energy

Advanced Reactor Materials

High-temperature, radiation damage and corrosion-resistant materials for use in molten salt systems. Materials that employ microstructure features to minimize neutron induced loss of creep ductility in nickel-based alloys are especially desirable. Materials that maintain desirable performance attributes at temperatures above 750 °C and can be readily formed and joined are especially desirable.

Functional materials for valves, filters, control elements and drive mechanisms, gaskets, impulse lines, bellows, and optical windows for molten salts.

#### Molten Salt Chemistry

An area of specific interest is molten salt chemistry, including (i) low-uncertainty molten salt thermochemical and thermophysical properties for advanced nuclear systems, (ii) practical techniques for implementing chemical control at MSRs, (iii) phase equilibria and diagram data for molten salt bearing actinides and fission products, and (iv) fuel-salt iodine removal techniques to minimize potential accident source term.

Instrumentation and techniques to rapidly and inexpensively assess the trace impurity levels of newly received salts.

Low-cost, large-scale chlorine isotope separation techniques.

High thermal neutron cross section lanthanide element separation techniques from fuel salt without prior actinide removal.

Techniques to process used fuel salts into stable waste forms.

#### Nuclear Data

Areas of interest include improving nuclear data for actinides and chlorine, including neutron cross section refinement and covariance data for advanced nuclear fuels and reactors.

#### Advanced Manufacturing

Techniques to apply high-quality, corrosion resistant layers/coatings (carbides, nitrides, phosphides, refractory or noble metals, etc.) to high-temperature structural alloys for molten salt reactors. Techniques suitable for long heat exchanger tubes and complex geometries are especially desirable. Suitability for deployment in a high neutron flux environment is also desired.

Tooling and techniques to support rapid replacement of used components to minimize outage intervals.

#### Instrumentation

Low uncertainty heat balance instruments and measurement techniques (mass flow and temperature difference) for utility scale molten salt coolant lines.

Rapid quantification instrumentation and techniques for residual fissile materials on used components and filters being removed from the reactor containment.

Plant instrumentation to assess the composition (corrosion products, actinide isotopes, tritium, oxygen) of small, periodically withdrawn, highly radioactive fuel salt samples.

Techniques and tooling to support remote replacement or recalibration of sensors within a high-radiation containment.

# Areas of specific disinterest across nuclear energy technologies include: Fissile material separation technologies.

# **Funding Limitations**

DOE EPSCoR funding will neither be awarded to DOE National Laboratories or other Federally Funded Research and Development Centers FFRDCs nor to non-EPSCoR jurisdictions either as the awardee or as a subawardee. Awardees may use EPSCoR funding to provide travel reimbursement for FFRDC and non-EPSCoR state collaborators for on-site experiments and collaborations. Applications requesting consultant costs will need to explain: how the overall consultant costs are in line with the EPSCoR mission and how the skills, expertise or capabilities provided by the consultant will be transferred in a sustainable manner to the applicant institution. No funds provided in any award, subaward or other relationship resulting from this Funding Opportunity Announcement may be used for purposes of construction, alteration, renovation, or the purchase of real property. Applications containing such requested costs will be rejected without further review or consideration.

After an initial project period of up to two years, renewal applications will be considered for up to two additional project periods of up to two years each. Renewal applications will subject to peer review. Consideration in the decision process for renewals will include but are not limited to: continuing meritorious performance and progress in the previous award period, continuing commitment to the effort on behalf of the awardee institution(s) and the jurisdiction, continuing program office need at DOE, DOE program office commitment to the effort, and the availability of funds. Requests for continuation funding and renewal funding will also be evaluated for adherence to the Office of Science <u>Public Access Plan</u> for publications and inclusion of <u>appropriate acknowledgements</u> in peer reviewed and technical publications.

## **Collaboration – Subawards**

If multiple EPSCoR institutions wish to collaborate on an application then they must choose one institution as the lead. The lead institution will submit the application with the other EPSCoR participants receiving support as subawardees. EPSCoR participants receiving funding as subawardees must be also located in acceptable EPSCoR jurisdictions listed in <u>Section III A</u>. Formal collaborative pre-applications or applications, in which each proposing institution partnering on the research submits an application separately to DOE, will be deemed non-responsive to the FOA. Again, no funding on under these awards may be sub awarded to FFRDCs.

## **Principal Investigator and Project Director Roles:**

For this EPSCoR FOA, each application will have a single principal investigator (PI) with other scientific/technical participants having a role of "Co-Investigator" (Co-I). It is recommended that the PI be the lead technical director for the application and have affiliation with the lead institution or organization. If it is advantageous to the management of the research, s/he should work under a specified Project Director (PD) who may help coordinate research efforts

particularly if it involves multiple organizations or institutions. The PD and PI must provide signed statements that reflects their commitment to the project, including the level of time commitment. These letters of commitment are limited to one page each.

# Principal Investigators Meetings, Program Meetings, Reviews

While the EPSCoR program does not have annual meetings, PIs should budget for and plan on attending DOE program meetings relevant to the proposed research. Such meetings may occur on an annual or biennial basis. DOE EPSCoR may conduct on-site or reverse-site visit reviews. It is advisable to build in flexibility to accommodate for these possibilities as well.

# **Open Science**

SC is dedicated to promoting the values of openness in Federally-supported scientific research, including, but not limited to, ensuring that research may be reproduced and that the results of Federally-supported research are made available to other researchers. These objectives may be met through any number of mechanisms including, but not limited to, data access plans, data sharing agreements, the use of archives and repositories, and the use of various licensing schemes.

The use of the phrase "open-source" does not refer to any particular licensing arrangement, but is to be understood as encompassing any arrangement that furthers the objective of openness.

All entities submitting applications to this FOA must recognize the moral and legal obligations to comply with export controls and policies that limit the transfer of technologies with potential dual use. Applicants are reminded that international collaboration must comply with nonproliferation, sanction, and other protocols described at <u>https://www.export.gov</u> and <u>https://www.state.gov/strategictrade/overview/</u>

International activities related to special nuclear materials (SNM) are subject to additional requirements. Please see 10 CFR 810 for further information.

This FOA is to support scientific endeavors that could be described in scholarly publications. Do not submit applications containing restricted data or unclassified nuclear information as defined in the Atomic Energy Act of 1954, as amended, 42 USC 2011 et seq., 10 CFR 1017, 10 CFR 1045.

# Section II – AWARD INFORMATION

# A. TYPE OF AWARD INSTRUMENT

DOE anticipates awarding grants under this FOA.

# **B. ESTIMATED FUNDING**

Research grant awards, fully funded in FY 2019, are expected to be made for a period of up to two years at a funding level appropriate for the proposed scope. Release of continuation funding (funding for the second budget period) will be contingent on: (1) continued availability of funds appropriated by Congress; (2) progress towards meeting the objectives of the approved application; (3) submission of required reports; and (4) compliance with the terms and conditions of the award.

Total funding up to \$20,000,000 is expected to be available to support this FOA, subject to appropriation of funds by the Congress, with the potential for up to 10 awards. DOE is under no obligation to pay for any costs associated with the preparation or submission of an application. DOE reserves the right to fund, in whole or in part, any, all, or none of the applications submitted in response to this FOA.

# C. MAXIMUM AND MINIMUM AWARD SIZE

The award size will depend on the number of meritorious applications and the availability of appropriated funds.

## Ceiling

\$1,500,000 per year

## Floor

\$1,000,000 per year

# **D. EXPECTED NUMBER OF AWARDS**

DOE expects up to 10 awards under this FOA. The exact number of awards will depend on the number of meritorious applications and the availability of appropriated funds.

# E. ANTICIPATED AWARD SIZE

Applicants are encouraged to propose research expenditures that correspond to the funding needed for their proposed research program. DOE expects the typical award size will be 2,000,000 to 3,000,000 for two years.

# F. PERIOD OF PERFORMANCE

DOE anticipates making awards with a project period of two years.

# G. TYPE OF APPLICATION

DOE will accept new applications under this FOA.

# H. SUBSEQUENT RENEWAL APPLICATIONS

Successful awardees may apply for up to two renewals periods of up to two years each for a total support period of six years. It is anticipated that successful renewal awards will be up to \$2,500,000 per year.

## I. RESPONSIBILITY

The successful prime applicant/awardee (lead organization) will be the responsible authority regarding the settlement and satisfaction of all contractual and administrative issues, including but not limited to, disputes and claims arising out of any agreement between the applicant and any team member, and/or subawardee.

# Section III – ELIGIBILITY INFORMATION

# A. ELIGIBLE APPLICANTS

All types of applicants meeting the jurisdictional limitations described below are eligible to apply except: DOE National Laboratories, other Federally Funded Research and Development Center (FFRDC) Contractors, and nonprofit organizations described in section 501(c)(4) of the Internal Revenue Code of 1986 that engaged in lobbying activities after December 31, 1995.

Since DOE EPSCoR follows <u>NSF EPSCoR RII Program eligibility determinations</u>, applicants within the following jurisdictions will be eligible for this FOA: Alabama, Alaska, Arkansas, Delaware, Guam, Hawaii, Idaho, Kansas, Kentucky, Louisiana, Maine, Mississippi, Montana, Nebraska, Nevada, New Hampshire, North Dakota, Oklahoma, Puerto Rico, Rhode Island, South Carolina, South Dakota, Vermont, Virgin Islands, West Virginia, and Wyoming.

All research supported by an EPSCoR award must be performed in an EPSCoR jurisdiction or at a DOE national laboratory. Funding support for the prime applicant and any potential subawardees or consortia members is limited to those with addresses within one or more EPSCoR jurisdictions. Funding of foreign entities is not permitted for this FOA.

Domestic industrial applicants must include a letter from a responsible member of institutional management committing that the location of the research as well as the staff participating for this application will be within one of the eligible jurisdictions.

To be considered eligible for an award under this FOA, potential lead organizations are *required* to submit a pre-application in accordance with the instructions provided in <u>Section IV.B.2</u>, and to receive notification from DOE that they are allowed to submit a full proposal. Applications received from an applicant who has not submitted the required pre-application, or who has received notification from DOE that they are disallowed from submitting a full application, will be deemed non-responsive and will be rejected without further review.

Also as noted in Section I E in the <u>subsection on collaboration – subawards</u>, if multiple institutions are involved, there will be one organization leading. Other participating organization(s) may be included as lower-tier participant(s) or sub-awardee(s) who will be responsible for a smaller portion of the overall project. If an application is approved for funding, DOE will provide the total DOE project funds to the lead organization that will then provide funding to the other participant(s) via a subcontract/subaward arrangement. The application must clearly describe the role to be played by each organization, specify the managerial arrangements and explain the advantages of the multi-organizational effort.

For applications containing subcontracts/subawards, upon request, the applicant must provide the DOE contracting officer (CO) with a collaboration agreement, commonly referred to as the articles of collaboration, which sets out the rights and responsibilities of each participant of the research consortium. This agreement binds the individual consortium members together and must discuss, among other things, the consortiums:

• Management structure;

- Method of making payments to consortium members;
- Means of ensuring and overseeing members' efforts on the project;
- Provisions for members' cost sharing contributions; and
- Provisions for ownership and rights in intellectual property developed previously or under the agreement.

Applications from for-profit organizations that propose research related to current commercial activity may be declined without merit review.

Domestic industrial or non-profit applicants or subcontractees/subawardees must include a letter from the responsible member of management committing that the location of the research as well as the staff participating for this application will be within one of the eligible jurisdictions. A foreign entity may not serve at the lead in an application but may receive funding as a subawardee or subcontractor (team member) after committing that the location of the research and the staff participating will be within an eligible State or territory of the United States.

Applicants with mailing addresses, corporate offices, or headquarters in non-EPSCoR jurisdictions must ensure that their applications describe how all work will be performed in either EPSCoR jurisdictions or DOE National Laboratories.

# **B. COST SHARING**

Cost sharing is not required. Letters of jurisdictional, institutional or private sector commitment towards the research effort are required. Please refer to <u>Section IV C., Appendix 7</u>.

# C. ELIGIBLE INDIVIDUALS

Individuals with the skills, knowledge, and the resources necessary to carry out the proposed research as a Principal Investigator (PI) are invited to work with their organizations to develop an application for assistance. Individuals from underrepresented groups as well as individuals with disabilities are always encouraged to apply for assistance.

- j. DOE Program Office Scientific/Technical Contact(s) (this is in addition to the DOE EPSCoR program manager and may not be a DOE National Laboratory staff member other than Fossil Energy Program Managers from the National Energy Technology Laboratory); and,
- k. the topical research area(s) (discussed in Section I of this FOA)
- 2) A narrative of up to four pages (excluding the cover page). The narrative must present the scientific and technical objectives and the research plan. The narrative must reference the jurisdiction's strategy to develop and utilize the scientific and technical resources (this is the jurisdiction's science and technology plan referred to in NSF EPSCoR literature) and place the research in context of that jurisdiction's strategy. The pre-application may not exceed four pages, with a minimum text font size of 11 point and margins no smaller than one inch on all sides. Figures and references, if included, must fit within the four-page limit. Pre-applications that exceed the four-page limit for the technical narrative may be discouraged without additional review.
- 3) The pre-application must also include a list of the names and institutional affiliations of all participating investigators, including collaborators and consultants on the proposed project. This information is not included in the four-page limit. For each funded investigator, provide a list of collaborative co-investigators including co-authors of the past 48 months, co-editors of the past 24 months, graduate and postdoctoral advisors/advisees, and close associations. This list of participants and collaborators will not count toward the page limit for the pre-application. This information must be submitted in the tables, whose format is shown below. If these tables are not included, the pre-application will be discouraged without additional review.

\* For the PI and Co-Is, Table 2 must include co-authors over the past 48 months, graduate and postdoctoral advisors, graduate students and postdoctoral associates that have been supervised during the past 60 months, and any other current close associations. Table 2 must exclude all personnel at any of the institutions listed in Table 1.

\*\* Applicants are strongly encouraged to follow the exact format of the sample table since the tabular information will be compiled across all applications. This includes the following elements:

- Include grid lines around each cell.
- Do not merge name or institution cells, even if individuals share the same institution.
- Do not change the order of the columns.
- Do not include any additional information (e.g. "PI", "Co-PI", or footnote symbols) under "Last Name" and "First Name".
- Do not include departmental affiliations under Institutions.
- If an individual has a joint appointment, separate the institutions with a "/" (i.e. "Univ of X / National Lab Y").

## PRE-APPLICATION REVIEW

All pre-applications will be reviewed to determine their responsiveness to the objectives of the FOA.

Pre-applications that fail to comply with administrative requirements will be discouraged without further review. Pay particular attention to:

- Observing the four-page limit for the narrative
- Including the required tables of collaborators

In addition, federal Program Managers will evaluate the pre-applications to determine their competitiveness, based on the following criteria:

- 1. Responsiveness to the objectives of the FOA.
- 2. Scientific and technical merit.
- 3. Appropriateness of the proposed research approaches.
- 4. Likelihood of scientific impact.

5. Fit within the jurisdiction's strategy to develop and utilize the scientific and technical resources

6. Ensuring a diverse pool of applicants.

Pre-application comparative reviews will compare pre-applications within a topical field with priority given to scientifically innovative and forward-looking early stage research with the highest likelihood of success as a full application. These reviews will be conducted by no less than three federal program managers chosen for their topical knowledge and diversity of perspective. The results of the review will be documented.

Applicants with the highest rated pre-applications will be encouraged to submit applications; others will not be permitted to submit applications. Upon request, feedback from the comparative review will be provided after the deadline for the receipt of applications.

DOE is committed to ensuring that a sufficient number of applicants will be encouraged to submit applications to foster a competitive merit review of full applications. The intent in discouraging submission of certain pre-applications is to benefit applicants who would not prepare and submit applications with a negligible likelihood of success.

The PI will be automatically notified when the pre-application is encouraged or discouraged. The DOE SC Portfolio Analysis and Management System (PAMS) will send an email to the PI from PAMS.Autoreply@science.doe.gov, and the status of the pre-application will be updated at the PAMS website https://pamspublic.science.energy.gov/. Notifications are sent as soon as the decisions to encourage or discourage are finalized.

## PRE-APPLICATION SUBMISSION

It is important that the pre-application be a single file with extension .pdf, .docx, or .doc. The filename must not exceed 50 characters. The pre-application must be submitted electronically through the DOE SC Portfolio Analysis and Management System (PAMS) website <u>https://pamspublic.science.energy.gov/</u>. The PI and anyone submitting on behalf of the PI must register for an account in PAMS before it will be possible to submit a pre-application. All PIs and those submitting pre-applications on behalf of PIs are encouraged to establish PAMS accounts as soon as possible to avoid submission delays.

You may use the Internet Explorer, Firefox, Google Chrome, or Safari browsers to access PAMS.

# Submit Your Pre-Application:

You can enter an optional personal message to the PI in the "Comments" box, and it will be included in the email sent by PAMS to the PI. You must wait until the PI registers before you can submit the preproposal. Save the preproposal for later work by clicking the "Save" button at the bottom of the screen. It will be stored in "My Preproposals" for later editing.
- Enter a title for your preproposal.
- Select the appropriate technical contact from the Program Manager dropdown.
- To upload the preproposal file into PAMS, click the "Attach File" button at the far right side of the screen. Click the "Browse" (or "Choose File" depending on your browser) button to search for your file. You may enter an optional description of the file you are attaching. Click the "Upload" button to upload the file.
- At the bottom of the screen, click the "Submit to DOE" button to save and submit the preproposal to DOE.
- Upon submission, the PI will receive an email from the PAMS system <<u>PAMS.Autoreply@science.doe.gov</u>> acknowledging receipt of the preproposal.

You are encouraged to register for an account in PAMS at least a week in advance of the preproposal submission deadline so that there will be no delays with your submission.

**WARNING**: The PAMS website at <u>https://pampspublic.science.energy.gov</u> will permit you to edit a previously submitted pre-application in the time between your submission and the deadline. If you choose to edit, doing so will remove your previously submitted version from consideration. If you are still editing at the time of the deadline, you will not have a valid submission. Applicants should read the registration instructions carefully and prepare the information requested before beginning the registration process. Reviewing and assembling the required information before beginning the registration process will alleviate last-minute searches for required information.

Organizations must have a Data Universal Numbering System (DUNS) Number, active System for Award Management (SAM) registration, and Grants.gov account to apply for grants. The EBiz POC **must** authorize people who are able to make legally binding commitments on behalf of the organization as a user with the AOR role; **this step is often missed and it is crucial for valid and timely submissions.** 

3. How to Submit an Application to SC via Grants.gov

Grants.gov applicants can apply online using Workspace. Workspace is a shared, online environment where members of a grant team may simultaneously access and edit different webforms within an application. For each FOA, you can create individual instances of a workspace.

To trigger this feature, an applicant must complete the SF-424 information first. Once it is completed, the information will transfer to the other forms.

3) Submit a Workspace: An application may be submitted through workspace by clicking the Sign and Submit button on the Manage Workspace page, under the Forms tab. Grants.gov recommends submitting your application package at least 24-48 hours prior to the close date to provide you with time to correct any potential technical issues that may disrupt the application submission.

4) Track a Workspace: After successfully submitting a workspace package, a Grants.gov Tracking Number (GRANTXXXXXXX) is automatically assigned to the package. The number will be listed on the Confirmation page that is generated after submission.

Proof of timely submission is automatically recorded by Grants.gov. An electronic date/time stamp is generated within the system when the application is successfully received by

Grants.gov. The applicant AOR will receive an acknowledgement of receipt and a tracking number (GRANTXXXXXX) from Grants.gov with the successful transmission of their application. Applicant AORs will also receive the official date/time stamp and Grants.gov Tracking number in an email serving as proof of their timely submission.

When SC successfully retrieves the application from Grants.gov, and acknowledges the download of submissions, Grants.gov will provide an electronic acknowledgment of receipt of the application to the email address of the applicant with the AOR role. Again, proof of timely submission shall be the official date and time that Grants.gov receives your application. Applications received by Grants.gov after the established due date for the program will be considered late and will not be considered for funding by SC.

Applicants using slow internet, such as dial-up connections, should be aware that transmission can take some time before Grants.gov receives your application. Again, Grants.gov will provide either an error or a successfully received transmission in the form of an email sent to the applicant with the AOR role. The Grants.gov Support Center reports that some applicants end the transmission because they think that nothing is occurring during the transmission process. Please be patient and give the system time to process the application.

Files that are attached to the forms must be PDF files unless otherwise specified in this FOA. Attached PDF files must be plain files consisting of text, numbers, and images without editable fields, signatures, passwords, redactions, or other advanced features available in some PDFcompatible software. Do not use PDF portfolios or binders.

Please note the following restrictions that apply to the names of all files attached to your application:

- Please limit file names to 50 or fewer characters
- Do not attach any documents with the same name. All attachments must have a unique name.

• Please use only the following characters when naming your attachments: A-Z, a-z, 0-9, underscore, hyphen, space, period, parenthesis, curly braces, square brackets, ampersand, tilde, exclamation point, comma, semi colon, apostrophe, at sign, number sign, dollar sign, percent sign, plus sign, and equal sign. Attachments that do not follow this rule may cause the entire application to be rejected or cause issues during processing.

#### LETTERS

Letters of support or commitment must be included for all collaborations and consultants described or listed in the application as contributing to the research effort. These letters must not exceed a single page in length.

**RENEWAL APPLICATIONS** 

Renewal applications may not be submitted for this FOA.

New awardees from this FOA may be able to submit up to two renewal applications in future EPSCoR Implementation Grant FOAs under this topic.

#### **RESUBMISSION OF APPLICATIONS**

Applications submitted under this FOA may be withdrawn from consideration by using the PAMS website at <u>https://pamspublic.science.energy.gov</u>. Applications may be withdrawn at any time between when the applicant submits the application and when DOE makes the application available to merit reviewers. Such withdrawals take effect immediately and cannot be reversed. Please exercise due caution.

After an application is withdrawn, it may be resubmitted, if this FOA is still open for the submission of applications. Such resubmissions will only count as one submission if this FOA restricts the number of applications from an applicant.

#### A. CRITERIA

#### **1. Initial Review Criteria**

Prior to a comprehensive merit evaluation, DOE will perform an initial review in accordance with 10 CFR 605.10(b) to determine that (1) the applicant is eligible for the award; (2) the information required by the FOA has been submitted; (3) all mandatory requirements are satisfied including having an approved pre-application and attachment with the required table listing collaborators, a biosketch, current and pending, data management plan, and letters of commitment; (4) the proposed project is responsive to the objectives of the funding opportunity announcement (including limitations on technical topics described in the Supplementary Information), and (5) the proposed project is not duplicative of ongoing or completed programmatic work. Applications that fail to pass the initial review will not be forwarded for merit review and will be eliminated from further consideration.

#### 2. Merit Review Criteria

Applications will be subjected to scientific merit review (peer review) and will be evaluated against the following criteria, listed in descending order of importance as found in 10 CFR 605.10 (d), the Office of Science Financial Assistance Program Rule.

- Scientific and/or Technical Merit of the Project;
- Appropriateness of the Proposed Method or Approach;
- Competency of Applicant's Personnel and Adequacy of Proposed Resources; and
- Reasonableness and Appropriateness of the Proposed Budget.

In addition to the criteria established by regulation, merit reviewers will be asked to evaluate each application by the following criteria:

- Synergism among the PIs in a program and the programmatic focus of a multi-PI effort; and,
- The likelihood of success of the implementation grant.

Note that external peer reviewers are selected with regard to both their scientific expertise and the absence of conflict-of-interest issues. Both Federal and non-Federal reviewers may be used, and submission of an application constitutes agreement that this is acceptable to the investigator(s) and the submitting institution.

Site visits or reverse site visits may be used as part of the evaluation process and in the review of performance from the inception of an award through its completion.

The questions below are provided to the merit reviewers to elaborate the criteria:

SCIENTIFIC AND/OR TECHNICAL MERIT OF THE PROPOSED RESEARCH

- What is the scientific innovation of proposed research?
- What is the likelihood of achieving valuable results?

- How might the results of the proposed work impact the direction, progress, and thinking in relevant scientific fields of research?
- How does the proposed work compare with other efforts in its field, both in terms of scientific and/or technical merit and originality?
- Is the Data Management Plan suitable for the proposed research and to what extent does it support the validation of research results?

APPROPRIATENESS OF THE PROPOSED METHOD OR APPROACH

- How logical and feasible are the research approaches?
- How the proposed research employ innovative concepts or methods?
- Are the conceptual framework, methods, and analyses well justified, adequately developed, and likely to lead to scientifically valid conclusions?
- How does the applicant recognize significant potential problems and consider alternative strategies?

COMPETENCY OF APPLICANT'S PERSONNEL AND ADEQUACY OF PROPOSED RESOURCES

- What is the past performance and potential of the Principal Investigator (PI)?
- How well qualified is the research team to carry out the proposed research?
- Are the research environment and facilities adequate for performing the research?
- How does the proposed work take advantage of unique facilities and capabilities?

REASONABLENESS AND APPROPRIATENESS OF THE PROPOSED BUDGET

- Are the proposed budget and staffing levels adequate to carry out the proposed research?
- Is the budget reasonable and appropriate for the scope?
- If consultant costs are included, are the overall consultant costs are in line with the EPSCoR mission and how will the skills, expertise or capabilities provided by the consultant will be transferred in a sustainable manner to the applicant institution?

SYNERGISM AMONG THE PIS IN A PROGRAM AND THE PROGRAMMATIC FOCUS OF A MULTI-PI EFFORT

- How does the application exhibit a coherent focus on one energy-related research area bringing together multiple researchers?
- What aspects of the management plan will support coordination of multiple investigators working on a common theme including performance milestones and a timetable for achieving project goals and deliverables?

The Likelihood of Success of the Implementation Grant

- How well does the application couple with the jurisdiction's strategy to develop and utilize the scientific and technological resources that reside in its research universities and the jurisdiction's industrial or economic resources?
- How does the application adequately present the opportunities for enhanced academic research and development competitiveness and if appropriate, industrial or economic competitiveness, for the jurisdiction, including plans for the acquisition of sustained non-EPSCoR support?
- What plans does the applicant have to make (or has the applicant made) competitive

faculty hires and retained outstanding faculty within the scope of the implementation award? Does the applicant have a plan to attract (or has the applicant hired) outstanding graduate students and post docs?

- What plans do the applicant have to develop (or have they developed) as part of the implementation grant unique infrastructure capabilities that are critical to the advancement of science or technology? Alternatively, are they planning to or making unique contributions to DOE oriented capabilities (e.g., building or developing unique capabilities for a DOE experiment or facility)?
- What plans do the applicant have to (or are the grantees on track to) achieve a sustainable leadership position in their discipline(s)?
- What plans do the applicant have to (or are the grantees effectively) leveraging DOE funding and capabilities with local and regional resources? Are there commitments from the applicant's jurisdiction, institution or from private sources to assist in this leveraging?

- Relevance of the proposed activity to SC or Technology Office priorities
- Ensuring an appropriate balance of activities within SC or Technology Office programs
- Performance under current or previous awards by the PD, PI, or co-PIs
- Institutional and jurisdictional capacity to manage challenging projects as evidenced, where applicable, by prior performance under EPSCoR or other awards.
- Institutional, jurisdictional and other commitment
- Presence of tenure-track or tenure-equivalent investigators
- Providing career pathways for the next generation of researchers
- Training the next generation of researchers, i.e. graduate students
- Maximizing the use of DOE user facilities
- Ensuring opportunities to investigators not currently supported by DOE
- Quality of domestic or international collaboration
- Participation with multi-institutional teams
- For applicant institutions that are not institutions of higher education: the presence of joint appointments with academic institutions, the presence of graduate students receiving academic credit for their research participation, the existence of tenure-like appointments,

and the commitment to research of a basic and fundamental nature divorced from current commercial activity and business applications.

• Commitment to sharing the results of research

#### 3. Selection

The Selection Official will consider the findings of the merit review and may consider any of the Program Policy Factors described above.

#### 4. Review of Risk

Pursuant to 2 CFR 200.205, DOE will conduct an additional review of the risk posed by applications submitted under this FOA. Such review of risk will include:

- Technical merit of the application,
- Reports and findings from audits performed under 2 CFR 200 or OMB Circular A-133, and
- Systems maintained under 2 CFR 180.

DOE may make use of other publicly available information and the history of an applicant's performance under DOE or other Federal agency awards.

Applicants with no prior performance of DOE awards may be asked to provide information about their financial stability and or their ability to comply with the management standards of 2 CFR 200.
