SUMMARY

The DOE SC program in Fusion Energy Sciences (FES) hereby announces its interest in receiving single investigator or small multi-investigator research proposals to carry out research in the Fusion Materials, Fusion Nuclear Science, and Enabling R&D areas. The purpose of this FOA is to reorient the laboratory based foundational and basic science research programs in these areas to better align and support the new FES program vision. Research should address critical scientific gaps and align with the FES vision and future Science and Technology Roadmap. Outcomes will inform the future U.S. Fusion Science and Technology roadmap, and other parts of our program was we expand, define, and develop the fusion and plasma science ecosystem for energy.

Researchers at institutions that are not DOE/NNSA national laboratories are invited to work with their institutions to submit applications in this subject area to the FY 2024 Continuation of Solicitation for the Office of Science Financial Assistance Program, DE-FOA-0003177, in Grants.gov. Applicants doing so should adhere to the technical topical descriptions in this Program Announcement while ensuring that their applications follow all requirements in the Funding Opportunity Announcement (FOA) DE-FOA-0003177.

Program Mission

The mission of the FES program is to expand the fundamental understanding of matter at very high temperatures and densities and to build the scientific foundations needed to develop a fusion energy source. This is accomplished by the study of the plasma state and its interactions with its surroundings. The Energy Act of 2020 (42 U.S.C. § 18645) augmented the scientific mission of FES with "supporting the development of a competitive fusion power industry in the U.S."

FES has since reoriented its program priorities to the following:

1. Accelerate fusion development as a carbon-free energy source via public-private partnerships ("bold decadal vision")

- 2. Support R&D to establish FS&T basis of a Fusion Pilot Plant (FPP)
- 3. U.S. participation in ITER to leverage engineering and study burning plasma science technology at power plant scale while expanding Inertial Fusion Energy (IFE) program.
- 4. Support discovery plasma science and technology.
- 5. Broaden participation in fusion and DEIA activities to enable the program.

Building off the program priorities, the key elements of FES's vision are:

- Workforce Development and Sustainment: Ensuring we establish sustainable and resilient pathways for diverse and exceptional talent;
- Bridging Gaps: Creating innovation engines with national laboratories, universities, and industry to resolve R&D gaps and support domestic supply chains for fusion energy; and
- Transformational Science: Nurturing plasma science and technology discovery translating to innovation impact.

To achieve its mission, FES invests in flexible U.S. experimental facilities of various scales, international partnerships leveraging U.S. expertise, large-scale numerical simulations based on experimentally validated theoretical models, development of advanced fusion-relevant materials, future blanket concepts and tritium fuel cycle, and innovation in measurement techniques. Additionally, FES supports partnerships with the private fusion sector to enable viable Fusion Pilot Plant designs.

FES research is guided by the Long-Range Plan "Powering the Future: Fusion and Plasmas" developed by the Fusion Energy Sciences Advisory Committee (FESAC): https://science.osti.gov/-/media/fes/fesac/pdf/2020/202012/FESAC Report 2020 Powering the Future.pdf

This report included recommendations to support and expand R&D for fusion materials and technologies including expanding the blanket and tritium R&D program. More broadly, the program specific recommendations make mention of the need to expand into the areas listed in the "Topical Areas" section below. In addition to this report and building off the recommendations in the LRP, four different research communities hosted community-organized workshops to better define gaps, challenges, and research objectives of their research community. This includes neutronics, magnet research, fuel cycle, blanket, and materials. Some final reports are available, and links are listed below. Applicants are encouraged to reach out to the lead organizers for more information and to become familiar with the activities, workshop pre-read materials, and historical documents that were the foundation to these workshops.

Descriptions of Topical Areas

Please note, some of these research topics are considered cross-cutting and R&D can be supported by more than one of the topics below. If this is the case, please indicate if the topic is cross-cutting. It is strongly encouraged that any basic science research proposed must (1) identify how the research aligns with the FS&T drivers identified in the LRP; (2) demonstrate a comprehensive understanding of the research's potential end-use and the associated complexities with whole-system integration and interdependencies that would help inform end-use for viable fusion energy; (3) demonstrate how the research would create bridges to other parts of the FES research program (e.g., Advanced Tokamak, IFE, INFUSE, Milestone) to encourage information sharing, collaborations, and active participation in the vibrant fusion energy ecosystem and reduce barriers, siloing and duplicative efforts.

1. Enabling Research and Development:

The realization of fusion energy and the advancement of plasma science requires advances in supporting technologies to achieve higher levels of performance and flexibility to explore new plasma regimes. The purpose of the Enabling Research and Development (R&D) program element is to develop these supporting technologies for deployment on existing and next generation fusion research facilities. Proposals to this area must focus on experimental research and/or model validation pertaining to supporting technologies and how it enables plasma initiation, control and flexibility, confinement, performance, and/or operation.

2. Fusion Materials:

The selection of materials for future fusion device design is foundational. Every component, from the innermost chamber walls to the outer framework, demands a diverse array of materials that can endure a spectrum of conditions encompassing heat, particle exposure, and neutron fluxes. This endeavor involves advancing materials, developing physical and numerical models, and other essential tools for realizing the next generation fusion material technologies.

Leveraging the FESAC Long-Range Plan and recent community workshops, listed above, underscores the urgent necessity for a fusion prototypic neutron source which can replicate fusion conditions. This capability serves as the fundamental basis for the materials constituting a fusion device. Alongside the neutron environment, there exist other interconnected materials challenges that broaden the spectrum of considerations for a fusion device. This subprogram supports research in the areas listed below.

- Plasma Material Interactions and Plasma Facing Components (PFC): The innermost wall of a fusion device, known as the plasma-facing components (PFCs), is exposed to the high-energy plasma. Plasma-material interactions can cause erosion, sputtering, and material migration. Research in this area aims to develop materials that can withstand extreme heat, particle fluxes, and erosion caused by plasma interactions.
- Structural Materials for Fusion: Structural materials refer to those materials used in the overall construction of the fusion device, such as the vacuum vessel, blanket structure, and other supporting components. These materials must be able to withstand the structural loads, radiation, and heat while maintaining their desired material properties. Advanced structural steels, advanced alloys, and engineered composites are areas of interest for research.
- Fundamental Modeling and Materials Behavior: Advances in materials modeling play a crucial role in predicting how materials will behave under fusion system conditions. Computational tools allow researchers to simulate material responses to high temperatures, radiation, and stress, aiding in material selection and design optimization.
- Functional Materials: These are materials that impact the functionality of various fusion components beyond their structural integrity. For instance, materials used for sensors and heat transfer enhancement fall under this category.
- Advanced and Additive Manufacturing: Novel manufacturing techniques, including additive manufacturing, offer the potential to create components with enhanced material characteristics and complex geometries that might be challenging to achieve through traditional manufacturing methods. This area includes researching near-net-shape additive manufacturing and exploring ways to improve component performance and cost compared to conventional manufacturing techniques.

3. Fusion Nuclear Science:

Interlinked with burning plasma and materials that can withstand fusion system conditions are all the key systems required to capture the power, breed fuel, and ensure the safe operation of a fusion plant. Building off the FESAC Long-Range Plan, the fusion technology community organized a series of workshops which outlined in more detail key challenges and research objectives, which can be found below. This program area supports research in the following areas:

- Blanket: Breeding tritium within the fusion plant is crucial for achieving a self-sustaining fusion reaction. Areas of interest are tritium control, functional materials, and blanket enabling technologies.
- Fuel Cycle: Extraction and exhaust processing is crucial for maintaining the self-sustaining fusion reaction. Areas of interest are fueling and exhaust processing, isotope processing, rebalancing and storage, and confinement processing and tritium accountancy.

- Advanced first wall and divertor engineering components: Liquid metal plasma facing components included in the first wall and/or the divertor.
- Remote Handling: Fusion involves hazardous environments, so remote handling systems are required for maintenance, repairs, and component replacement.
- Safety Analysis: Safety assessments, helping to understand how the fusion plant behaves under various operational and accident scenarios.
- Fusion Nuclear Analysis: Incorporates neutronics for fusion devices including the development of methodologies, radiation transport simulations, nuclear heating to components, activation of in-vessel components, radiation damage to materials, and neutron and γ-ray fluxes and biological dose rates throughout the facility.
- Activation and Waste: Neutrons can cause activation and radiation damage in fusion materials. Studying these effects helps design materials that can withstand the fusion environment and predict the radioactive waste generated during operation.
- Integration and Impact Evaluation: Fusion will be integrated into the larger energy grid and society. This involves assessing the broader impacts of fusion design choices on economic, safety, environmental, and social factors.

Program Objectives

Proposals must demonstrate the following:

- Relevance to the new FES mission, vision, and topical area(s)
- How is research foundational to fusion science and technology?
- How would the results inform the fusion science and technology community?
- How will programs train the next generation of researchers?
- How will resulting data and metadata be managed based on community standards in preparation for a fusion database?
- Only for existing programs: How are you reorienting your existing program to better support the fusion science and technology vision?

This Announcement does not support medium to large-scale capability development or facility sustainability. This Announcement is for single PI or small collaborative research endeavors that are foundational to the basic fusion materials, fusion nuclear science, and enabling technology areas. Research that includes coordination of fusion science and technology meta data standards, participation in, or interest in the development of a fusion science and technology database is of particular interest to FES. Proposals addressing research clearly within the mission space of other SC and FES programs not mentioned in the topic above are nonresponsive and may be declined without a merit review.

SC is committed to promoting the diversity of investigators and institutions it supports, as indicated by the ongoing use of program policy factors (see Section V.B.2) in making selections of awards. To strengthen this commitment, small collaborative research proposals are encouraged to form teams that include the participation of emerging research institutions and minority serving institutions (MSIs) institutions that are underrepresented in the FES research portfolio as well as researchers from groups historically underrepresented in STEM.

Post-Award Process

The awarded projects will be expected to coordinate their research efforts, to the extent possible, with the FES fusion science and technology community activities. Awardees will be required to attend an annual PI meeting hosted by FES or a contractor. Awardees will be required to include a reporting schedule estimating dates for annual reporting and a mid-term review. Annual reporting is required, and a mid-term review is contingent on award progress.

Proposal Tracks

Proposals will be accepted under three tracks that are differentiated by the award size and award duration. Award size represents per year amount.

An example of an Exploratory Proposal is of smaller scope and duration such as a proposal from a lab with no existing funding from FES fusion materials, fusion nuclear science, or enabling R&D. An Exploratory Proposal is not required before submitting a Full Proposal-single topic or Full Proposal-multiple topics. Applicants interested in the Full Proposal-single or multiple topics should leverage existing capabilities.

All proposals will be considered equally. The distribution between the number of and funding for Exploratory and Full awards depends on the number and quality of the proposals; there is no quota for each category.

Proposals do not need to be at or near the award ceiling. Equal budgets for each year of the award are not required; for example, the first year of the award could include one-time costs for equipment purchases.

Open Science

SC is dedicated to promoting the values of openness in Federally-supported scientific research, including, but not limited to, ensuring that research may be reproduced and that the results of Federally-supported research are made available to other researchers. These objectives may be met through any number of mechanisms including, but not limited to, data access plans, data sharing agreements, the use of archives and repositories, and the use of various licensing schemes. The use of the phrase "open-source" does not refer to any particular licensing arrangement, but is to be understood as encompassing any arrangement that furthers the objective of openness.

Multi-Institutional Teams

SC uses two different mechanisms to support teams of multiple institutions.

COLLABORATIVE PROPOSALS

Collaborative proposals will not be accepted under this Announcement.

SUBAWARDS

Multi-institutional teams may submit one proposal from a designated lead institution with all other team members proposed as subawards.

Other Federal agencies, and another Federal agency's FFRDCs¹ may not be proposed as subawardees.

Note that the value of any such proposed subaward will be removed from any such prime award: DOE will make separate awards to Federally-affiliated institutions.

II.A. TYPE OF AWARD INSTRUMENT

DOE anticipates awarding laboratory work authorizations under this DOE National Laboratory Program Announcement.

Any awards made under this Announcement will be subject to the provisions of the contract between DOE and the awardee National Laboratory.

II.B. ESTIMATED FUNDING

A total of \$51,000,000 in current and future fiscal year funds may be available to support awards made under this DOE National Laboratory Announcement. 

IV.C.2. Abstract

The project summary/abstract is a summary of the proposed activity suitable for distribution to the public and sufficient to permit potential reviewers to identify conflicts of interest. It must be a self-contained document. The project summary/abstract must be comprised of

- A cover sheet containing the name of the applicant, the project title, the PI and the PI's institutional affiliation, and any coinvestigators and their institutional affiliations.
- This information must be followed by a statement of the project's objectives, a description of the project, including methods to be employed, and the potential impact of the project (i.e., benefits, outcomes).
- The description of the proposed research may not exceed one page when printed using standard letter-size (8.5-inch x 11 -inch) paper with 1-inch margins (top, bottom, left, and right). The body text font must not be smaller than 11-point. Figures and references, if included, must fit within the one-page limit.

INCORPORATED CONSORTIA

Incorporated consortia are eligible to apply for funding as a prime recipient (lead organization) or subrecipient (team member).

Each incorporated consortium must have an internal governance structure and a written set of internal rules. Upon request, the consortium must provide a written description of its internal governance structure and its internal rules to the DOE contracting officer. There is no requirement that subawards be formalized into incorporated consortia.

UNINCORPORATED CONSORTIA

Unincorporated consortia (team arrangements) must designate one member of the consortium to serve as the prime recipient/consortium representative (lead organization). There is no requirement that subawards be formalized into unincorporated consortia.

Upon request, unincorporated consortia must provide the DOE contracting officer with a collaboration agreement, commonly referred to as the articles of collaboration, which sets out the rights and responsibilities of each consortium member. This agreement binds the individual consortium members together and should discuss, among other things, the consortium's:

Do not use PDF portfolios or binders.

Please note the following restrictions that apply to the names of all files attached to your proposal:

- Please limit file names to 50 or fewer characters
- Do not attach any documents with the same name. All attachments must have a unique name.

RESUBMISSION OF PROPOSALS

SC requires the use of the format approved by the National Science Foundation (NSF), which may be generated by the Science Experts Network Curriculum Vitae (SciENcv), a cooperative venture maintained at https://www.ncbi.nlm.nih.gov/sciencv/. The fillable PDFs provided by the National Science Foundation at https://nsf.gov/bfa/dias/policy/nsfapprovedformats/ are no longer available. If an interagency common format for a biographical sketch has been promulgated, that format must be used in an application. The use of a format required by another agency is intended to reduce the administrative burden to researchers by promoting the use of common formats.

Requested information may be appended to a biographical sketch, whether produced from a

fillable PDF or in SciENcy.

SC strongly recommends the use of SciENcv to reduce administrative burden by allowing the use of digital persistent identifiers, including the Open Researcher and Contributer ID (ORCiD).

Do not attach a listing of individuals who should not be used as merit reviewers: This information is no longer collected as part of a biographical sketch.

- Advisors of the senior/key person while a graduate student or a postdoc
- Close associates of the senior/key person over the past 48 months
- Co-authors of the senior/key person over the past 48 months
- Co-editors of the senior/key person over the past 48 months
- Co-investigators of the senior/key person over the past 48 months
- Collaborators of the senior/key person over the past 48 months

Do not identify any personnel at the applicant institution or any proposed subrecipient or team institution: Those personnel are prohibited from serving as merit reviewers.

Large collaborations of 10 or more researchers do not require that all collaborators be identified: rather, only list the researchers with whom the senior/key person actually collaborated.

For all identified individuals, provide the following information:

- The senior/key person to whom the individual was an advisee, advisor, close associate, co-author, co-editor, co-investigator, or collaborator, identified by first name and last name
- The individual's first (given) name
- The individual's last (family) name
- The individual's Open Researcher and Contributor ID (ORCiD), if known
- The individual's institutional affiliation spelling out acronyms (For joint appointments, separate each institution with a slash ("/"). Do not list departmental affiliations.)
- The reason for listing the individual (advisee, advisor, close associate, co-author, co-editor, co-investigator, collaborator)
- The year when the individual last was a close associate, co-author, co-editor, co-investigator, or collaborator

You may also provide a list of all senior/key personnel who are planned to be or are identified in Section A of the proposal budget for the applicant and any proposed subrecipients.

The lists do not need to be sorted in any method.

The lists must be submitted in tabular format, preferably as Microsoft Excel (.xls or .xlsx) files.

For your convenience, a template is available at https://science.osti.gov/grants/Policy-and-Guidance/Agreement-Forms. If using the template:

- Do not add tabs to the spreadsheet
- Do not merge the existing tabs
- Do not remove headers
- Fill out the requested headers on both tabs with the same information
- Ensure that given and family names are presented in the correct columns

VIII.A.7. How to Prepare Current and Pending Support

WARNING: These instructions have been significantly revised to require disclosure of a variety of potential conflicts of interest or commitment, including participation in foreign government-sponsored talent recruitment programs.

Current and Pending support is intended to allow the identification of potential duplication, overcommitment, potential conflicts of interest or commitment, and all other sources of support. The PI and each senior/key person at the prime applicant and any proposed subaward must provide a list of all sponsored activities, awards, and appointments, whether paid or unpaid; provided as a gift with terms or conditions or provided as a gift without terms or conditions; full-time, part-time, or voluntary; faculty, visiting, adjunct, or honorary; cash or in-kind; foreign or domestic; governmental or private-sector; directly supporting the individual's research or indirectly supporting the individual by supporting students, research staff, space, equipment, or other research expenses. Include the current application and any application submitted to any source of funding in a list of current and pending support. All sources of support must be disclosed, but for work that is subject to government classification or enforceable non-disclosure agreements, the general area of the research should be described without disclosing sensitive details and the sponsor should be listed as "Government Agency" or "private sponsor." All foreign government-sponsored talent recruitment programs must be identified in current and pending support.

SC requires the use of the format approved by the National Science Foundation (NSF), which may be generated by the Science Experts Network Curriculum Vitae (SciENcv), a cooperative venture maintained at https://www.ncbi.nlm.nih.gov/sciencv/. The fillable PDFs provided by the National Science Foundation at https://nsf.gov/bfa/dias/policy/nsfapprovedformats/ are no longer available. If an interagency common format for current and pending support has been promulgated, that format must be used in an application. The use of a format required by another agency is intended to reduce the administrative burden to researchers by promoting the use of common formats.

For every activity, list the following items:

- The sponsor of the activity or the source of funding.
- The award or other identifying number.

- The title of the award or activity. If the title of the award or activity is not descriptive, add a brief description of the research being performed that would identify any overlaps or synergies with the proposed research.
- The total cost or value of the award or activity, including direct and indirect costs. For pending proposals, provide the total amount of requested funding.
- The award period (start date end date).
- The person-months of effort per year being dedicated to the award or activity.

If required to identify overlap, duplication of effort, or synergistic efforts, append a description of the other award or activity to the current and pending support.

Requested information may be appended to current and pending support, whether produced from a fillable PDF or in SciENcv.

SC strongly recommends the use of SciENcv to reduce administrative burden by allowing the use of digital persistent identifiers, including the Open Researcher and Contributer ID (ORCiD).

Details of any obligations, contractual or otherwise, to any program, entity, or organization sponsored by a foreign government must be provided on request to either the applicant institution or DOE.

VIII.A.8. How to Prepare a Data Management Plan

In general, a DMP should address the following requirements:

- 1. DMPs should describe whether and how data generated in the course of the proposed research will be shared and preserved. If the plan is not to share and/or preserve certain data, then the plan must explain the basis of the decision (for example, cost/benefit considerations, other parameters of feasibility, scientific appropriateness, or limitations discussed in #4). At a minimum, DMPs must describe how data sharing and preservation will enable validation of results, or how results could be validated if data are not shared or preserved.
- 2. DMPs should provide a plan for making all research data displayed in publications resulting from the proposed research open, machine-readable, and digitally accessible to the public at the time of publication. This includes data that are displayed in charts, figures, images, etc. In addition, the underlying digital research data used to generate the displayed data should be made as accessible as possible to the public in accordance with the principles stated in the Office of Science Statement on Digital Data Management (https://science.osti.gov/funding-opportunities/digital-data-management. This requirement could be met by including the data as supplementary information to the published article, or through other means. The published article should indicate how these data can be accessed.
- 3. DMPs should consult and reference available information about data management resources to be used in the course of the proposed research. In particular, DMPs that explicitly or implicitly commit data management resources at a facility beyond what is conventionally made available to approved users should be accompanied by written approval from that facility. In determining the resources available for data management at Office of Science User Facilities, researchers should consult the published description of data management resources and practices at that facility and reference it in the DMP. Information about other

- 4. DMPs must protect confidentiality, personal privacy, Personally Identifiable Information, and U.S. national, homeland, and economic security; recognize proprietary interests, business confidential information, and intellectual property rights; avoid significant negative impact on innovation, and U.S. competitiveness; and otherwise be consistent with all applicable laws, and regulations. There is no requirement to share proprietary data.

DMPs will be reviewed as part of the overall SC research proposal merit review process. Applicants are encouraged to consult the SC website for further information and suggestions for how to structure a DMP: https://science.osti.gov/funding-opportunities/digital-data-management

VIII.A.9. How to Prepare a Budget and Justification

The following advice will improve the accuracy of your budget request:

- Funds requested for personnel (senior, key, and other) must be justified as the product of their effort on the project and their institutional base salary.
- Funds requested for fringe benefits must be calculated as the product of the requested salary and, if present, the negotiated fringe benefit rate contained in an institution's negotiated indirect cost rate agreement.
- Funds requested for indirect costs must be calculated using the correct indirect cost base and the negotiated indirect cost rate.
- You are encouraged to include the rate agreement used in preparing a budget as a part of the budget justification.
- Do not prepare a budget justification using the expired DOE form F4260.1.

VIII.A.10. How to Register in PAMS

You must register in PAMS to submit a pre-proposal, letter of intent, or DOE national laboratory proposal.

Notifications sent from the PAMS system will come from the PAMS email address < <u>PAMS.Autoreply@science.doe.gov</u>>. Please make sure your email server/software allows delivery of emails from the PAMS email address to yours.

Registering to PAMS is a two-step process; once you create an individual account, you must associate yourself with ("register to") your institution. Detailed steps are listed below.

CREATE PAMS ACCOUNT:

To register, click the "Create New PAMS Account" link on the website https://pamspublic.science.energy.gov/.

- Click the "No, I have never had an account" link and then the "Create Account" button.
- You will be prompted to enter your name and email address, create a username and password, and select a security question and answer. Once you have done this, click the "Save and Continue" button.
- On the next page, enter the required information (at least one phone number and your mailing address) and any optional information you wish to provide (e.g., FAX number, website, mailstop code, additional email addresses or phone numbers, Division/Department). Click the "Create Account" button.
- Read the user agreement and click the "Accept" button to indicate that you understand your responsibilities and agree to comply with the rules of behavior for PAMS.

VIII.B. POLICY PROVISIONS

VIII.B.1. Availability of Funds

Funds are not presently available for this award. The Government's obligation under this award is contingent upon the availability of appropriated funds from which payment for award purposes can be made. No legal liability on the part of the Government for any payment may arise until funds are made available to the Contracting Officer for this award and until the awardee receives notice of such availability, to be confirmed in writing by the Contracting Officer.

information and specifies the pages of the document which are to be restricted:

"The data contained in pages _____ of this document have been submitted in confidence and contain trade secrets or proprietary information, and such data shall be used or disclosed only for evaluation purposes, provided that if this applicant receives an award as a result of or in connection with the submission of this proposal, DOE shall have the right to use or disclose the data herein to the extent provided in the award. This restriction does not limit the government's right to use or disclose data obtained without restriction from any source, including the applicant."

To protect such data, each line or paragraph on the pages containing such data must be specifically identified and marked with a legend similar to the following:

"The following contains proprietary information that (name of applicant) requests not be released to persons outside the Government, except for purposes of review and evaluation."

VIII.B.10. Publications

Researchers are expected to publish or otherwise make publicly available the results of the work conducted under any authorization resulting from this Announcement. Publications and other methods of public communication describing any work based on or developed under an authorization resulting from this Announcement must contain an acknowledgment of SC support. The author's copy of any peer-reviewed manuscript accepted for funding must be announced to DOE's Office of Scientific and Technical Information (OSTI) and made publicly available in accordance with the instructions contained in the Reporting Requirements Checklist incorporated in all Assistance Agreements.
