Proposed Action Description:

The U.S. Department of Energy (DOE) proposes to proposes to modify the lease of real property on the Wilson Tract on the Lawrence Berkeley National Laboratory (LBNL, or Berkeley Lab) site. The lease is maintained between the U.S. Department of Energy (DOE) and the University of California (UC). The lease modification, referred to herein as Supplement No. 15, would (1) remove from the lease (Parcel 2) real property Trailer 46D (now demolished), (2) remove from the lease (Parcel 4) Building 54A (ATM Shelter, now demolished), and (3) set Parcel 1C start and end dates as September 22, 2021 to September 21, 2071. Parcel 1C would support the Biological and Environmental Program Integration Center (BioEPIC), a lab/office building currently under construction that would host bioscience research. No physical changes are anticipated as part of these lease amendments.
