All new and renewal proposals must provide a Promoting Inclusive and Equitable Research (PIER) Plan as an appendix to the research narrative. Please read the instructions in <u>Section IV</u> and the associated review criteria in <u>Section V</u>.

INTERAGENCY FORMATS FOR CURRENT AND PENDING SUPPORT AND BIOGRAPHICAL SKETCHES

Interagency common instructions for preparing current and pending support and biographical sketches are being developed. SUMMARY

The DOE SC program in Biological and Environmental Research (BER) hereby announces its interest in receiving proposals for the development of a pilot study to measure marine aerosols, clouds, and other environmental parameters of interest from commercial ocean vessels. Oceans cover 71% of the Earth's surface and the responses of marine clouds to climate change are a critical uncertainty in Earth system models. More observations of marine aerosols, clouds, greenhouse gases, and other atmospheric properties are needed to evaluate and improve Earth system models. The ability to leverage the vast number of commercial vessels that regularly sail the world's oceans would provide opportunities to greatly expand the reach of shipborne observations, but significant challenges must be addressed before a sustained atmospheric observing program on commercial vessels would be feasible. This announcement solicits proposals led by DOE/NNSA National Laboratories (including academic or industry partners, as appropriate) that focus on the identification, development, and pilot deployment of a small suite of instruments that can be operated autonomously on commercial vessels to address BER science questions.

SUPPLEMENTARY INFORMATION

Program Objective

The mission of the Biological and Environmental Research (BER) program (https://science.osti.gov/ber) is to support transformative science and scientific user facilities to achieve a predictive understanding of complex biological, earth, and environmental systems for energy and infrastructure security, independence, and prosperity. Within BER, Atmospheric System Research (https://science.osti.gov/ber/Research/eessd/Atmospheric-System-Research-Program) is focused on quantifying the interactions among aerosols, clouds, precipitation, and radiation to improve understanding of key cloud, aerosol, precipitation, and radiation processes that affect the Earth's radiative balance and hydrological cycle, especially processes that limit the predictive ability of regional and global models.

In 2018, BER hosted a workshop to facilitate input and discussion from the scientific community on the highest-priority opportunities for BER observational capabilities to best address the BER

goal of improving the predictability of Earth system models (Atmospheric Radiation Measurement (ARM) User Facility ARM Mobile Facility Workshop Report). One of the key areas identified in that workshop were marine regions. As discussed in the workshop report, "Approximately 80% of all low clouds on Earth occur over the oceans, and uncertainty in how marine low clouds are expected to change with increasing greenhouse gases remains the largest source of uncertainty in cloud feedback and climate sensitivity. In addition, although most anthropogenic aerosols originate from emissions over land, models show that a disproportionately large fraction of the global aerosol indirect forcing is associated with aerosol-cloud interactions over remote marine regions. Earth system models suffer from major biases in their representation of clouds, precipitation, and aerosols in marine regions. There is a great need for surface and in situ observations of clouds, aerosols, and precipitation in marine regions, but logistical and measurement challenges mean that such observations are mostly restricted to relatively short campaigns with research vessels and/or aircraft."

Targeted field campaigns on dedicated research vessels allow deployment of complex instruments to particular marine regions of interest to address important science questions. However, these complex instruments usually require dedicated scientists and technicians to operate them for high quality measurements. The expense of these dedicated campaigns and the small number of available research vessels limit the amount of data that can be collected. Development of suites of autonomously operating instrumentation that could be deployed on ships without dedicated scientists/technicians would enable scientists to leverage the vast number of commercial vessels that regularly sail the world's oceans and would provide opportunities to greatly expand the reach of shipborne observations.

A pilot study to identify and address the challenges in deploying unattended autonomously operating instruments on commercial vessels for atmospheric observations would provide important information for assessing the feasibility and scientific value of developing a sustained observational program. In March 2024, BER organized a workshop to obtain information from the research community on the highest scientific priorities, technical challenges and potential solutions, and opportunities for deploying instrumentation to measure marine aerosols, clouds, greenhouse gases, and other atmospheric variables on commercial ocean vessels. The draft workshop report Observing Marine Aerosols and Clouds from Ships 2024 Workshop Report identified key logistical challenges and potential solutions; opportunities for coordination with existing efforts; high-priority feasible instrumentation for unattended autonomous operations; scientific questions that could be potentially addressed with these measurements; and key elements that would be necessary for a successful pilot program.

Pilot study

Given the significant challenges that must be overcome to develop a sustainable observational program on commercial ships, BER is soliciting proposals for a pilot study to develop and deploy a small suite of autonomously operating instruments on a commercial ship to address BER science questions. The primary goals of the pilot study are to demonstrate feasibility of the selected set of instrumentation for unattended operations on ships, develop data management procedures suitable for the measurements, and illustrate the potential of the measurements for addressing BER-relevant science questions.

Proposals must include:

- A vision for a sustained observational program of unattended autonomous measurements of marine aerosols, clouds, and other environmental factors on commercial ships to address BER science questions;
- A research plan and up to 3-year timeline for conducting a pilot study to test and assess the feasibility and approach in support of the observational program vision;
- Discussion of collaboration, leveraging, or coordination with existing activities; and
- A comprehensive Data Management Plan (DMP) that spans quality control, data processing, data flow, data archiving, and data distribution.

The proposed pilot study must include:

- Metrics of success for the pilot study demonstration;
- A set of specific BER-relevant science questions;
- A defined set of planned instrumentation and measurements that are clearly linked to the set of specific BER-relevant science questions;
- Any necessary instrument development, hardening, packaging into modules, operational configuration, and phased testing of autonomous operations;
- Development of instrument maintenance and calibration processes suitable for a sustained observational program (i.e., that do not require skilled technicians to operate/maintain the instruments onboard the vessel);
- Demonstration of unattended autonomous deployment of instrumentation on a nonresearch marine vessel for at least a one-week period;
- Analysis of the proposed observations and evaluation of their applicability and utility for addressing the set of BER-relevant science questions;
- A publicly available pilot study report that summarizes instrument development, data management processes, best practices, and lessons learned; and
- Communication and engagement with the broader scientific community.

Applicants may consider phased approaches for the pilot study, in which a small set of instruments is initially deployed, and additional more complex instruments are added in later phases. The pilot study may focus on a smaller subset of science questions than those described in the vision for a sustained observational program.

Coordination with existing DOE or other agency activities

Applicants are encouraged to coordinate with and/or leverage expertise on instrumentation, data quality control, data processing, and data archiving from existing DOE projects or facilities (or other agency efforts), where appropriate rather than developing new or stand-alone capabilities. Funding for the personnel/effort to support these activities should be included in the budget of this application.

Applicants should not assume that instrumentation from the Atmospheric Radiation Measurement (ARM) facility will be available for loan or deployment to support the proposed

pilot project. Applicants may propose to use existing equipment owned by their institutions or to purchase new equipment to support the pilot project.

Participation in ASR Meetings

To ensure that the program meets the broadest needs of the research community and the specific needs of BER, successful applicants are expected to attend the annual science team meeting and to participate as ASR science team members in the appropriate working group(s) relevant to their efforts.

Costs for participation in the annual Joint ARM User Facility and ASR Principal Investigators Meeting should be included in the budget. Estimated costs should be based on one one-week meeting in Washington, D.C.

Teaming Arrangements

Teams of multiple institutions are invited to submit a proposal under this Program Announcement. Any multi-institutional team must be led by a DOE/NNSA National Laboratory

- 1. Members of multi-institutional teams that are not DOE/NNSA National Laboratories must be proposed as subawards under the proposal from the lead DOE/NNSA National Laboratory.
- 2. Members of multi-institutional teams that are DOE/NNSA National Laboratories must be proposed using the collaborative proposal process described below.

Limitation on Submissions

Applicant institutions are limited to no more than one letter of intent or proposal as the lead institution.

Open Science

SC is dedicated to promoting the values of openness in Federally-supported scientific research, including, but not limited to, ensuring that research may be reproduced and that the results of Federally-supported research are made available to other researchers. These objectives may be met through any number of mechanisms including, but not limited to, data access plans, data sharing agreements, the use of archives and repositories, and the use of various licensing schemes.

The use of the phrase "open-source" does not refer to any particular licensing arrangement, but is to be understood as encompassing any arrangement that furthers the objective of openness.

To be in compliance with the data policy of the U.S. Global Change Research Program of full and open access to global change research data and the Office of Science Statement on Digital Data Management, the required DMP must include a description of the researcher's data sharing plans if the proposed research involves the acquisition of data in the course of the research that

would be of use to the climate research and assessment communities. This includes data from extensive, long-term observations and experiments and from long-term model simulations of climate that would be costly to duplicate. The DMP must describe plans for sharing the data that are to be acquired in the course of the proposed research, particularly how the acquired data will be preserved, documented, and quality assured, and where it will be archived for access by others. Data of potentially broad use in climate change research and assessments should be archived, when possible, in data repositories for subsequent dissemination. Additional BER requirements and guidance for digital data management is available at https://science.osti.gov/ber/Funding-Opportunities/Digital-Data-Management.

Multi-Institutional Teams

SC uses two different mechanisms to support teams of multiple institutions.

COLLABORATIVE PROPOSALS

Teams of multiple institutions may submit collaborative proposals for DOE/NNSA National Laboratories. Each submitted proposal in such a team must indicate that it is part of a collaborative project/group. Every partner institution must submit its own proposal through its own processes. Each multi-institutional team can have only one lead institution. Each proposal within the multi-institutional team, including the narrative, starting with the title page, and all required appendices and attachments, must be identical with the following exceptions:

- Each proposal must contain a correct PAMS cover page for the submitting institution only.
- Each proposal must contain a unique budget corresponding to the expenditures for that proposal's submitting institution only.
- Each proposal must contain a unique budget justification corresponding to the expenditures for that proposal's submitting institution only.
- Each proposal must include a list for the Identification of Merit Review Conflicts for the submitting institution's senior/key personnel and its subawards' senior/key personnel.
- Each proposal must include the biographical sketches and current and pending support from that institution's senior/key personnel. The applicant leading the multi-institutional team must include biographical sketches and current and pending support from each institution's senior/key personnel.

Our intent is to create from the various proposals associated with a multi-institutional team one document for merit review that consists of the common, identical materials combined with a set of detailed budgets from the partner institutions. Thus, it is very important that every research narrative in the multi-institutional team be identical, while each team member must submit its own system-generated cover page, budget, and budget justification.

SUBAWARDS

Multi-institutional teams may submit one proposal from a designated lead institution with all non-DOE/NNSA National Laboratory team members proposed as subawards.

Other Federal agencies and another Federal agency's FFRDCs¹ may not be proposed as team members, either as subawardees or using the collaborative proposal process.

DISTINGUISHING BETWEEN COLLABORATIVE PROPOSALS AND SUBAWARDS

The following points of advice to proposers may be helpful:

- 1. Both collaborative proposals and proposed subawards are methods by which multiple institutions can work together to reach the scientific objectives described in this Announcement. Choose the appropriate structure based on the institutions being proposed.
 - a. Team members that are not DOE/NNSA National Laboratories must be proposed as subawards under the lead DOE/NNSA National Laboratory's proposal.
 - b. Team members that are DOE/NNSA National Laboratories must be proposed using the collaborative proposal process.
- 2. A single multi-institutional team may thus require the use of both subawards and collaborative proposals.

Section II – AWARD INFORMATION

II.A. TYPE OF AWARD INSTRUMENT

DOE anticipates awarding laboratory work authorizations under this DOE National Laboratory Program Announcement.

Any awards made under this Announcement will be subject to the provisions of the contract between DOE and the awardee National Laboratory.

DOE will consider funding multi-institution teams submitted as collaborative proposals, in which each institution must submit its own proposal with an identical common research narrative, under this Announcement. Multi-institutional teams may also apply using a prime and subaward model with one proposal submitted by the lead institution. Team members that are not DOE/NNSA National Laboratories must be proposed as subawards under the lead DOE/NNSA National Laboratories must be proposed using the collaborative proposal process.

ILB. ESTIMATED FUNDING

DOE anticipates that a total of \$3 million in current fiscal year funds will be used to support awards under this Announcement.

DOE is under no obligation to pay for any costs associated with preparation or submission of proposals. DOE reserves the right to fund, in whole or in part, any, all, or none of the proposals submitted in response to this Announcement.

II.C. MAXIMUM AND MINIMUM AWARD SIZE

(See B. Estimated Funding section above.)

A multi-institutional team, whether applied for as a prime applicant with subawards or as collaborative proposals, is limited to a total request of no more than \$3,000,000.

Ceiling

\$3,000,000 total

The award ceiling applies to the total budget, regardless of whether the application is from a single institution or from a multi-institutional team.

Floor

\$2,750,000 total

II.D. EXPECTED NUMBER OF AWARDS

One award is expected.

II.E. ANTICIPATED AWARD SIZE

(See B. Estimated Funding Section above.)

It is anticipated that award size will be approximately \$3,000,000.

II.F. PERIOD OF PERFORMANCE

(See B. Estimated Funding section above.)

DOE anticipates making awards with a project period of two to three years.

Continuation funding (funding for the second and subsequent budget periods) is contingent on: (1) availability of funds appropriated by Congress and future year budget authority; (2) progress towards meeting the objectives of the approved proposal; (3) submission of required reports; and (4) compliance with the terms and conditions of the award.

II.G. TYPE OF PROPOSAL

DOE will accept new DOE National Laboratory Proposals under this DOE National Laboratory Announcement. Please only submit a PAMS lab technical proposal in response to this Announcement; do not submit a DOE Field Work Proposal (FWP) at this time. SC will request FWPs later from those selected for funding consideration under this Announcement.

Section III – ELIGIBILITY INFORMATION

III.A. ELIGIBLE APPLICANTS AND TOPICS

This is a DOE/NNSA National Laboratory-only Announcement. FFRDCs from other Federal agencies are not eligible to submit in response to this Program Announcement.

III.B. COST SHARING

Cost sharing is not required.

III.C. ELIGIBLE INDIVIDUALS

Eligible individuals with the skills, knowledge, and resources necessary to carry out the proposed research as a Principal Investigator (PI) are invited to work with their organizations to develop a proposal. Individuals from underrepresented groups as well as individuals with disabilities are always encouraged to apply.

III.D. LIMITATIONS ON SUBMISSIONS

Applicant institutions are limited to no more than one letter of intent or proposal as the lead institution.

Should DOE receive submissions in excess of the applicable limits, DOE reserves the right, in its sole discretion, to request additional or clarifying information to ascertain the institution's intended submissions. The project narrative **must not exceed a page limit of 18 pages** of technical information, including charts, graphs, maps, photographs, and other pictorial presentations, when printed using standard letter-size (8.5-inch x 11-inch) paper with 1-inch margins (top, bottom, left, and right). The body text font of all main text must not be smaller than 11-point. Merit reviewers will only consider the number of pages specified in the first sentence of this paragraph. This page

limit does not apply to the Title Page, Budget Page(s), Budget Justification, biographical material, publications and references, and appendices, each of which may have its own page limit defined later in this Announcement.

Merit reviewers are not required to access Internet sites; however, Internet publications in a list of references will be treated identically to print publications. DOE notes that not all requests for late submission will be approved.

Section V - PROPOSAL REVIEW INFORMATION

V.A. CRITERIA

V.A.1. Initial Review Criteria

Prior to a comprehensive merit evaluation, DOE will perform an initial review to determine that (1) the applicant is eligible for the award; (2) the information required by the Program Announcement has been submitted; (3) all mandatory requirements are satisfied; (4) the proposed project is responsive to the objectives of the Program Announcement, and (5) the proposed project is not duplicative of programmatic work. Proposals that fail to pass the initial review will not be forwarded for merit review and will be eliminated from further consideration.

V.A.2. Merit Review Criteria

Proposals will be subjected to scientific merit review (peer review) and will be evaluated against the following criteria, listed in descending order of importance.

- Scientific and/or Technical Merit of the Project;
- Appropriateness of the Proposed Method or Approach;
- Competency of Applicant's Personnel and Adequacy of Proposed Resources; and
- Reasonableness and Appropriateness of the Proposed Budget.
- Quality and Efficacy of the Promoting Inclusive and Equitable Research (PIER) Plan.

The evaluation process will also include program policy factors such as the relevance of the proposed research to the terms of the DOE National Laboratory Announcement and the agency's programmatic needs, the balance of activities within the program, and the utility of the proposed activities to the broader scientific community. Note that external peer reviewers are selected with regard to both their scientific expertise and the absence of conflict-of-interest issues. Both Federal and non-Federal reviewers may be used, and submission of a proposal constitutes agreement that this is acceptable to the investigator(s) and the submitting institution.

The questions below are provided to the merit reviewers to elaborate the criteria:

SCIENTIFIC AND/OR TECHNICAL MERIT OF THE PROPOSED RESEARCH

- What is the scientific innovation of the proposed research?
- What is the likelihood of achieving valuable results?
- How might the results of the proposed work impact the direction, progress, and thinking in relevant scientific fields of research?
- How does the proposed work compare with other efforts in its field, both in terms of scientific and/or technical merit and originality?
- Is the Data Management Plan suitable for the proposed research? To what extent does it support the validation of research results? To what extent will research products, including data, be made available and reusable to advance the field of research?

• Is the Data Management Plan comprehensive? How effectively does it span quality control, data processing, data flow, data archiving, and data distribution?

APPROPRIATENESS OF THE PROPOSED METHOD OR APPROACH

- Does the proposed effort employ innovative concepts or methods?
- How logical and feasible are the approaches?
- Are the conceptual framework, methods, and analyses well justified, adequately developed, and likely to lead to scientifically valid conclusions?
- Does the applicant recognize significant potential problems and consider alternative strategies?
- Is the timeline of activities reasonable and suitable for meeting the goals of the pilot project?

COMPETENCY OF APPLICANT'S PERSONNEL AND ADEQUACY OF PROPOSED RESOURCES

- Does the proposed work take advantage of unique facilities and capabilities?
- What is the past performance of the team?
- Is the lead institution proposing to perform a greater portion of the scientific and technical work than any other team member?
- How well qualified is the team to carry out the proposed work?
- Are the environment and facilities adequate for performing the proposed effort?
- To what extent does the proposed work effectively leverage or coordinate with existing activities?

REASONABLENESS AND APPROPRIATENESS OF THE PROPOSED BUDGET

- Are the proposed budget and staffing levels adequate to carry out the proposed work?
- Is the budget reasonable and appropriate for the scope?

QUALITY AND EFFICACY OF THE PROMOTING INCLUSIVE AND EQUITABLE RESEARCH PLAN

- Is the proposed Promoting Inclusive and Equitable Research (PIER) Plan suitable for the size and complexity of the proposed project and an integral component of the proposed project?
- To what extent is the PIER plan likely to lead to participation of individuals from diverse backgrounds, including individuals historically underrepresented in the research community?
- What aspects of the PIER plan are likely to contribute to the goal of creating and maintaining an equitable, inclusive, encouraging, and professional training and research environment and supporting a sense of belonging among project personnel?
- How does the proposed plan include intentional mentorship and are the associated mentoring resources reasonable and appropriate?

V.B. REVIEW AND SELECTION PROCESS

V.B.1. Merit Review

Proposals that pass the initial review will be subjected to a formal merit review and will be evaluated based on the criteria above.

V.B.2. Program Policy Factors

The Selection Official may consider any of the following program policy factors in making the selection, listed in no order of significance:

- Availability of funds
- Relevance of the proposed activity to SC priorities
- Ensuring an appropriate balance of activities within SC programs
- Performance under current awards
- Quality of international or interagency collaboration
- Participation with multi-institutional teams
- Commitment to sharing the results of research
- Promoting principal investigators with a commitment to improving diversity, equity, and inclusion in the STEM community

V.B.3. Selection

The Selection Official will consider the findings of the merit review and may consider any of the Program Policy Factors described above.

V.B.4. Discussions and Award

The Government may enter into discussions with a selected applicant for any reason deemed necessary. Failure to resolve satisfactorily the issues identified by the Government will preclude award to the applicant.

V.C. ANTICIPATED NOTICE OF SELECTION AND AWARD DATES

It is anticipated that the award selection will be completed by September 30, 2024. It is expected that awards will be made in Fiscal Year 2024.

VIII.A.1. How Consortia May be Used

INCORPORATED CONSORTIA

Incorporated consortia are eligible to apply for funding as a prime recipient (lead organization) or subrecipient (team member).

Each incorporated consortium must have an internal governance structure and a written set of internal rules. Upon request, the consortium must provide a written description of its internal governance structure and its internal rules to the DOE contracting officer. There is no requirement that subawards be formalized into incorporated consortia.

UNINCORPORATED CONSORTIA

Unincorporated consortia (team arrangements) must designate one member of the consortium to serve as the prime recipient/consortium representative (lead organization). There is no requirement that subawards be formalized into unincorporated consortia.

Upon request, unincorporated consortia must provide the DOE contracting officer with a collaboration agreement, commonly referred to as the articles of collaboration, which sets out the rights and responsibilities of each consortium member. This agreement binds the individual consortium members together and should discuss, among other things, the consortium's:

- Management structure;
- Method of making payments to consortium members;
- Means of ensuring and overseeing members' efforts on the project;
- Provisions for members' cost sharing contributions; and
- Provisions for ownership and rights in intellectual property developed previously or under the agreement.

Note that a consortium is applied for in one proposal and results in one award with subawards to consortia members. Multi-institutional teams may, if permitted under this Announcement, submit collaborative proposals with each institution submitting its own proposal with an identical research narrative, resulting in multiple awards to the collaborating institutions.

VIII.A.2. How to Submit Letters of Intent

It is important that the LOI be a single file with extension .pdf, .docx, or .doc. The filename must not exceed 50 characters. The PI and anyone submitting on behalf of the PI must register for an account in PAMS before it will be possible to submit a letter of intent. All PIs and those submitting LOIs on behalf of PIs are encouraged to establish PAMS accounts as soon as possible to avoid submission delays.

Submit Your Letter of Intent:

- Log into PAMS. From the proposals tab, click the "View DOE National Laboratory Announcements" link and find the current announcement in the list. Click the "Actions/Views" link in the Options column next to this Announcement to obtain a dropdown menu. Select "Submit Proposal" from the dropdown.
- Note that you must select one and only one Principal Investigator (PI) per proposal; to do so, click the "Select PI" button on the far right side of the screen. Find the appropriate PI from the list of all registered users from your institution returned by PAMS. (Hint: You may have to sort, filter, or search through the list if it has multiple pages.) Click the "Actions" link in the Options column next to the appropriate PI to obtain a dropdown menu. From the dropdown, choose "Select PI."
- If the PI for whom you are submitting does not appear on the list, it means he or she has not yet registered in PAMS. For your convenience, you may have PAMS send an email invitation to the PI to register in PAMS. To do so, click the "Invite PI" link at the top left of the "Select PI" screen. Please only submit a PAMS lab technical proposal in response to this Announcement; do not submit a DOE Field Work Proposal (FWP) at this time. SC will request FWPs later from those selected for funding consideration under this Announcement.

PROPOSAL PREPARATION

All files submitted a part of a proposal must be PDF files unless otherwise specified in this Announcement. Attached PDF files must be plain files consisting of text, numbers, and images without editable fields, signatures, passwords, redactions, or other advanced features available in some PDF-compatible software. Do not use PDF portfolios or binders.

Please note the following restrictions that apply to the names of all files attached to your proposal:

- Please limit file names to 50 or fewer characters
- Do not attach any documents with the same name. All attachments must have a unique name.
- Please use only the following characters when naming your attachments: A-Z, a-z, 0-9, underscore, hyphen, space, period, parenthesis, curly braces, square brackets, ampersand, tilde, exclamation point, comma, semi colon, apostrophe, at sign, number sign, dollar sign, percent sign, plus sign, and equal sign. Attachments that do not follow this rule may cause the entire proposal to be rejected or cause issues during processing.

RESUBMISSION OF PROPOSALS

Proposals submitted under this announcement may be withdrawn from consideration by using the PAMS website at https://pamspublic.science.energy.gov. Proposals may be withdrawn at any time between when the applicant submits the proposal and when DOE makes the proposal available to merit reviewers. Such withdrawals take effect immediately and cannot be reversed. Please exercise due caution. After the proposal is made available to merit reviewers, the applicant may contact the DOE program office identified in this Announcement to request that it be withdrawn.

After a proposal is withdrawn, it may be resubmitted, if this Announcement is still open for the submission of proposals. Such resubmissions will only count as one submission if this Announcement restricts the number of proposals from an applicant.

IMPROPER CONTENTS OF PROPOSALS

Proposals submitted under this Announcement will be stored in controlled-access systems, but they may be made publicly available if an award is made. As such, it is critical that applicants follow these guidelines:

- Do not include information subject to any legal restriction on its open distribution, whether classified, export control, or unclassified controlled nuclear information.
- Do not include sensitive and protected personally identifiable information, including social security numbers, birthdates, citizenship, marital status, or home addresses. Pay particular attention to the content of biographical sketches and curriculum vitae.
- Do not include letters of support from Federal officials.
- Do not include letters of support on Federal letterhead. Letters that are not letters of support (such as letters confirming access to sites, facilities, equipment, or data; or letters from cognizant contracting officers) may be on Federal letterhead.
- Clearly mark all proprietary or trade-secret information.

VIII.A.5. How to Prepare a Biographical Sketch

A biographical sketch is to provide information that can be used by reviewers to evaluate the PI's potential for leadership within the scientific community. Examples of information of interest are invited and/or public lectures, awards received, scientific program committees, conference or workshop organization, professional society activities, special international or industrial partnerships, reviewing or editorship activities, or other scientific leadership experiences.

SC requires the use of the format approved by the National Science Foundation (NSF), which may be generated by the Science Experts Network Curriculum Vitae (SciENcv), a cooperative venture maintained at https://www.ncbi.nlm.nih.gov/sciencv/. The fillable PDFs provided by the National Science Foundation are no longer available. When interagency common formats and instructions are promulgated, their use will be accepted. See https://new.nsf.gov/funding/senior-personnel-documents for more information. The use of a format required by another agency is intended to reduce the administrative burden to researchers by promoting the use of common formats.

Requested information may be appended to a biographical sketch, whether produced from a fillable PDF or in SciENcv.

SC strongly recommends the use of SciENcv to reduce administrative burden by allowing the use of digital persistent identifiers, including the Open Researcher and Contributer ID (ORCiD).

Do not attach a listing of individuals who should not be used as merit reviewers: This information is no longer collected as part of a biographical sketch.

VIII.A.6. How to Prepare a List of Individuals Who Should Not Serve as Reviewers

To assist in identifying individuals who should not serve as merit reviews, provide the following information for each and every senior/key person who is planned to be or is identified in Section A of the proposal budget for the applicant and any proposed subrecipients:

- Advisees (graduate students or postdocs) of the senior/key person
- Advisors of the senior/key person while a graduate student or a postdoc
- Close associates of the senior/key person over the past 48 months
- Co-authors of the senior/key person over the past 48 months
- Co-editors of the senior/key person over the past 48 months
- Co-investigators of the senior/key person over the past 48 months
- Collaborators of the senior/key person over the past 48 months

Do not identify any personnel at the applicant institution or any proposed subrecipient or team institution: Those personnel are prohibited from serving as merit reviewers.

Large collaborations of 10 or more researchers do not require that all collaborators be identified: rather, only list the researchers with whom the senior/key person actually collaborated.

For all identified individuals, provide the following information:

- The senior/key person to whom the individual was an advisee, advisor, close associate, co-author, co-editor, co-investigator, or collaborator, identified by first name and last name
- The individual's first (given) name
- The individual's last (family) name
- The individual's Open Researcher and Contributor ID (ORCiD), if known
- The individual's institutional affiliation spelling out acronyms (For joint appointments, separate each institution with a slash ("/"). Do not list departmental affiliations.)
- The reason for listing the individual (advisee, advisor, close associate, co-author, co-editor, co-investigator, collaborator)
- The year when the individual last was a close associate, co-author, co-editor, co-investigator, or collaborator

You may also provide a list of all senior/key personnel who are planned to be or are identified in Section A of the proposal budget for the applicant and any proposed subrecipients.

The lists do not need to be sorted in any method.

The lists must be submitted in tabular format, preferably as Microsoft Excel (.xls or .xlsx) files.

For your convenience, a template is available at https://science.osti.gov/grants/Policy-and-Guidance/Agreement-Forms. If using the template:

- Do not add tabs to the spreadsheet
- Do not merge the existing tabs
- Do not remove headers
- Fill out the requested headers on both tabs with the same information

Current and Pending support is intended to allow the identification of potential duplication, overcommitment, potential conflicts of interest or commitment, and all other sources of support. The PI and each senior/key person at the prime applicant and any proposed subaward must provide a list of all sponsored activities, awards, and appointments, whether paid or unpaid; provided as a gift with terms or conditions or provided as a gift without terms or conditions; full-time, part-time, or voluntary; faculty, visiting, adjunct, or honorary; cash or in-kind; foreign or domestic; governmental or private-sector; directly supporting the individual's research or indirectly supporting the individual by supporting students, research staff, space, equipment, or other research expenses. All foreign government-sponsored talent recruitment programs must be identified in current and pending support.

SC requires the use of the format approved by the National Science Foundation (NSF), which may be generated by the Science Experts Network Curriculum Vitae (SciENcv), a cooperative venture maintained at https://www.ncbi.nlm.nih.gov/sciencv/. The fillable PDFs provided by the National Science Foundation are no longer available. When interagency common formats and instructions are promulgated, their use will be accepted. See https://new.nsf.gov/funding/senior-personnel-documents for more information. The use of a format required by another agency is intended to reduce the administrative burden to researchers by promoting the use of common formats.

For every activity, list the following items:

- The sponsor of the activity or the source of funding.
- The award or other identifying number.
- The title of the award or activity. If the title of the award or activity is not descriptive, add a brief description of the research being performed that would identify any overlaps or synergies with the proposed research.
- The total cost or value of the award or activity, including direct and indirect costs. For pending proposals, provide the total amount of requested funding.
- The award period (start date end date).

• The person-months of effort per year being dedicated to the award or activity.

If required to identify overlap, duplication of effort, or synergistic efforts, append a description of the other award or activity to the current and pending support.

Requested information may be appended to current and pending support, whether produced from a fillable PDF or in SciENcv.

SC strongly recommends the use of SciENcv to reduce administrative burden by allowing the use of digital persistent identifiers, including the Open Researcher and Contributer ID (ORCiD).

Details of any obligations, contractual or otherwise, to any program, entity, or organization sponsored by a foreign government must be provided on request to either the applicant institution or DOE.

VIII.A.8. How to Prepare a Data Management Plan

In general, a DMP should address the following requirements:

- 1. DMPs should describe whether and how data generated in the course of the proposed research will be shared and preserved. If the plan is not to share and/or preserve certain data, then the plan must explain the basis of the decision (for example, cost/benefit considerations, other parameters of feasibility, scientific appropriateness, or limitations discussed in #4). At a minimum, DMPs must describe how data sharing and preservation will enable validation of results, or how results could be validated if data are not shared or preserved.
- 2. DMPs should provide a plan for making all research data displayed in publications resulting from the proposed research open, machine-readable, and digitally accessible to the public at the time of publication. This includes data that are displayed in charts, figures, images, etc. In addition, the underlying digital research data used to generate the displayed data should be made as accessible as possible to the public in accordance with the principles stated in the Office of Science Statement on Digital Data Management (https://science.osti.gov/funding-opportunities/digital-data-management. This requirement could be met by including the data as supplementary information to the published article, or through other means. The published article should indicate how these data can be accessed.
- 3. DMPs should consult and reference available information about data management resources to be used in the course of the proposed research. In particular, DMPs that explicitly or implicitly commit data management resources at a facility beyond what is conventionally made available to approved users should be accompanied by written approval from that facility. In determining the resources available for data management at Office of Science User Facilities, researchers should consult the published description of data management resources and practices at that facility and reference it in the DMP. Information about other Office of Science facilities can be found at https://science.osti.gov/user-facilities/.
- 4. DMPs must protect confidentiality, personal privacy, Personally Identifiable Information, and U.S. national, homeland, and economic security; recognize proprietary interests, business confidential information, and intellectual property rights; avoid significant negative impact on innovation, and U.S. competitiveness; and otherwise be consistent with all applicable laws, and regulations. There is no requirement to share proprietary data.

DMPs will be reviewed as part of the overall SC research proposal merit review process. Applicants are encouraged to consult the SC website for further information and suggestions for how to structure a DMP: https://science.osti.gov/funding-opportunities/digital-data-management

VIII.A.9. How to Prepare a Budget and Justification

The following advice will improve the accuracy of your budget request:

- Funds requested for personnel (senior, key, and other) must be justified as the product of their effort on the project and their institutional base salary.
- Funds requested for fringe benefits must be calculated as the product of the requested salary and, if present, the negotiated fringe benefit rate contained in an institution's negotiated indirect cost rate agreement.
- Funds requested for indirect costs must be calculated using the correct indirect cost base and the negotiated indirect cost rate.
- You are encouraged to include the rate agreement used in preparing a budget as a part of the budget justification.
- Do not prepare a budget justification using the expired DOE form F4260.1.

VIII.A.10. How to Register in PAMS

You must register in PAMS to submit a pre-proposal, letter of intent, or DOE national laboratory proposal.

Notifications sent from the PAMS system will come from the PAMS email address < <u>PAMS.Autoreply@science.doe.gov</u>>. Please make sure your email server/software allows delivery of emails from the PAMS email address to yours.

Registering to PAMS is a two-step process; once you create an individual account, you must associate yourself with ("register to") your institution. Detailed steps are listed below.

CREATE PAMS ACCOUNT:

To register, click the "Create New PAMS Account" link on the website https://pamspublic.science.energy.gov/.

- Click the "No, I have never had an account" link and then the "Create Account" button.
- You will be prompted to enter your name and email address, create a username and password, and select a security question and answer. Once you have done this, click the "Save and Continue" button.
- On the next page, enter the required information (at least one phone number and your mailing address) and any optional information you wish to provide (e.g., FAX number, website, mailstop code, additional email addresses or phone numbers, Division/Department). Click the "Create Account" button.
- Read the user agreement and click the "Accept" button to indicate that you understand your responsibilities and agree to comply with the rules of behavior for PAMS.
- PAMS will take you to the "Having Trouble Logging In?" page. (If you have been an SC merit reviewer or if you have previously submitted a proposal, you may already be linked to an institution in PAMS. If this happens, you will be taken to the PAMS home page.)

Upon submission, the proposal will appear under My Proposals for the PI and the Submitter with a Proposal Status of "Submitted to DOE."

VIII.B. POLICY PROVISIONS

VIII.B.1. Availability of Funds

Funds are not presently available for this award. The Government's obligation under this award is contingent upon the availability of appropriated funds from which payment for award purposes can be made. No legal liability on the part of the Government for any payment may arise until funds are made available to the Contracting Officer for this award and until the awardee receives notice of such availability, to be confirmed in writing by the Contracting Officer.

VIII.B.2. Commitment of Public Funds

The use and disclosure of such data may be restricted, provided the applicant includes the following legend on the first page of any document included in the proposal that contains such proprietary information and specifies the pages of the document which are to be restricted:

"The data contained in pages _____ of this document have been submitted in confidence and contain trade secrets or proprietary information, and such data shall be used or disclosed only for evaluation purposes, provided that if this applicant receives an award as a result of or in

connection with the submission of this proposal, DOE shall have the right to use or disclose the data herein to the extent provided in the award. This restriction does not limit the government's right to use or disclose data obtained without restriction from any source, including the applicant."

To protect such data, each line or paragraph on the pages containing such data must be specifically identified and marked with a legend similar to the following:

"The following contains proprietary information that (name of applicant) requests not be released to persons outside the Government, except for purposes of review and evaluation."

VIII.B.10. Publications

Researchers are expected to publish or otherwise make publicly available the results of the work conducted under any authorization resulting from this Announcement. Publications and other methods of public communication describing any work based on or developed under an authorization resulting from this Announcement must contain an acknowledgment of SC support.
