AUTHORITY HAVING JURISDICTION AND BUILDING CODE OFFICIAL

DELEGATION

Effective February 1, 2024, I am delegating Tony Jondo as the Fire Protection Authority Having Jurisdiction (FP-AHJ) and Building Code Official (BCO) for the Office of Science (SC) Consolidated Service Center (CSC) as outlined in Department of Energy Order (DOE O) 420.1C Change 3, *Facility Safety*, with Joon Yoo serving as his backup. I am delegating Melkie Tega as the Electrical Authority Having Jurisdiction (E-AHJ) and Electrical Safety Officer (ESO) for the SC CSC as outlined in DOE O 420.1C Change 3, *Facility Safety*. The roles and responsibilities of the AHJ and BCO are provided in DOE O 420.1C Change 3, *Facility Safety*, DOE-STD-1066-2023, *Fire Protection*, and National Fire Protection Association, International Building Code, and other applicable codes and standards.

In general, your delegated responsibilities include enforcing the requirements of DOE Orders, codes, and standards, approving equipment, materials, and installations or procedures, and monitoring daily operations and compliance for fire protection and electrical related activities. Your delegated responsibilities also include developing, issuing, and approving equivalencies to codes and standards as outlined in applicable DOE orders.

The Electrical Safety Officer is also delegated the authority for the Electrical Safety Program implementation for all electrical safety and code requirements for DOE facilities managed by the CSC, approval of equipment and materials and performing routine interpretation of electrical safety and code compliance as necessary to support field implementation of these requirements including responsibilities normally referred to in national codes and standards as

the "owner." The efficient and effective implementation of the CSC Electrical Safety Program is dependent on certain E-AHJ authorities being delegated.

Appropriate documentation, including code determinations made by the AHJ and BCO, shall be generated and retained for all delegated AHJ and BCO activities. Records of technical justification must be maintained and reevaluated for appropriateness as activities or operations change. This delegation will continue until rescinded, amended, or superseded in writing. This delegation is only applicable to buildings in which the SC CSC has current functional responsibility for facility operation and ownership.
