SUMMARY

The CHIPS and Science Act of 2022 authorized the Department of Energy to establish Microelectronics Science Research Centers (MSRCs). This announcement solicits proposals to establish the first such MSRCs, with a focus on energy efficient microelectronics and microelectronics for extreme environments. The DOE SC programs in Advanced Scientific Computing Research (ASCR), Basic Energy Sciences (BES), Fusion Energy Sciences (FES), High Energy Physics (HEP), and Nuclear Physics (NP) hereby announce their interest in multi-investigator, multi-disciplinary proposals for basic research in microelectronics technologies for computing, communication, sensing, and power, seeking transformative advances in energy efficiency and/or resilience in extreme environments. The awarded network of projects will collectively form one or more MSRCs.

For decades, SC has been at the leading edge of microelectronics, both as a consumer and as an engine of scientific understanding that has enabled many of the technological breakthroughs adopted by industry. Today, the end of Moore's Law, along with the emergence of new computing and sensing workloads and rapidly expanding data, have resulted in an unprecedented need and opportunity to "redesign" the innovation process. In this funding announcement the terms "microelectronics" and/or "semiconductor" are used broadly to refer to electronic, magnetic, or photonic materials, devices, sensors, integrated circuits, processors, architectures, software tools, processing chemistries, design, fabrication including plasma based etching, deposition, and surface modification, lithography, packaging, modeling and simulation, and related technologies.

Although quantum devices (quantum sensors, qubits, etc.) may also operate under extreme environments, they are not in scope for this Announcement; however, materials, devices, and processing pertaining to energy-efficient microelectronics for classical computing and sensing or for extreme environments may very well take advantage of quantum effects.

SUPPLEMENTARY INFORMATION

Background

SC is the nation's largest supporter of basic research in the physical sciences, the steward of 10 of the Nation's national laboratories, and the lead federal agency supporting fundamental

research for energy production and security. SC accelerates discovery with the world's largest array of major scientific user facilities that includes particle accelerators and colliders, powerful neutron and X-ray light sources, exascale supercomputers, and nanoscience centers. Some of the most complex scientific instruments and supercomputers in the world reside in DOE user facilities and enable technological innovation while speeding insights into everything from the properties of materials, plasma in fusion reactors, to complex weather and climate patterns, to the geophysics of earthquakes. Discovery and use-inspired science supported by SC provides an enduring foundation for technological innovation and economic progress.

The following five SC programs are participating in this funding opportunity:

Advanced Scientific Computing Research (ASCR): The ASCR program's mission is to advance applied mathematics and computer science; deliver the most sophisticated computational scientific applications in partnership with disciplinary science; advance computing and networking capabilities; and develop future generations of computing hardware and software tools for science and engineering in partnership with the research community, including U.S. industry. ASCR supports state-of-the-art capabilities that enable scientific discovery through computation and networking.

Basic Energy Sciences (BES): BES supports fundamental research to understand, predict, and ultimately control matter and energy at the electronic, atomic, and molecular levels in order to provide the foundations for new energy technologies and to support DOE missions in energy, environment, and national security. BES research is supported through three Divisions, all of which have interest in science relevant to microelectronics: The Chemical Sciences, Geosciences, and Biosciences (CSGB) Division, the Materials Sciences and Engineering (MSE) Division, and the Scientific User Facilities (SUF) Division.

Fusion Energy Sciences (FES): The mission of the Fusion Energy Sciences (FES) program is to expand the fundamental understanding of matter at very high temperatures and densities and to build the scientific foundation needed to develop a fusion energy source. This is accomplished through the study of plasma, the fourth state of matter, and how it interacts with its surroundings.

High Energy Physics (HEP): The HEP program's mission is to understand how the universe works at its most fundamental level by discovering the elementary constituents of matter and energy, probing the interactions between them, and exploring the basic nature of space and time.

Nuclear Physics (NP): The NP program's mission is to discover, explore, and understand all forms of nuclear matter. Nuclear physicists seek to understand not just the familiar forms of matter we see around us, but also exotic forms such as those that existed in the first moments after the Big Bang and that exist today inside neutron stars. The aim is to understand why matter takes on the specific forms now observed in nature and how that knowledge can benefit society in the areas of commerce, medicine, and national security.

In 2018, SC held a workshop entitled *Basic Research Needs (BRN) for Microelectronics* [2]. The workshop identified the need to move away from the historical sequential R&D process to a co-design framework where each scientific discipline informs and engages the others, with multi-directional information flow. The workshop report described five priority research directions: 1) Flip the current paradigm: Define innovative material, device, and architecture requirements driven by applications, algorithms, and software; 2) Revolutionize memory and data storage; 3) Reimagine information flow unconstrained by interconnects; 4) Redefine computing by leveraging unexploited physical phenomena; and 5) Reinvent the electricity grid through new materials, devices, and architectures. In addition, the report identified the need for a dramatic shift toward a co-design approach, where each discipline informs and engages others to achieve transformative advances in system-level performance.

In 2022, FES held a workshop on *Plasma Science for Microelectronics Nanofabrication* [14] to identify the plasma science challenges and technical barriers that must be overcome for new plasma-based semiconductor nanofabrication technologies. The report from this workshop outlined a set of Priority Research Opportunities (PROs) to focus attention on the most strategic plasma science challenges to be addressed to benefit the U.S. semiconductor industry.

Applicants are strongly encouraged to align proposals with the priority research directions and opportunities, and co-design approaches articulated in these reports.

In addition, the References subsection below cites reports [1-15], listed alphabetically, that may also be informative in the development of proposals. (Except for the Basic Research Needs in Microelectronics [2] and the Plasma Science for Microelectronics Nanofabrication [14] reports, responding directly to these reports is not a requirement of this funding opportunity.)

Research Scope

To enable continued advances in sensing, computing, communication, networking, and power technologies, a fundamental rethinking is needed of the science behind the materials and chemistries, synthesis and fabrication, plasma-based surface processing and control, device physics, architectures, algorithms, software, and modeling/simulation. In addition, the competitiveness of future microelectronics technologies will depend on their ability not only to provide advanced functionality, but also to operate efficiently. For SC's mission, it is simultaneously true that advances are needed not only for microelectronics generally, but also specifically for microelectronics designed to operate in extreme environments, including high-radiation, cryogenic, and high magnetic field environments. While these two needs are sometimes overlapping, for example cryogenic environments often require highly-energy-efficient microelectronics, for the purposes of this call, each awarded project will be assigned either to an MSRC focused on energy efficiency or an MSRC focused on extreme environments. For additional information on the MSRC structure, please see the *Teaming Arrangements* subsection below.

SC is poised at the convergence of these diverse research areas, in a unique position to play a critical role in the advancement of microelectronics technologies over the coming decades, and also to benefit from the resultant capabilities for advancing fundamental scientific research. To

support and foster this paradigm shift, this funding opportunity is requesting proposals for fundamental scientific research in the following four **Research Areas:**

- 1. New or improved materials, surface processing and control, chemistry, synthesis, and fabrication
- 2. Advanced computing paradigms and architectures
- 3. Integrated sensing, edge computing, and communication
- 4. Processing in extreme environments, radiation, radiation transport, and materials interaction

Each Pre-Proposal and Proposal in response to this funding opportunity is encouraged to propose research that is integrated across <u>at least two of these areas</u>.

Detailed descriptions of each area follow:

• New materials, surface processing and control, chemistry, synthesis, and fabrication

Experimental, theoretical, and computational research to provide a fundamental understanding of chemical transformations and energy flow serves as a basis for the development of new processes for microelectronics by enabling the realization of innovative materials, devices, and architectures, through new concepts for data storage and memory, and through new architectures, such as 3D assemblies, as well as flexible soft interfaces. Similarly, the discovery and design of new materials with novel structures, functions, and properties serves as a basis for the development of new computing, communications, and sensing technologies based on unexploited physical phenomena. Proposed research must focus on establishing the science foundation for transformative changes in the way we detect, analyze, communicate, and store information, rather than on incremental improvements to current technologies. Highly energy efficient systems and processes should also be envisioned by all research projects.

This funding opportunity seeks proposals that use intermolecular interactions to control electronic states or electron flow, resulting in fundamental consequences such as: (i) molecular recognition as a basis for patterning structures with innovative molecular synthesis; (ii) short-range interactions for electronic transport pathways over controllable distances; (iii) synthesis of molecules that provide stationary electronic states for memory; and (iv) approaches that are inspired by the way that biological systems control electron transfer, sense and respond to environmental conditions, and deal with excess energy in ways that could lead to new, robust processes to perform computation. The funding opportunity also seeks proposals that explore and control novel materials systems and physical properties that could be exploited to enable future logic, memory, sensing, and communications devices and systems. In particular, research focused on the discovery, synthesis, characterization, and control of a broad range of electronic and magnetic materials including (but not limited to) semiconductors, superconductors, ferroelectrics, multiferroics, and optoelectronic and topological materials is encouraged. While studies of bulk three-dimensional (3D) materials may be supported, particular

emphasis will be placed on 1D, 2D, and nanostructured materials that have the potential to be integrated into future nanofabricated devices and systems.

Research on the science underpinning synthesis and fabrication is encouraged, including new techniques to synthesize materials and molecules with desired structure, properties, and function. This includes, but is not limited to, synthesis of complex thin films and nanoscale materials with atomic layer-by-layer control; understanding the contributions of the liquid and other precursor states to the processing of bulk nanoscale materials; low energy processing techniques for large scale nanostructured materials; and innovative synthetic approaches to enable scalable assembly of matter.

Low temperature plasmas are essential to the manufacture of devices in the semiconductor industry, from the creation of extreme ultraviolet photons used in the most advanced lithography to thin film etching, deposition, and surface modifications. It is estimated that 40-45% of all process steps needed to manufacture semiconductor devices use low temperature plasmas (LTPs) in one form or another. LTPs have been an enabling technology in the multi-decade progression of the shrinking of device dimensions, often referred to as Moore's Law. New challenges in circuit and device design, novel materials, and increasing demands to achieve environmentally benign processing technologies are pushing the boundaries of what is possible today in plasma technology. Areas of interest include but are not limited to: efficient and sustainable development of device manufacturing with integrated efforts in plasma science, reactor technology, process engineering, and plasma chemistry; understanding, characterization, and control of plasma-surface interactions down to the atomic scale to enable materials and device structures required for future microelectronics and semiconductor fabrication; developing fundamental data and centralized databases to enable comprehensive low temperature plasma diagnostics and modeling; enabling experimentally validated, predictive, and integrated modeling of fundamental low temperature plasma physics, chemistry, and surface interactions to enable next generation semiconductor plasma processing, and efforts on developing novel institutional structures to meet emerging challenges of the field.

• New computing paradigms and architectures

Over the past three decades, the evolution of microelectronics technologies has enabled DOE to design and deploy, in partnership with U.S. industry, some of the world's most powerful high-performance computing and networking capabilities to meet its energy, national security and science missions. New research and development opportunities in microelectronics are needed to enable breakthroughs beyond current state-of-the-art computing technologies. To enable new generations of energy-efficient computing systems over the next decade, a complete reconceptualization of the science and technology underlying the microelectronics co-design approach is needed to integrate emerging devices, materials, interconnects, photonics, and non-linear phenomena with the needs of scientific computing applications. This funding opportunity solicits the development of new modeling and simulation software tools that incorporate artificial intelligence and machine learning technologies to accelerate the exploration and

development of emerging hardware approaches that may advance a range of new computing technologies including identifying new approaches to address the movement of data between processors and between nodes, high performance computing, edge computing, bio-inspired or neuromorphic computing, and advanced wireless for scientific applications.

Neuromorphic computing promises to achieve over one million times improvement in energy efficiency compared to current state of the art in computing and could significantly accelerate artificial intelligence and machine learning approaches. In addition, it could be leveraged to enhance a wide range of applications such as embedded, edge computing, networking, analysis, and high-performance computing accelerators. This area of research requires effective collaboration between various scientific disciplines from materials science, devices, microelectronics, engineering, computer science, high performance computing, to neuroscience, all of which are required to make neuromorphic computing a reality. The ultimate goal is to develop an energy efficient computing architecture capable of autonomous operation, learning, self-diagnosis and repair.

In addition to advances in energy-efficient neuromorphic architectures, a variety of approaches hold promise for transformative increases in microelectronics energy efficiency. The 2020 Advanced Computing Ecosystem Strategic Plan [9] calls for "Support[ing] research on novel, beyond-CMOS device and/or /hardware topics to support implementations of these computing paradigms; and support[ing] R&D in beyond-CMOS devices/logics, memories/storages, and interconnects, and their integration in, for example, superconductors, biomolecules, spin electronics, and photonics, to establish advanced hardware platforms for implementation of emerging computing paradigms." Moreover, approaches including non-volatility, spintronics, magnetism, superconductivity, ionic conductivity, and photonics can potentially enable both energy-efficient general-purpose and special-purpose devices using digital logic, analog computation, or a combination of the two.

• Integrated sensing, edge computing, and communication

Today's experimental, observational, and computational sciences involve dynamically integrated and interactive collaborations. Often, the science is conducted as a workflow of many related tasks. Scientific instruments could be static, mobile, remote, and/or distributed, and could benefit from being able to connect and interact with established networking, storage, cloud, or high-performance computing facilities. Data may be generated by sensor systems, edge computing devices, or a combination of various data sources and models.

Most instruments employ advanced sensors and tightly integrated, application-specific front-end electronics (FEE) and trigger and data acquisition electronics that require cutting-edge microelectronics technologies. Often, these instruments include microelectronics that must function in extreme radiation, temperature, or magnetic-field environments and consume very little power.

Sensors with exquisite detection efficiency and energy or spatial resolution are needed for charged particle and radiation detection over a wide range of energies and wavelengths. To date, silicon is the most widely used sensor material, with many fabrication processes provided by the semiconductor industry. Improved or new sensor materials are needed (e.g., large-bandgap semi-conductors, diamond, thin film materials, 2D materials, superconductor materials, etc.) to enhance performance across a broad range of applications, and processes need to be developed, in collaboration with industry, to structure these materials such that they can be fabricated into sensors.

Application-specific integrated circuits (ICs) and edge computing have become indispensable in extracting, digitizing, and processing analog sensor information. Complexity has increased to the point that entire systems are now integrated in a chip (system-on-chip, SoC). New technologies are needed to continue to increase the level of integration: novel interconnect techniques to enable "vertical 3D integration" of sensor and analog and digital data-processing elements; and new processes to integrate photonics or RF transmitter components for optical or wireless communications ("4D integration"). For example, current fifth generation and beyond (5G+) wireless offers up to 20Gbps connectivity with 1ms latency and could enable new communication modes. The ultimate goal is a process that results in a monolithic device, where all sensor, analog and digital processing, and communication functions in "one piece of silicon"; or in an integrated package containing multiple chiplets, multiple "pieces of silicon", tightly coupled together.

Detectors often must operate in extreme environments: very high levels of ionizing radiation (≥100s of Mrad); or cryogenic (~100 K) or deep cryogenic (≤4 K) temperatures; and/or high magnetic fields (≥1 T). For such environments, research is needed into (i) process technologies, models, and standard cell libraries; (ii) building blocks for system on chip (e.g., low-power, high-speed I/O protocols; wireless; power management; Single Event Effect mitigation techniques; pico-second precision clock and timing circuits); and (iii) emerging design and verification methodologies, including processes with Internet of Things (IoT) distributed network technology and in-hardware neural networks, neuromorphic processing, and asynchronous techniques. The ultimate goal is on-detector electronics capable of extracting high level physics information from simultaneous multichannel, in-hardware processing of the initial analog raw signals.

Data acquisition begins at the font-end sensors and takes the data to permanent storage, either in a triggered or streaming architecture. Future large detector systems require real-time, sustained data transmission and processing reaching the exascale. Research is needed into high-bandwidth, radiation-hard, low-power data links; real-time processing on heterogeneous hardware employing low-latency artificial intelligence and machine learning techniques; neuromorphic computing; and advanced feature extraction for triggering. The ultimate goal is to develop technologies for detector systems capable of autonomous operation, including self-calibration and -alignment as well as self-diagnosis and -repair.

• Processing in extreme environments, radiation, radiation transport, and materials interaction

The continued quest and economic drive to extend Moore's Law is in large part dependent on photolithography to define the features that will be fabricated on semiconductor wafers. The photoresist (the radiation sensitive coating) is exposed to radiation after it has been applied to the wafer through a mask or pattern. Fabricating smaller and smaller features requires shorter and shorter wavelengths to expose the photoresist to make finer and finer patterns. Research on an ultralow-damage etching process is needed for future device fabrication. A deeper understanding of the synergistic effects of vacuum ultraviolet (VUV, <200 nm) light and radicals, ions, crystal surface, and sheath electric fields on plasma etching is critically important for future microelectronics processing. A thorough understanding of the generation of VUV light in processing plasmas, its transport to surfaces, and the complex chemistry and solid-state physics, including electronic effects, of the photon surface interactions will be required to ensure that plasma processes, most importantly plasma etching, continue without limits in future semiconductor device manufacturing.

This funding opportunity seeks research proposals that aim to optimize the generation of extreme ultraviolet (EUV) photons capable of printing patterns on the order of the 13.5 nm wavelength on a semiconductor chip. Areas of interest include but are not limited to: efficient plasma source to produce photons in the EUV range; EUV photons and plasma species interactions with the background gas, optical, and plasma facing surfaces in the EUV source and the lithographic scanner; controlled management of Sn in the plasma ablated droplet; efficient generation of EUV light for lithography and for table-top metrology; scaling of plasma excited lasers for future processing needs; effective diagnostics and models for the multiple plasmas used in EUV production; control, customize, and manipulate VUV for semiconductor processing to enhance (or deemphasize) photon stimulated surface processes, understanding and control of plasma enabled etching reactions; understanding mechanisms for photo-assisted etching, understanding VUV induced damage and defects, understanding the effects of VUV light on processes at other plasma-facing surfaces and their feedback to the plasma; quantifying plasma generated VUV fluxes to surfaces; improved understanding of the generation and propagation of VUV light in processing plasmas; validated mechanisms for VUV induced etching and defect formation. For more information, see PRO 5 in reference [14]

Annual Meetings

The selected awardees will be expected to attend one annual PI meeting. Applicants should anticipate a need for travel to effectively communicate with other researchers and request appropriate funding in their budgets.

Teaming Arrangements

Proposals will be accepted only from multi-investigator teams, not single investigators. Multi-investigator teams may be at multiple institutions. Lead DOE Laboratories are encouraged to form partnerships with academia, industry, other DOE Laboratories, and other agencies or agencies' FFRDCs.

SC intends to form one or more Microelectronics Science Research Centers (MSRC) comprising a network of awards made in response to this Announcement. Each center will have a focus either on energy efficiency and/or on extreme environments. The purpose of all MSRCs is to deliver scientific discoveries leading to innovation in microelectronics with enhanced energy efficiency and/or that operate with state-of-the-art performance in extreme environments. Each MSRC is expected to include collaborations or connections with U.S. industry that maximize the extent to which scientific discoveries will enhance U.S. competitiveness.

After selection, the PIs of all awards that will comprise a center will be expected to collectively develop a plan, in coordination with the projects' SC program managers, to share knowledge across the center, collaborate where advantageous, and otherwise make the whole of the center more than the sum of its constituent projects. The PIs will comprise the center's Leadership Council (LC), and the LC will be expected to meet on a regular basis.

SC may, if appropriate, include in any center projects selected in response to other solicitations and may, if appropriate, augment any center in future years with additional projects. Note that, pursuant to 42 USC 19331(d)(12), the total funding associated with all projects in each center shall not exceed \$25,000,000 per year.

INDUSTRY ADVISORY COUNCIL

The MSRCs are each expected to have an industry advisory council. Each project is expected to propose one or more industry advisors. These advisors may be uncompensated, or paid collaborators, but advisors are expected to attend the PI meeting and travel for the advisors to attend the meeting each year should be budgeted as needed. The MSRC PIs will select a subset of the industry project advisors to serve on the industry advisory council for the center as a whole, potentially on a rotating basis, and those selected will be expected to work together to provide directional guidance to the MSRC projects wholistically in addition to their role advising individual projects.

The first page of the pre-application must specify at least one scientific hypothesis whose investigation motivates the proposed work, using no more than 100 words, in a box with a black border. For any hypothesis that is not itself innovative, the pre-application must describe at least one innovative insight into how the hypothesis can be investigated that may be exploited by the planned research.

PRE-PROPOSAL REVIEW

Program Managers may evaluate all or some portion of pre-proposals to determine their competitiveness within a scientific topic.

Any review will be based on the following criteria:

- 1. Responsiveness to the objectives of the Announcement.
- 2. Scientific and technical merit.
- 3. Appropriateness of the proposed research approaches.
- 4. Likelihood of scientific impact.

Any such review will be conducted by no less than three federal program managers chosen for their topical knowledge and diversity of perspective.

Reviews within a topical field will be a comparative review with priority given to scientifically innovative and forward-looking basic research with the highest likelihood of success as a proposal. The results of the review will be documented.

Applicants with the highest rated pre-proposals will be encouraged to submit proposals; others will be discouraged from submitting proposals.

Written feedback about preproposals will be provided, upon request, after award selections have been announced.

Topics with comparatively few pre-proposals may not make use of such pre-proposal reviews. The ratio of encourage/discourage results will differ between topical subjects.

SC is committed to ensuring that a sufficient number of applicants will be encouraged to submit proposals to foster a competitive merit review of the proposals. SC's intent in discouraging submission of certain proposals is to save the time and effort of applicants in preparing and submitting proposals with a negligible likelihood of success.

INCORPORATED CONSORTIA

Incorporated consortia are eligible to apply for funding as a prime recipient (lead organization) or subrecipient (team member).

Each incorporated consortium must have an internal governance structure and a written set of internal rules. Upon request, the consortium must provide a written description of its internal governance structure and its internal rules to the DOE contracting officer. There is no requirement that subawards be formalized into incorporated consortia.

UNINCORPORATED CONSORTIA

Unincorporated consortia (team arrangements) must designate one member of the consortium to serve as the prime recipient/consortium representative (lead organization). There is no requirement that subawards be formalized into unincorporated consortia.

Upon request, unincorporated consortia must provide the DOE contracting officer with a collaboration agreement, commonly referred to as the articles of collaboration, which sets out the rights and responsibilities of each consortium member. This agreement binds the individual consortium members together and should discuss, among other things, the consortium's:

- Management structure;
- Method of making payments to consortium members;

VIII.A.3. How to Submit a Pre-Proposal

It is important that the pre-proposal be a single file with extension .pdf, .docx, or .doc. The filename must not exceed 50 characters. The PI and anyone submitting on behalf of the PI must register for an account in PAMS before it will be possible to submit a pre-proposal. All PIs and those submitting pre-proposals on behalf of PIs are encouraged to establish PAMS accounts as soon as possible to avoid submission delays.

Submit Your Pre-Proposals:

VIII.A.4. How to Prepare and Submit a Proposal

SUBMITTING A PROPOSAL

The following information is provided to help with proposal submission. Detailed instructions and screen shots can be found in the PAMS Help materials, accessible by clicking the "PAMS Help" link on the PAMS home page. Onscreen instructions are available within PAMS.

- Log into PAMS. From the proposals tab, click the "View DOE National Laboratory Announcements" link and find the current announcement in the list. Click the "Actions/Views" link in the Options column next to this Announcement to obtain a dropdown menu. Select "Submit Proposal" from the dropdown.
- Note that you must select one and only one Principal Investigator (PI) per proposal; to do so, click the "Select PI" button on the far right side of the screen. Find the appropriate PI from the list of all registered users from your institution returned by PAMS. (Hint: You may have to sort, filter, or search through the list if it has multiple pages.) Click the "Actions" link in the Options column next to the appropriate PI to obtain a dropdown menu. From the dropdown, choose "Select PI."
- If the PI for whom you are submitting does not appear on the list, it means he or she has not yet registered in PAMS. For your convenience, you may have PAMS send an email invitation to the PI to register in PAMS. To do so, click the "Invite PI" link at the top left of the "Select PI" screen. You can enter an optional personal message to the PI in the "Comments" box, and it will be included in the email sent by PAMS to the PI. You may enter an optional description of the file you are attaching. Click the "Upload" button to upload the file.
- Once you have saved all of the sections, the "Submit to DOE" option will appear in the dropdown menu at the bottom of the screen.
- To submit the proposal, select "Submit to DOE" from the dropdown menu and then click the "Go" button.
- Upon submission, the PI will receive an email from the PAMS system <<u>PAMS.Autoreply@science.doe.gov</u>> acknowledging receipt of the proposal.
- The proposal will also appear under My Proposals with a Proposal Status of "Submitted to DOE."

Please only submit a PAMS lab technical proposal in response to this Announcement; do not submit a DOE Field Work Proposal (FWP) at this time. SC will request FWPs later from those selected for funding consideration under this Announcement.

PROPOSAL PREPARATION

All files submitted a part of a proposal must be PDF files unless otherwise specified in this Announcement. Attached PDF files must be plain files consisting of text, numbers, and images without editable fields, signatures, passwords, redactions, or other advanced features available in some PDF-compatible software. Do not use PDF portfolios or binders.

Please note the following restrictions that apply to the names of all files attached to your proposal:

- Please limit file names to 50 or fewer characters
- Do not attach any documents with the same name. All attachments must have a unique name.
- Please use only the following characters when naming your attachments: A-Z, a-z, 0-9, underscore, hyphen, space, period, parenthesis, curly braces, square brackets, ampersand, tilde, exclamation point, comma, semi colon, apostrophe, at sign, number sign, dollar sign, percent sign, plus sign, and equal sign. Attachments that do not follow this rule may cause the entire proposal to be rejected or cause issues during processing.

RESUBMISSION OF PROPOSALS

Proposals submitted under this announcement may be withdrawn from consideration by using the PAMS website at https://pamspublic.science.energy.gov. Proposals may be withdrawn at any time between when the applicant submits the proposal and when DOE makes the proposal available to merit reviewers. Such withdrawals take effect immediately and cannot be reversed. Please exercise due caution. After the proposal is made available to merit reviewers, the applicant may contact the DOE program office identified in this Announcement to request that it be withdrawn.

After a proposal is withdrawn, it may be resubmitted, if this Announcement is still open for the submission of proposals. Such resubmissions will only count as one submission if this Announcement restricts the number of proposals from an applicant.

IMPROPER CONTENTS OF PROPOSALS

Proposals submitted under this Announcement will be stored in controlled-access systems, but they may be made publicly available if an award is made. As such, it is critical that applicants follow these guidelines:

A biographical sketch is to provide information that can be used by reviewers to evaluate the PI's potential for leadership within the scientific community. Examples of information of interest are invited and/or public lectures, awards received, scientific program committees, conference or workshop organization, professional society activities, special international or industrial partnerships, reviewing or editorship activities, or other scientific leadership experiences.

SC requires the use of the format approved by the National Science Foundation (NSF), which may be generated by the Science Experts Network Curriculum Vitae (SciENcv), a cooperative venture maintained at https://www.ncbi.nlm.nih.gov/sciencv/. The fillable PDFs provided by the National Science Foundation are no longer available. When interagency common formats and instructions are promulgated, their use will be accepted. See https://new.nsf.gov/funding/senior-personnel-documents for more information. The use of a format required by another agency is intended to reduce the administrative burden to researchers by promoting the use of common formats.

Requested information may be appended to a biographical sketch, whether produced from a fillable PDF or in SciENcv.

SC strongly recommends the use of SciENcv to reduce administrative burden by allowing the use of digital persistent identifiers, including the Open Researcher and Contributer ID (ORCiD).

Do not attach a listing of individuals who should not be used as merit reviewers: This information is no longer collected as part of a biographical sketch.

VIII.A.6. How to Prepare a List of Individuals Who Should Not Serve as Reviewers

To assist in identifying individuals who should not serve as merit reviews, provide the following information for each and every senior/key person who is planned to be or is identified in Section A of the proposal budget for the applicant and any proposed subrecipients:

- Advisees (graduate students or postdocs) of the senior/key person
- Advisors of the senior/key person while a graduate student or a postdoc
- Close associates of the senior/key person over the past 48 months
- Co-authors of the senior/key person over the past 48 months
- Co-editors of the senior/key person over the past 48 months
- Co-investigators of the senior/key person over the past 48 months
- Collaborators of the senior/key person over the past 48 months

Do not identify any personnel at the applicant institution or any proposed subrecipient or team institution: Those personnel are prohibited from serving as merit reviewers.

Large collaborations of 10 or more researchers do not require that all collaborators be identified: rather, only list the researchers with whom the senior/key person actually collaborated.

For all identified individuals, provide the following information:

- The senior/key person to whom the individual was an advisee, advisor, close associate, co-author, co-editor, co-investigator, or collaborator, identified by first name and last name
- The individual's first (given) name
- The individual's last (family) name
- The individual's Open Researcher and Contributor ID (ORCiD), if known
- The individual's institutional affiliation spelling out acronyms (For joint appointments, separate each institution with a slash ("/"). Do not list departmental affiliations.)
- The reason for listing the individual (advisee, advisor, close associate, co-author, co-editor, co-investigator, collaborator)
- The year when the individual last was a close associate, co-author, co-editor, co-investigator, or collaborator

You may also provide a list of all senior/key personnel who are planned to be or are identified in Section A of the proposal budget for the applicant and any proposed subrecipients.

The lists do not need to be sorted in any method.

The lists must be submitted in tabular format, preferably as Microsoft Excel (.xls or .xlsx) files.

For your convenience, a template is available at https://science.osti.gov/grants/Policy-and-Guidance/Agreement-Forms. If using the template:

- Do not add tabs to the spreadsheet
- Do not merge the existing tabs
- Do not remove headers
- Fill out the requested headers on both tabs with the same information
- Ensure that given and family names are presented in the correct columns

VIII.A.7. How to Prepare Current and Pending Support

WARNING: These instructions have been significantly revised to require disclosure of a variety of potential conflicts of interest or commitment, including participation in foreign government-sponsored talent recruitment programs.

Current and Pending support is intended to allow the identification of potential duplication, overcommitment, potential conflicts of interest or commitment, and all other sources of support. The PI and each senior/key person at the prime applicant and any proposed subaward must provide a list of all sponsored activities, awards, and appointments, whether paid or unpaid; provided as a gift with terms or conditions or provided as a gift without terms or conditions; full-time, part-time, or voluntary; faculty, visiting, adjunct, or honorary; cash or in-kind; foreign or domestic; governmental or private-sector; directly supporting the individual's research or indirectly supporting the individual by supporting students, research staff, space, equipment, or other research expenses. All foreign government-sponsored talent recruitment programs must be identified in current and pending support.

SC requires the use of the format approved by the National Science Foundation (NSF), which may be generated by the Science Experts Network Curriculum Vitae (SciENcv), a cooperative venture maintained at https://www.ncbi.nlm.nih.gov/sciencv/. The fillable PDFs provided by the National Science Foundation are no longer available. When interagency common formats and instructions are promulgated, their use will be accepted. See https://new.nsf.gov/funding/senior-personnel-documents for more information. The use of a format required by another agency is intended to reduce the administrative burden to researchers by promoting the use of common formats.

For every activity, list the following items:

- The sponsor of the activity or the source of funding.
- The award or other identifying number.
- The title of the award or activity. If the title of the award or activity is not descriptive, add a brief description of the research being performed that would identify any overlaps or synergies with the proposed research.
- The total cost or value of the award or activity, including direct and indirect costs. For pending proposals, provide the total amount of requested funding.
- The award period (start date end date).

• The person-months of effort per year being dedicated to the award or activity.

If required to identify overlap, duplication of effort, or synergistic efforts, append a description of the other award or activity to the current and pending support.

Requested information may be appended to current and pending support, whether produced from a fillable PDF or in SciENcv.

SC strongly recommends the use of SciENcv to reduce administrative burden by allowing the use of digital persistent identifiers, including the Open Researcher and Contributer ID (ORCiD).

Details of any obligations, contractual or otherwise, to any program, entity, or organization sponsored by a foreign government must be provided on request to either the applicant institution or DOE.

VIII.A.8. How to Prepare a Data Management Plan

In general, a DMP should address the following requirements:

- 1. DMPs should describe whether and how data generated in the course of the proposed research will be shared and preserved. If the plan is not to share and/or preserve certain data, then the plan must explain the basis of the decision (for example, cost/benefit considerations, other parameters of feasibility, scientific appropriateness, or limitations discussed in #4). At a minimum, DMPs must describe how data sharing and preservation will enable validation of results, or how results could be validated if data are not shared or preserved.
- 2. DMPs should provide a plan for making all research data displayed in publications resulting from the proposed research open, machine-readable, and digitally accessible to the public at the time of publication. This includes data that are displayed in charts, figures, images, etc. In addition, the underlying digital research data used to generate the displayed data should be made as accessible as possible to the public in accordance with the principles stated in the Office of Science Statement on Digital Data Management (https://science.osti.gov/funding-opportunities/digital-data-management. This requirement could be met by including the data as supplementary information to the published article, or through other means. The published article should indicate how these data can be accessed.
- 3. DMPs should consult and reference available information about data management resources to be used in the course of the proposed research. In particular, DMPs that explicitly or implicitly commit data management resources at a facility beyond what is conventionally made available to approved users should be accompanied by written approval from that facility. VIII.A.9. How to Prepare a Budget and Justification

The following advice will improve the accuracy of your budget request:

- Funds requested for personnel (senior, key, and other) must be justified as the product of their effort on the project and their institutional base salary.
- Funds requested for fringe benefits must be calculated as the product of the requested salary and, if present, the negotiated fringe benefit rate contained in an institution's negotiated indirect cost rate agreement.
- Funds requested for indirect costs must be calculated using the correct indirect cost base and the negotiated indirect cost rate.
- You are encouraged to include the rate agreement used in preparing a budget as a part of the budget justification.
- Do not prepare a budget justification using the expired DOE form F4260.1.

VIII.A.10. How to Register in PAMS

You must register in PAMS to submit a pre-proposal, letter of intent, or DOE national laboratory proposal.

Notifications sent from the PAMS system will come from the PAMS email address

< <u>PAMS.Autoreply@science.doe.gov</u>>. Please make sure your email server/software allows delivery of emails from the PAMS email address to yours.

Registering to PAMS is a two-step process; once you create an individual account, you must associate yourself with ("register to") your institution. Detailed steps are listed below.

CREATE PAMS ACCOUNT:

To register, click the "Create New PAMS Account" link on the website https://pamspublic.science.energy.gov/.

- Click the "No, I have never had an account" link and then the "Create Account" button.
- You will be prompted to enter your name and email address, create a username and password, and select a security question and answer. Once you have done this, click the "Save and Continue" button.
- On the next page, enter the required information (at least one phone number and your mailing address) and any optional information you wish to provide (e.g., FAX number, website, mailstop code, additional email addresses or phone numbers, Division/Department). Click the "Create Account" button.
- Read the user agreement and click the "Accept" button to indicate that you understand your responsibilities and agree to comply with the rules of behavior for PAMS.
- PAMS will take you to the "Having Trouble Logging In?" page. (If you have been an SC merit reviewer or if you have previously submitted a proposal, you may already be linked to an institution in PAMS. If this happens, you will be taken to the PAMS home page.)

- 5. Click the link labeled "Option 2: I know my institution and I am here to register to the institution." (Note: If you previously created a PAMS account but did not register to an institution at that time, you must click the Institutions tab and click the "Register to Institution" link.)

Type a word or phrase from your institution name in the field labeled, "Institution Name like," choose the radio button next to the item that best describes your role in the system, and click the "Search" button. A "like" search in PAMS returns results that contain the word or phrase you enter; you do not need to enter the exact name of the institution, but you should enter a word or phrase contained within the institution name. VIII.B. POLICY PROVISIONS

VIII.B.1. Availability of Funds

Funds are not presently available for this award. The Government's obligation under this award is contingent upon the availability of appropriated funds from which payment for award purposes can be made. No legal liability on the part of the Government for any payment may arise until funds are made available to the Contracting Officer for this award and until the awardee receives notice of such availability, to be confirmed in writing by the Contracting Officer.

VIII.B.2. Commitment of Public Funds

The Contracting Officer is the only individual who can make awards or commit the Government to the expenditure of public funds. A commitment by other than the Contracting Officer, either explicit or implied, is invalid.

VIII.B.9. Proprietary Proposal Information

Patentable ideas, trade secrets, proprietary or confidential commercial or financial information, disclosure of which may harm the applicant, should be included in a proposal only when such information is necessary to convey an understanding of the proposed project. The use and disclosure of such data may be restricted, provided the applicant includes the following legend on the first page of any document included in the proposal that contains such proprietary information and specifies the pages of the document which are to be restricted:

"The data contained in pages _____ of this document have been submitted in confidence and contain trade secrets or proprietary information, and such data shall be used or disclosed only for evaluation purposes, provided that if this applicant receives an award as a result of or in

connection with the submission of this proposal, DOE shall have the right to use or disclose the data herein to the extent provided in the award. This restriction does not limit the government's right to use or disclose data obtained without restriction from any source, including the applicant."

To protect such data, each line or paragraph on the pages containing such data must be specifically identified and marked with a legend similar to the following:

"The following contains proprietary information that (name of applicant) requests not be released to persons outside the Government, except for purposes of review and evaluation."

VIII.B.10. Publications

Researchers are expected to publish or otherwise make publicly available the results of the work conducted under any authorization resulting from this Announcement. Publications and other methods of public communication describing any work based on or developed under an authorization resulting from this Announcement must contain an acknowledgment of SC support.
